The Department of Personnel & Training has issued the instructions vide Office Memorandum cited above under the reference, for Grant of Notional increment on 1<sup>st</sup> July/1<sup>st</sup> January to the employees, on final outcome of petition filed by DOPT, seeking the review of the order dated 11.04.2024 of Hon'ble Supreme Court in CA No. 2471/2023.

Whereas Department of Telecom issued the orders forwarding the DOPT order mentioned above, vide OM No. 38-66/2024-Pen(T) (I) dated 26.05.2025, the Department of Post has not issued the corresponding order as yet.

The ongoing delay in forwarding these orders is a significant cause of concern among the postal pensioners.
