The grievances should reach to this office on or before 12th November 2025 upto 18:00 hrs. Grievances received after 18:00 hrs of 12<sup>th</sup> November 2025 will not be considered in this Pension Adalat.

Pensioners/family pensioners who have submitted their grievances earlier and whose grievances still remain unsettled after exhausting all other available channels only shall be considered for the Adalat. Legal cases pending before the Court of Law, issues like compassionate appointments, pay anomaly, medical bills, grievances relating to issue mapping letters, pensioners' identity cards and cases related to policy matters are not within the ambit of this Pension Adalat.
