We welcome the decision of Government of India to introduce Ayushman Bharat Pradhan Mantri Jan Arogya Yojana(PM-JAY) to cover all Senior Citizens aged 70years and above. Irrespective of their Socio-economic status. However, who are already availing the benefits of other Public Health Insurance Schemes such as CGHS, ECHS and CAPF may either choose their existing or opt for PM-JAY. In respect of Senior Citizens registered under CGHS, it is found reasonable to continue with CGHS.

17th December is celebrated as Pensioner's Day in India. It was on this day 17.12.1982 that Supreme Court delivered a landmark judgment guaranteeing dignity and decency to pensioners. Pensioners Day is celebrated in our country to remember with gratefulness, late Shri D.S. Nakara, who fought for years to bring dignity and grace to the community, through the judgment. Let us go through the words once again in the landmark judgment given by Late Justice Y.V. Chandrachud, then Chief Justice - Supreme Court of India "Pension is neither a bounty, nor a matter of grace depending upon the sweet will of the employer, nor an ex-gratia payment. It is a payment for the past services rendered. It is a social welfare measure rendering socio-economic justice to those who in the heyday of their life ceaselessly toiled for the employer on an assurance that in their old age they would not be left in the lurch"

Shri H. F. Chaudhari, GS and Shri K. S. Kulkarni, AGS while in New Delhi visited the Office of Sr. DDG(PAF), DOP. On 11th November, 2024. As he was busy in the preparation of meeting with Hon. Minister, met Mrs Kalpana Singh DDG. She said the matter of Notional increment is dealt in Establishment. Finally contacted Shri Raj Kumar DDG(Estt), who issued the corrigendum as demanded by us on 11.11.2024 in the interest of postal pensioners.

In addition to Stay order of CWP 2490/2024 the Hon'ble High Court of Punjab & Chandigarh issued a Stay Order dated 09/02/2024 in the case of Shri Ram Saroop Jindal v/s State of Punjab on further recovery of commutation value of the petitioner. The Central Administrative Tribunal (CAT), Mumbai in the Order pronounced on 11th November, 2024 (OA No. 860/2024) was convinced that when the full amount of commuted pension is already recovered then there is no justification in continuing with curtailed pensions to these pensioners and ruled in favour of a group of pensioners from the Department of Post in a matter related to restoration of commuted pension after 12 years of retirement. Most of the Central Governments pensioners are thinking to approach to the CAT, to get the justice. Driving individual pensioners to Courts & legal battle is not a healthy situation. We have brought into notice of Cabinet Secretary and Secretary(Pension) on 29th April, 2024 for consideration of long pending demand of restoration of commuted pension on completion of 12 years instead of 15 years.

## Government Order

**O.M. No. 19/116/2024-Pers.Pol. (Pay)(Pt) Dated the 14th October, 2024. from GOI, Ministry of Personnel, Public Grievances & Pensions Department of Personnel & Training, North Block, New Delhi**

**Subject : Grant of notional Increment on 1st July/1st January to the employees who retired from Central Govt. service on 30th June/31st December respectively for the purpose of calculating their pensionary benefits - regarding.**

The undersigned is directed to say that in terms of Rule 10 of the Central Civil Services (Revise Pay) Rules, 2006, notified by D/O Expenditure vide Notification No. G.S.R. 622 (E) dated 29.08.2008, date of annual Increment was made uniform viz. 1 July of every year with effect from 01.01.2006. It was subsequently decided vide Rule 10 (1) of the Central Civil Services (Revise Pay) Rules, 2016, notified by D/O Expenditure Vide Notification No. G.S.R. 721 (E) dated 25.07.2016, that there shall be two dates for grant of increment namely 1st January and 1st July of every year.

2. Hon'ble High Court of Madras in its Order dated 15.09.2017 in W.P. No.15732 of 2017-P. Ayyamperumal Vs Union of India & Ors. allowed grant of notional increment to the petitioner on the day following the date of his retirement from service for the purpose of calculation of pensionary benefits. Judgement in the case of Shri P. Ayyamperumal was implemented in personam. Following this, D/O Personnel and Training (DoPT) received a number of representations from the employees who superannuated on 30th June/ 31st December claiming similar benefit. Large number of Court cases have also been filed before Hon'ble Administrative Tribunals, High Courts and Supreme Court on the subject matter.

3. The issue was examined in consultation with the nodal authorities concerned and with due regard to the relevant provisions in the Fundamental Rules (FRs) which regulate grant of increment to the Central Government employees. It is pertinent to note that FR 9(21)(a) defines 'pay' as the amount sanctioned to a Government servant for a post held by him substantively or in an officiating capacity or to which he is entitled by reason of his position in a cadre. FR 17 provides that subject to any exceptions specifically made in these Rules, an employee shall begin to draw the pay and allowances attached to his tenure of a post with effect from the date when he assumes the duties of that post and shall cease to draw them as soon as he ceases to discharge those duties. Further, FR 24 stipulates that an increment may be withheld from a Government servant if his conduct has not been good or his work has not been satisfactory. To summarise these Rule provisions, for availing the benefit of an Increment on the date of its accrual, an employee should be in service, should have rendered satisfactory work and should have displayed good conduct during the period of qualifying service.

4. However, Hon'ble Supreme Court vide Order dated 11.04.2023 in Civil Appeal No.2471 of 2023 (@SLP (C) No. 6185/2020) - Director (Admn. and HR), KPTCL Vs C.P. Mundinamani & Ors, upheld the Orders passed by the Division Bench of the Hon'ble High Court of Karnataka at Bengaluru in Writ Appeal No. 4193/2017 allowing grant of one annual Increment, which the original writ petitioners earned on the last day of their service for rendering services during preceding one year from the date of retirement with good behaviour and efficiently, for the purpose of calculating the retiral benefits. However, Union of India was not among the Parties in the said case.

5. Subsequently, Hon'ble Supreme Court vide Order dated 19.05.2023 dismissed SLP(C) No.4722/2021 (UoI Vs M. Siddaraj) filed by M/o Railways on the subject matter with the observation that the appeals filed therein are squarely covered by the Order dated 11.04.2023 in CA No. 2471 of 2023. M/o Railways filed a Miscellaneous Application (MA No. 2400/2024) before the Hon'ble Supreme Court seeking guidance/ clarification regarding the modalities to be adopted while Implementing its Order dated 19.05.2023. On 22.07.2024, while hearing the matter, Supreme Court ordered that the learned counsel for the Union of India shall examine as to whether Union of India needs to file an application in CA No.2471/2023 disposed of vide judgment dated 11.04.2023. After due legal consultations on the directions of the Apex Court, this Department filed a Petition (Dy. No. 36418/2024) before Supreme Court on 12.08.2024 seeking review of its Order dated 11.04.2023 which is pending before the Hon'ble Supreme Court.

6. Meanwhile, on 06.09.2024, while hearing MA No. 2400/2024 filed by Mo Railways along with several Intervention Applications tagged therewith, Hon'ble Supreme Court took note of the pending Petition (Dy. No. 36418/2024) filed by Union of India seeking review of its Order dated 11.04.2023 In CA No.2471/2023 in the matter. While observing that the issue raised in the applications requires consideration Insofar as the date of applicability of the judgment dated 11.04.2023 In CA No. 2471/2023 to third parties is concerned, Hon'ble Court issued following directions, by way of an Interim Order, to prevent any further iltigation and confusion:

a. The judgment dated 11.04.2023 will be given effect to in case of third parties from the date of the judgment, that is, the pension by taking into account one increment will be payable on and after 01.05.2023. Enhanced pension for the period prior to 30.04.2023 (erroneously mentioned as 31.04.2023 in the Order) will not be paid.

b. For persons who have filed writ petitions and succeeded, the directions given in the said judgment will operate as res judicata, and accordingly, an enhanced pension by taking one increment would have to be paid.

c. The direction in (b) will not apply, where the judgment has not attained finalty, and cases where an appeal has been preferred, or if filed, is entertained by the appellate court.

d. In case any retired employee has filed any application for intervention/impleadment in Civil Appeal No. 3933/2023 or any other writ petition and a beneficial order has been passed, the enhanced pension by including one Increment will be payable from the month in which the application for intervention/impleadment was filed,

This Interim order will continue till further orders of this Court. However, no person who has already received an enhanced pension including arrears, will be affected by the directions in (a), (c) and (d).

Relist in the week commencing 04.11.2024.”

7. The matter has been examined in consultation with Dio Expenditure and D/O Legal Affairs. It is advised that in pursuance of the Order dated 06.09.2024 of the Hon'ble Supreme Court referred above, action may be taken to allow the increment on 1st July/ 1st January to the Central Government employees who retired/are retiring a day before it became due I.e. on 30th June/31 December and have rendered the requisite qualifying service as on the date of their superannuation with satisfactory work and good conduct for calculating the pension admissible to them. As specifically mentioned in the Orders of the Hon'ble Supreme Court, grant of the notional increment on 1st January/1st July shall be reckoned only for the purpose of calculating the pension admissible and not for the purpose of calculation of other pensionary benefits.

8. It may also be noted that these instructions are being issued in compliance of the Interim Orders dated 06.09.2024 of the Hon'ble Supreme Court in MA Dy. No.2400/2024 without prejudice to the legal stand of the Union of India in the matter and without prejudice to any change of law in this regard. Further, the action taken shall be subject to the final outcome of the Review Petition (Dy. No.36418/2024) pending before the Hon'ble Supreme Court which is expected to be heard by the Apex Court in the week commencing 04.11.2024.

9. This issues with the concurrence of D/o Expenditure vide their Dy. No. 08- 09/2019-E.III.A(Vol.III) (3969602) dated 08.10.2024 and D/o Legal Affairs vide Computer Dy. No. E 128445 dated 30.09.2024.

**O.M. No. 1/15/2024-PAPW(F)/9809, Dated the 25 October, 2024 from GOI, Department of Pension & Pensioners' Welfare, 3rd Floor, Lok Nayak Bhavan, Khan Market, New Delhi,**

**Subject : Implementation of pension related rules and timely release of retirement benefits by the administrative Ministries / Departments.**

Department of Pension and Pensioners' Welfare (DoPPW) has recently issued Central Civil Services (Extraordinary Pension) Rules, 2023. These rules apply to the Government servant to whom the Central Civil Services (Pension) Rules, 2021 apply. Extraordinary Pension (IOP) Rules are in the form of Disability pension/extraordinary family pension that may be paid to the Government servant/his family if disablement/

death (or the aggravation of disablement/death) of the Government servant, during his service, are attributed to the Government service.

2. The above rules are implemented by the administrative Ministry Department/ Organisation. Recently, in one such case court ordered for grant of EOP to the eligible family members of few Government servants who were killed in action during Govt duty. There was order from the court to grant them family pension under EOP Rules. However, the concerned Department took a view that since these employees are covered under EOP Rules which have been notified/issued by DoPPW, hence, the order should be implemented by DoPPW. The matter was subsequently clarified to the that Department and the same was implemented by that Department only. However, the process got prolonged resulting delay in payment etc.

3. In view of the above experience, it is reiterated that as per provisions of the Allocation of Business Rules in the Govt of India, sanction of pension/pensionary benefits is the sole mandate and responsibility of the administrative Ministry/Department/organisaition. Therefore, the concerned organization is required to release all the retirement benefits including EOP as per rules at the earliest possible. It is added that delay in payment of pension, gratuity and family pension attracts payment of interest in terms of Rule 65 of CCS (Pension) Rules, 2021.

4. All Ministries/Departments are requested to observe the above strictly and sensitise all authorities under them to process and relcase payment in such cases at the earliest possible.

5. This issues with the approval of competent authority.

**O.M. F.No. 38/10(04)/2024-P&PW(A) (e 10124), Dated: 18.10.2024 from GOI, Department of Pension & Pensioners' Welfare, 3rd Floor, Lok Nayak Bhawan Khan Market, New Delhi-110 003,**

**Subject : Revision of pension after authorisation under Central Civil Services (Pension) Rules 2021-reg.**

The undersigned is directed to say that as per Sub Rule 2 of Rule 66 of CCS(Pension) Rules 2021 [erstwhile Rule 70 of CCS(Pension) Rules 1972), subject to provisions of Rule 7 and 8 of CCS(Pension) Rules 2021, **pension or family pension once authorised after final assessment or revised under Sub Rule 1 of Rule 66 of CCS(Pension) Rules 2021 shall not be revised to the disadvantage of the pensioner or family pensioner unless such revision becomes necessary on account of detection of a clerical error subsequently**, In case the clerical error is detected after a period of two years from the date of authorisation or revision of pension or family pension, no revision of pension to the disadvantage of the pensioner or family pensioner shall be ordered without the concurrence of Department of Pension and Pensioners" Welfare

2. Further, **the question whether the revision has become necessary on account of a clerical error or not shall be decided by the administrative Ministry or Department.** If, consequent on revision of pension or family pension under sub-rule 2, an excess payment of pension or family pension is found to have been made to the pensioner or family pensioner **and if such excess payment is not on account of any misrepresentation of facts by the pensioner or family pensioner, the administrative Ministry or Department shall examine in consultation with the Department of Expenditure whether or not recovery of such excess payment can be waived off** and issue appropriate orders in accordance with the relevant rules and instructions in this regard. Where the administrative Ministry or Department decides not to waive off the excess payment of pension or family pension, the retired Government servant concerned or family pensioner shall be served with a notice by the Head of Office requiring him to refund the excess payment of pension within a period of two months from the date of receipt of notice by him. In case the Government servant fails to comply with the notice, the Head of Office shall, by order in writing, direct that such excess payment shall be adjusted in instalments by short payments of pension in future, in one or more instalments, as the Head of Office may direct.

3. All Ministries/Departments are requested that the above provisions of Central Civil Services (Pension) Rules, 2021 may be brought to the notice of all concerned for compliance.

**O.M. No. 11/15/2022-P&PW(II)-8363 (I), Dated- 24-10-2024 GOI, Department of Pension and Pensioners' Welfare, 3rd Floor, Lok Nayak Bhawan, Khan Market, New Delhi-110 003**

**Subject : Change of name of spouse- Advice of Department of Pension and Pensioners' Welfare.**

The undersigned is directed to refer to this Department's OM No. 3(2)/2022- P&PW(11)-7942 dated 6-10-2022 regarding change of name of spouse (Copy attached). The advice contained in the above-mentioned OM dated 06-10-2022 are as under:

(i) There is no separate procedure prescribed in the CCS (Pension) Rules, 2021 or CCS (Pension) Rules, 1972 for change of name/surname in the PPO of Government employees or spouse after retirement. The PPO is issued on the basis of service record/service book of the employee and the maintenance of service book is concerned with DoPT.

(ii) Further, this matter was discussed in the inter-ministerial Review meeting of pending grievances in CPENGRAMS, held under the chairmanship of Director (PW), Department of Pension & Pensioners' Welfare, Ministry of Statistics & Programme Implementation were informed that they may follow DoP'T's OM No. 190016/187-Estt. dated 12th March, 1987 for change of name of family pensioner also. In case the Ministry of Statistics & Programme Implementation feels that there is some discrepancy in the documents submitted by the complainant family pensioner in support of her application for change of name in the PPO, they may sort it out with her directly and ensure that the request for change of name fulfils the conditions of DoP'T's OM No. 190016/187-Est. dated 12th March, 1987.

2. All Ministries/Departments are requested that the above provisions may be brought to the notice of the personnel dealing with the pensionary benefits in the Ministry/Department and attached/subordinate offices thereunder for compliance.

**Subject : Clarification on deletion of name of daughter from the family details of a Central Government pensioner.**

The undersigned is directed to say that the Department of Pension and Pensioners' Welfare has notified the Central Civil Services (Pension) Rules, 2021 in supersession of the Central Civil Service (Pension) Rules, 1972

2. Rule 50 (15) of the CCS (Pension) Rules, 2021 provides that as soon as a Government servant enters Government service, he shall give details of his family in Form 4 to the Head of Office, which shall include all relevant details relating to spouse, all children, parents and disabled siblings (whether or not eligible for family pension). This Rule further provides that the Government servant shall submit the up to date details of the family in Form 4 again along with the pension papers, before retirement from Government service.

3. References were received seeking clarification in respect of deletion of name of the daughter from the details of family members after retirement of the Government servant.

4. It has been clarified by this Department vide OM No. 3(2)/2022-P&PW(1)-7942 dated 07-10-2022 that the Government servant/pensioner shall submit details of all member of family whether or not eligible for family pension. The daughter is deemed to be a member of the family of Government servant as and when intimated by the Government servant in the prescribed proforma. Hence, the name of the daughter shall remain included in the details of family members. The eligibility for family pension would be decided after demise of pensioner/family pensioners in accordance with the existing rules.

5. All Ministries/Departments are requested that the above provisions may be brought to the notice of the personnel dealing with the pensionary benefits in the Ministry/Department and attached/subordinate offices thereunder for compliance.

**Subject : Minutes of the meeting held on 14.10.2024 on Simplification of Family Pension Rule.**

A meeting was held to discuss simplification of Rule 50 of the CCS (Pension) Rules, 2021 on Monday, the 14th of October, 2024 at 04:30 p.m.in Lok Nayak Bhawan under the chairmanship of JS (P&PW). The following Officers attended the meeting:

2. Brief of discussions and action points are as follows:

(i) The Chair began the discussion by acknowledging the need to deliberate deeply on simplifying Rule 50 of the CCS (Pension) Rules, 2021, the family pension rule, which has become lengthy and convoluted over time due to amalgamation of Amendments and Orders.

(ii) The Chair then invited comments from the representatives of the associations as they are on the cutting edge of the issues faced by pensioners.

(iii) Comments of the Stakeholders are as below:

S.No.	Remarks
1	Ms. Nagalaxmi pointed out some deficiencies in Rule 50(9) and requested that they may be addressed during the simplification process.
2	Ms. Rajalaxmi pointed out the need to accurately define terminologies such as 'Livelihood' used in the Rules which would lead to better standardisation of processes across organizations. Further, disability percentage for eligibility for Family Pension may be specified in the rules.
3	Sh. Chaudhary requested that during formulation of the simplified rules, particular care may be taken for inclusion of transgender persons in Rule 50(9)(2). He also suggested that a clear list of supporting documents for establishing relationship with pensioner may be prescribed in the rule especially in case of widowed daughter who becomes a widow after the demise of the G.S.
4	Sh. Kanagotagi suggested that a flow chart may be prepared indicating the family member next in line to receive Family pension. He also suggested that the definition of 'Family Member' may be expanded keeping in mind the modern Indian context.

(iv) The Chair acknowledged the remarks of the attendees and directed the following:

a. Standardisation: All forms & formats may be standardised and a list of prescribed documents may be defined during the process of simplification of rules.

b. Co-authorization: Co-authorization of family pensioners may be made a default/standard practice. This would decrease administrative burden and would reduce delay in payment of family pension to next of kin.

c. Family Pension Flow Chart may be prepared.

d. An internal document on simplification may be prepared and shared with the participants for their perusal and comments.

3. The meeting ended with a vote of thanks.

Please refer to DOPT OM No. 19/116/2024-Pers.Pol.(Pay) (Pt) dated 14.10.2024 (copy enclosed) whereby guidelines to deal with the cases of grant of notional increment to the officials retiring on 30th June or 31st December, as the case may be, have been issued based on the interim directions of the Hon'ble Supreme Court in Review Petition No. 2400/2024 and connected matter seeking review of its order dated 11.04.2023 in CA No.2471/2023.

2. Hon'ble Court has inter-alia issued directions that the judgement dated 11.04.2023 will be given effect to in case of third parties from the date of judgement (in CA No. 2471/2023), that is, the pension by taking into account one increment will be payable on and after 01.05.2023. Enhanced pension for the period prior to 30.04.2023 will not be paid.

3. On the basis of the aforesaid OM dated 14.10.2024 of the DoPT and interim directions of the Hon'ble Supreme Court mentioned above, following course of action has been approved:

(i) The officials retiring on 30th June/31st December and have rendered the requisite qualifying service as on the date of their superannuation with satisfactory work and good conduct will be entitled for a notional

increment as on 1st July/1st December, as the case may be, for calculating the pension admissible to them. The notional increment will not be admissible for any other pensionary benefit. The orders will be applicable on all the officials retired after 30.04.2023. The payment of enhanced pension would be subject to the outcome of the above referred Review Petition of the Govt. of India.

(ii) In respect of pending court before CAT/High Court etc., the concerned Circle will apprise about the aforementioned interim directions of the Hon'ble Supreme Court as well as the orders of the DoPT for disposing of the cases accordingly..

(iii) The individual representations of the officials, retired before the crucial date of 30.04.2023, may be disposed off accordingly.

(iv) In case the benefit has been extended by the Tribunal/Court in individual case who have retired prior to April 30th 2023 and it has not been implemented so far, the decision of the lower court/tribunal will be challenged before the higher court.

(v) The pending contempt petition may be contested on the basis of the aforementioned interim orders of the Hon'ble Supreme Court. In appropriate cases, filing of review petition/writ petition may be considered in consultation with government counsel by filing review petition.

(vi) Benefits granted to ex-officials prior to the issuance date of this OM shall not be recovered.

We wish to bring into your notice the discrepancy in the DOP order mentioned under the reference above.

The DOPT has issued the advisory vide OM 19/116/2024-Pers. Pol(Pay)(Pt) dated 14-10-2024 in pursuance of the interim orders of Hon'ble Supreme Court dated 06.09.2024 in MA Dy. No. 2400/2024.

Para 7 of the order mentioned above clearly mention and quote 'It is advised that in pursuance of the order dated 06.09.2024 of the Hon'ble Supreme court referred, action may be taken to allow the increment on 1st July/1st January to the Central Government employees, who retired/are retiring a day before it became due ie. on 30th June/31st December and have rendered the requisite qualifying service on the date of their superannuation with satisfactory work and good conduct for calculating the pension admissible to them'.

As per the directives of the Hon'ble Supreme court, mentioned in Para 6 a. of the said order mention 'The judgment dated 11.04.2023 will be given effect to in case of third parties from the date of the judgment, that is, the pension by taking into account one increment will be payable on and after 01.05.2023. Enhanced pension for the period prior to 30.04.2023 will not be paid.'

**As per the directives of the Hon'ble Supreme Court and the advisory issued by DOPT, the Notional increment is to be granted on 1st July/1st January to the Central Government employees, who retired/ are retiring a day before it became due ie. on 30th June/31st December irrespective of the date of their retirement after 1.1.2006 but the revised pension will be payable with effect from 01.05.2023.**

Department of post has issued the orders dated 18.10.2024 mentioned under the reference for implementation of the DOPT's OM dated 14-10-2024.

Last CGHS WC was sanctioned for Pune in the year 1986 after that there is no further expansion of CGHS in Pune, even though the city of Pune has spread far and wide. The population of Pune has also increased several folds. In fact the city of Pune has been declared as the biggest city in Maharashtra recently, larger than Mumbai (area wise).

There are 21 CGHS WCs under CGHS Mumbai whereas there are only 9 WCs under CGHS Pune although the geographical area of BMC is smaller than PMC.

Therefore, it is proposed open new WCs at Pune in the following localities.

**Subject : Advisory to All CGHS Empanelled Healthcare Organizations (HCOs).**

It has come to the Directorate's attention that certain Healthcare Organizations (HCOS) are engaging in fraudulent activities when submitting bills on the NHA portal. Complaints have also been received from beneficiaries regarding overcharging, denial of treatment, and other grievances. To address these issues, the following guidelines are issued for strict compliance by all HCOs empanelled under CGHS:

#### **1. Provision of Services**

- HCOS must not deny services to any eligible CGHS beneficiaries.
- Beneficiaries/ In cases of patient death or when the patient is in a coma, the signatures of the beneficiaries' attendants, along with their mobile numbers, must be obtained on the final bills for all Indoor and OPD services, including daycare. laboratory services, dialysis, etc.

#### **2. Reporting Requirements**

HCOs must report the following cases to the respective Additional Director's office within 24 hours via email to the dedicated email IDs (to be shared by the respective Additional Directors) :

- Details of non-referral cases.
- Emergency admissions and consultations.
- Direct visits and admissions of beneficiaries aged 70 years and above, including inpatient card details.

Cases that are not reported to the Additional Directors (ADS) will not be processed for approval.

#### **3. Bed Availability Display**

- HCOS must prominently display the availability of beds in various wards and ICUS for the benefit of visiting patients.

#### **4. Ward Entitlement**

- Beneficiaries must be provided their entitled ward category. Allocating a lower category is unacceptable.

#### **5. Prescription Standards**

- Prescriptions must be written in generic names and in capital letters.
- HCOs must not insist on specific brands.

#### **6. Acceptance of Medicines**

- HCOS must accept medicines supplied by CGHS, which are procured through standardized procurement processes, ensuring proper cold chain maintenance.

- If an HCO declines to accept CGHS-restricted medicines, they must provide the purchase invoice for the medicines. In such cases, reimbursement will be made based on the purchase invoice cost.

### **7. Implant/Device Choices**

- If a beneficiary selects an implant priced above the CGHS ceiling rate, informed consent must be obtained, clearly stating that the additional cost cannot be claimed from CGHS. This consent must be attached to the bill.

### **8. Information Display**

All HCOs must display the following details on their notice boards and in other prominent places:

Empanelled under: CGHS City

Charges: As per CGHS approved rates

Beneficiaries eligible for Credit : Pensioners, Ex-Members of Parliament, Sitting Members of Parliament, Freedom Fighters, Serving CGHS/DGHS/Ministry of H&FW Employees, Serving employees in emergency & Other Categories of CGHS Cardholders (as notified by the Government)

### **Name and contact of the Nodal Officer:**

Escalation Matrix:

Email Id of Additional Director CGHS:

### **9. Nodal Officer Updates**

Any changes in the Nodal Officer's details (name or phone number) must be immediately communicated to the respective Additional Director.

**10. Portal Data Entry :** Only the beneficiary's phone number must be entered in the BIS/TMS portal.

### **11. Daily Photo Uploads :**

- Geo-tagged photos of all admitted (IPD) cases must be uploaded to the TMS portal daily.
- For OPD cases, photos taken on the same day must also be uploaded.

### **12. CGHS Help Desk/Kiosk**

- All HCOS must establish a CGHS Help Desk/Kiosk on their premises to facilitate beneficiaries.

### **13. CGHS Card Handling**

- HCOS are strictly prohibited from collecting or retaining the hard copy of the CGHS card of any beneficiary.

### **14. Adherence to Package Rates**

- HCOS must not collect any amount from beneficiaries beyond the package rates prescribed by CGHS.

### **15. Fraudulent Billing**

- Submission of fake bills or forged documents by any HCO will be considered financial fraud. Appropriate legal action will be initiated, including the filing of an FIR against the institution, in accordance with the law of the land.

**Failure to adhere to these instructions will result in serious consequences, including de-empanelment or blacklisting, as per the provisions of the Memorandum of Agreement (MOA).** All empanelled HCOs are directed to ensure strict compliance with the above guidelines.

**Subject : Yearly revalidation of BSNL MRS Card for retirees, regarding.**

As you are aware, retired employees are required to revalidate their BSNL MRS Card every year. The medical card revalidation is being done in the respective BAs for which retirees are required to be present in person in concerned office or sometimes documents are sent via posts.

It is observed that this very requirement of personally being present in front of concerned person in respective office causes a lot of hardship and unnecessary inconvenience particularly for the aged and infirm retirees who cannot always be in a position to present themselves in front of the particular authority.

Moreover, it is seen that Online Digital Life Certificate for Pension related requirements is now being done through biometric enabled Jeevan Pramaan digital service for pensioners which provides life certificates to the authorized pension disbursing agencies like Banks, Post offices etc.

Hence, in order to enable hassle-free revalidation of Medical Card issued to retired employees under BSNL MRS, **it is decided that Medical Card Issued to BSNL retirees shall be validated yearly on submission of digital Life Certificate issued by Jeevan Praman Portal. Digital Life Certificate may be submitted to the concerned authority electronically through email/messenger etc. to concerned BA/SSA/Circle office.** However, existing process of revalidation shall continue for any change in beneficiary.

It is therefore, requested to nominate one AGM/SDE under Admin/HR section in Circle/BA offices for confirming revalidation of BSNL MRS card electronically, on the basis of Digital Life Certificate received through email/messenger from retired employees. The official email(s)/Contact details of Nodal Officer may also be provided to unions/associations representatives.

A compliance report for the same shall be submitted by 10th December 2024, Positively for perusal of Director (HR).

**Minutes of the Meeting held with the office bearers of various Pensioners Welfare Association on 27-09-2024 at O/o CCA (MH & Goa) to discuss various points to relating to Pensioners**

AO (PDA) on behalf of CCA & Jt.CCA, welcomed all the participants to the quarterly meeting of the Pensioners Association and further requested Jt.CCA to address the Association office bearers gathered.

Jt.CCA welcome all the officer bearers gathered for the meeting. He stated that similar points have been highlighted by all the association and they have been taken into account and process initiated to resolve the same. He further requested due care to be taken about the words / language used whenever grievances are raised or mails sent to the office, so that the same can be taken in right spirit and resolved. He further requested the office bearers that individual cases may not be discussed in the meeting and cases / problems in general shall be taken up and further directed AO (Pension) to start the discussion.

AO (Pension) informed that an agenda has been compiled based on the representations / points submitted by all the associations and the same will be discussed - point wise. He further stated that individual cases may be forwarded to the section for discussion / resolving the same.

Following points were discussed :

- 1. Disbursement of Monthly Pension :** Pensioners Association Office bearers expressed pleasure that the pension was disbursed well in advance for the month of September 2024 and requested that the practice to be continued in the coming months also.

Jt. CCA assured that every effort is taken by CCA (MH& Goa) office to disburse the pension in time each month and the same will be continued in the coming months also.

- 2. Requirement of NOC for transfer of Bank Account :** AO (Pension) stated that NOC is required in case the pensioners want to transfer their account from one bank to another or from post to Bank & vice versa. He further stated that in case of Post office an account closure letter will also be accepted.

Association members requested that this requirement of NOC may be included in the guidelines / procedure laid down for shifting of account so that the pensioners will take note of it and send it compulsorily as when shifting of bank accounts is required to be done. **Jt. CCA directed AO(Pension) to take note of it and make necessary additions as stated.**

- 3. Non pay corrections :** AO (Pension) stated that a number of grievances are being received for corrections such as Mobile Number. These minor corrections are done immediately. However, for corrections to be done in Date of Birth, Date of Appointment, copy of PPO alongwith other relevant documents is mandatorily required. He further stated that if there is mismatch in date of birth of family pensioner in PPO & documents produced, then an affidavit has to be produced stating the correct date of birth to be taken into account. If no date of birth is available in the records, then date of birth mentioned in PAN or any other documents of proof of DoB may be considered. If there is change in name of family members, then copy of PPO is strictly required, else a gazette notification / affidavit regarding change of name may be produced. It is once again reiterated that this office strictly follows all the details mentioned in the PPO and change required to be done requires the PPO copy.

All the Association members present were once again requested to educate the pensioners about this and intimate them to send the copy of PPO / documents as stated while sending any request for correction in SAMPANN.

- 4. KYP Updation :** AO (Pension) informed that 7000 approx. KYP has been updated. Once the KYP is updated then the pensioners can view their updated photo / signature on login. KYP updation is continuous process. He further stated that if only Mobile number is to be updated, then a separate form is available (in website) and pensioners need to submit this form for mobile updation and the same will be updated immediately. If anyone has submitted the form but not yet updated may be intimated to forward the same again.

- 5. Issue of ID cards :** AO (Pension) intimated that applications received till date have been processed and ID cards issued. If any of the pensioner though applied have not received their ID cards, may be intimated to send the application again. He further stated that if there is any correction to be done in ID card already issued, then the pensioner needs to send the original ID card along with the information

regarding the correction to this office by post. It was also stated by AO (Pension) that this office has received a lot of ID card back as undelivered'

Association Members stated that a list of name and PPO number of the pensioners those whose ID card has returned as undelivered may be published on website' which they will also pursue with the concerned pensioners - **AO (Pension) to look into it'**.

6. **Income Tax related issues** : AO (PDA) stated that TDS has been deducted on the interest due on deferred gratuity to be paid in this financial year. The pensioners have to submit their proposed investment to be made by them and submit the proof of investment in time. If no document is received then they will be taxed under new TAX regime by default. It was also reiterated that advance messages have been sent to all concerned informing them about the TDS deduction of interest on deferred gratuity.

Association members requested for deducting TAX in lumpsum from the interest that will be paid. However, it was again conveyed to them that TDS has been deducted as per the provisions in Income TAX Act wherein Estimated income to be earned in future in the financial year has to be taken into account.

Association Members requested that the details of TAX due for the year as well as TDS deducted and TAX to be paid may be reflected in the pension slip for the reference of the Pensioners.

CCA directed Ao (Pension) / AO (PDA) to take the matter with SAMPANN TEAM to check feasibility for the information to be printed in Pension Slip.

#### **Additional Points**

1. **Life Certificate** : Association members requested that the DLC list uploaded on website may be put up Pin code wise. AO (PDA) to look into it.

JT.CCA stated this office is going to organize DLC camps through out Maharashtra in the coming days for the benefit of pensioners. It was once again reiterated by JT.CCA that Association office bearer should educate and impart training to the pensioners to update LC through various means available

2. **Setting up of effective grievance reply mechanism** : Association Members highlighted that emails/ grievances are not acknowledged by CCA Office.

CCA Madam assured that whatever grievances are received through mail / TOLL free number are addressed and settled. However, it was also stated that whenever grievances sent, care should be taken that it should be short with full details' Moreover, whenever updation is required then such grievances should be accompanied with documents.

3. It was stated by Association Members that grievances are closed in SAMPANN without actually resolving them. AO (Pension) stated that there is no mechanism in SAMPANN Grievance option to let the pensioners know about the documents required. As a result, it closes the case as resolved. In such case, the pensioner needs to send the documents for settling their grievance.

CCA directed AO (Pension) to take up this issue with SAMPANN Team / CGCA Office.

4. It was also stated by Association Members that 2nd stage Family Pension cases may be settled on Priority basis.

5. It was stated by Association Members that those pensioners who have retired before the year 2000 are asked for LPC by CGHS officials to transfer to CGHS facility. Jt.CCA stated that LPC cannot be issued by this office. However, last pay mentioned in ppO can be referred in such cases. He further directed AO (Pension) to issue a certificate certifying the last pay available in PPO for such pensioners who require it. - **AO (Pension) to look into it.**

6. It was stated by Association members that restoration of communication is pending for many pensioners. Jt. CCA directed to submit a list of all such pensioners to the concerned AO.

Dy.CCA thanked all the association members present for sharing / bringing out the problems/ issues faced by pensioners and helping cCA office to take a note of it and resolving the same. He also appreciated that the discussions were held in a peaceful manner with each side patiently listening. He ensured that o/o ccA (MH & Goa) is committed to look into the grievances of the pensioners and will take every effort for settling the same. The Communication Accounts O/o CCA (tt/H & Goa) meeting ended on a Positive note.

**Respected Sir,**

AICGPA Hq. Pune is the oldest pensioners Association formed by P&T pensioners in 1947 in Pune. Considering its activities, achievements and network, DOP&PW Delhi recognized it as identified Pensioners Association and a Standing Group member of SCOVA constituted in September, 2023. We represent most of the Postal/DOT/BSNL pensioners in South MP, Maharashtra, North Karnataka and Some districts of Tamilnadu.

We extend sincere gratitude for arranging Virtual Meeting with members of SCOVA on 1st October, 2024 at 2.15 P.M. on CGHS related matters. We hereby submit the following suggestions discussed during the said meeting.

1. Parliamentary Standing Committee on Personnel, Public grievances, Law and Justice(Report No. 120) was in agreement with the views of Pensioners Associations that Govt. may explore opening of CGHS Wellness Centers at District Headquarters.

Maharashtra being a progressive state, District headquarters are expanded, well developed cities. Sufficient number of Central Govt. employees /pensioners/BSNL pensioners are residing at the District headquarters. There is a demand of extension of CGHS facilities at Amaravati, Kolhapur-Sangli, Nanded, Satara.

2. In response to the strong demand from Pensioners at Kolhapur, we joined the hands with the Service Associations and submitted the proposal for extension of CGHS facilities at Kolhapur.

CGHS Directorate responded to the proposal stating that opening of a new wellness centre involves creation of new posts of staff and has financial implications. For this the approval of the Department of Expenditure is required. It seems they closed the proposal ignoring the demand. The copy of the letter is enclosed for ready reference.

3. At present there are only 9 CGHS Wellness Centres in Pune and Pimpri Chinchwad area. Last Wellness Centre was sanctioned for Pune in the year 1986. Pune City is expanded since 1986 and spread far and wide. But No CGHS Wellness center was opened to meet the demand. On the demand of ZAC, Additional Director, CGHS Pune has submitted the proposal dated 01.05.2024 for opening 5 additional CGHS wellness centers at Kothrud, Hadapsar, Pimpri, Lohagaon and Katraj. Copy of Additional Director's is enclosed herewith for ready reference.

4. We suggested one BSNL accommodation for Wellness Centre at Karve Road Telephone Exchange Building. Additional Director visited the place but said the rental charges quoted by BSNL is not found reasonable.

5. Shortage of staff: This item was discussed during 33rd SCOVA meeting held on 22/02/2024. But there is no improvement in the situation as yet.

Especially at CGHS Wellness Centre, Chhatrapati Sambhaji nagar(Aurangabad) covering 3500 CGHS Card, is run by only one Doctor. Good number of CGHS beneficiaries have to go back at 2 pm, without consultation/treatment. CGHS beneficiaries are demanding one Ayurvedic dispensary to meet the additional demand. Additional Director is not in a position to meet the demand due to shortage of staff.

We hereby request your honor to consider these suggestions and take up with CGHS authorities.

**B. Individual Grievances:**

We are sorry to reiterate the following grievances, which were raised in Agenda of the earlier meeting held on 27th September, 2024 and are not resolved so far.

1. Smt D. Kameshwari, wife of late D. Jagannadhan, Resident Audit Officer Retd. was migrated to SAMPANN in the month of December, 2023. She did not receive the pension for the month of November 2023. Union Bank of India advised her to approach CCA, Maharashtra.
2. Smt. Savitri Chidambar Kulkarni, Family Pensioner was migrated on 20/09/2023 PPO No., 402012011144071. Pension was stopped from September, 2023. It was informed by Accounts Officer(PDA) that the Pension Authorising Authority was CCA, Karnataka. The account is required to be transferred again on migration. Hence the Life Certificate Validity date was preponed to stop the payment. Family pensioner is still waiting for the arrears of pension.

CPAO, Ministry of Finance, Dept of Expenditure forwarded the representation alongwith original pensioner's disbursers half to Dy. Director (A/CS) CRPF 1, New Delhi-110066 vide letter dt. 31/03/2022 for necessary action. The copy of the same is enclosed herewith.

We are sorry to say, Family did not receive any response thereafter and she is living life without Family pension.

We hereby request you to look into personally and arrange to take an immediate action to transfer her pension in the Bank of Maharashtra to disburse the family pension with arrears.

**Subject :** Restoration of Commuted portion of pension on completion of 12 years in stead of 15 years:

**Respected Sir,**

We earlier addressed this issue to Department of Pension & Pensioners Welfare vide letters latest one dated 29th April, 2024 for rectification of error in Commutation factor and restoration of commuted pension on completion of 12 years instead of 15 years.

There is a full justification for restoration of commuted pension immediately after 12 years. Commutation table requires to be calibrated by taking into account RBI Repo rate. Interest rates started declining from 2019 and were within the range of 4.5% to 7% for quite some period but Government considered interest rate of 8% for calculation of restoration period.

5th Central Pay Commission had proposed recommendation, which favored pensioner's demand of bringing down the period of recovery to 12 years from 15 years.

The state government of Gujarath have already issued the orders for restoration of commuted value after 13 years. The State Government of Andhra Pradesh have already brought down the recovery period to 12 years

The DOP&PW has also recommended for restoration after 13 years in 2014 and after 12 years in 2023.

Hon'ble High Court of Punjab & Chandigarh issued a Stay Order dated 09/02/2024 in the case of

Shri Ram Saroop Jindal v/s State of Punjab on further recovery of commutation value of the petitioner. Government of Punjab has issued directions vide letter Dated: 29.08. 2024 to stop the recovery of Commuted Value of pension till vacation of Stay Orders, from all pensioners (including petitioners) of State Government, who have completed 10 years of retirement.

The Central Administrative Tribunal (CAT), Mumbai vide the Order pronounced on 11th November, 2024 (OA No. 860/2024) was convinced that when the full amount of commuted pension is already recovered then there is no justification in continuing with curtailed pensions to these pensioners and ruled in favour of a group of pensioners from the Department of Post in a matter related to restoration of commuted pension after 12 years of retirement.

Most of the Central Governments pensioners are in the chaos and thinking to approach to the CAT, to get the justice. Driving individual pensioners to Courts & legal battle is not a healthy situation.

Sir, We feel, in view of long pending demand of all Pensioners Associations, recommendation of 5th CPC, recommendation of DOP&PW, New Delhi, some State Government's decisions for their pensioners and latest Hon'ble CAT Mumbai verdict on 11th November, 2024, DOPT may take up the issue with the Ministry of Finance to arrest displeasure amongst the pensioners.

Sir, We therefore request to your honor to intervene in the matter, so that the Government will consider the restoration of commuted portion of pension on completion of 12 years only favorably.
