## GS Speaks:

Annual General Body Meeting of AICGPA Hq. Pune was held at Shri Kalikka Devi Mandir Sansthan Bhaktniwas, Nashik on 11<sup>th</sup> & 12<sup>th</sup> October, 2025. We extend our gratitude towards the Organizing team under the guidance of SarvaShri Arvind Jadhav, President, Vinayak Suryavanshi, Secretary, Shri B. J. Bhosale Vice President and Shri Ajit Julkarni for the arrangement of AGM with success.

Union Cabinet approved the Terms of Reference of 8<sup>th</sup> Central Pay Commission on 28<sup>th</sup> October, 2025. As there was no specific mention about the revision of existing pensioners. We addressed the Cabinet Secretary to include the item ' Revision of Pension in the case of employees, who have retired prior to the date of effect of the recommendations' as included in the Gazette Notification for Terms of reference of 7<sup>th</sup> Central Pay Commission. Ministry of Finance issued the Gazette Notification on 3.11.2025 for constitution of 8<sup>th</sup> CPC and Terms of Reference of the Commission. Terms Of Reference Vide item e(ii) include and quote " To review the Death-cum-Retirement Gratuity and pensions of employees not borne on the National Pension System (including Unified Pension Scheme) and make recommendations thereon keeping in view Para f(iii) below.

" In my opinion, this provision covers the pension revision of existing pensioners (OPS) also. Which is again confirmed with the reply by Hon'ble Minister of State in the Ministry of Finance, Shri Pankaj Chaudhary to question no. 1347 in Lok Sabha on 8<sup>th</sup> December, 2025. To the question of the present status of constitution and other proceedings regarding the setting up of 8<sup>th</sup> Pay Commission along with total number of Central Government employees and pensioners benefited; Hon'ble Minister replied and quote "The 8<sup>th</sup> Central Pay Commission (CPC) has already been constituted. The Terms of Reference (TOR) of the 8<sup>th</sup> Central Pay Commission have been notified vide Ministry of Finance Resolution dated 03.11.2025. The number of Central Government employees is 50.14 lakh and the number of pensioners is 69 lakh approximately." **No doubt, we will keep close watch on the proceedings of 8<sup>th</sup> of CPC and its recommendations.**

57<sup>th</sup> Pension Adalat was held under chairmanship Ms. Jayati Samaddar, GM Finance on. 15/09/2025. GM Finance Agreed to Issue i)Instructions to Regional Offices to hold the Pension Adalat twice in the year and submit the report to Circle Office ii) Issue instructions for processing the cases of Grant of Notional Increments. On our reminder dated 17.10.2025 and personal discussion with GM, Finance, the instructions are issued by CPMG Office on 18.12.2025 that Pension Adalats at Regional/Divisional level are required to be conducted before Circle Pension Adalat which is held April & October every year. Secondly to reach out the pensioners for submitting the cases with necessary documents for grant of notional increments. DAP Nagpur has also issued the circular dated 10.09.2025, regarding the documents required for processing the cases of grant of Notional increment. Now There are clear instructions from Circle office. Branch Secretaries are requested to take a copy of these and pursue the matter with Division.

Regarding Pay revision of BSNL employees, the Agreement between Managemnet side and Staff side is signed on 08.10.2025, but currently facing delays in Board's approval. We will take up with DOT, to consider the pension revision of existing pensioners along with the Pay revision of employees.

**73<sup>rd</sup> Annual General Body Meeting of AICGPA Hq. Pune was held at Nashik on 11<sup>th</sup> & 12<sup>th</sup> October 2025. Following resolutions were passed unanimously with immediate effect.**

1. In view of the expenditure for printing and postage of Pensioners Progress Bulletins was more than the Subscriptions /postage received. It was found necessary to enhance the postage charges.

It is resolved that the postage charges of Rs. 50/- will be collected in addition to cost of Bulletin. Bulletin Subscriber has to pay Rs. 150/- (Bulletin 100 plus 50 postage) per year for ordinary post. To avoid the complaints of "Bulletin is not received through ordinary post", Branch Secretaries are requested to collect the subscriptions from members and get the Bulletins in Bulk and distribute calling a quarterly meeting.

Members who want the Bulletins through SPEED POST directly from Pune Headquarter are required to pay Rs 300/- per year.

2. The Expenditure on travelling is increased due to the increase in the Railway fare. Secondly the remittances from Branches to Headquarter are also reduced as reduction in new membership.

It is resolved that Branches will bear the cost of Travelling expenses of the Hq. Office bearers attending the AGM of Branch.

## Reconstitution Of SCOVA

OM No. 42/08/2023-P&PW(D)/E-8962, Dated 29.9.2025, From Government of India, DoP&PW, New Delhi.  
Resolution

Consequent upon expiry of tenure of the standing committee of Voluntary Ageneies (SCOVA) constituted vide this Department's resolution No. 42/08/2023-P&PW(D) dated 26th september, 2023 for a period of two years, the governmet of India has decided to reconstitute the SCOVA with the followig composition :

- a) Minister of State (Personnel, PG & Pensions) : Chairman
- b) Secretary, Department of Pension & PW : Convener & Member Secretary
- c) Official Members :
  - i. Representative of Ministry of Finance, ii. Representative of Ministry of Defence,
  - iii. Representative of Ministry of Railways, iv. Representative of Department of Posts,
  - v. Representative of Department of Telecom, vi. Representative of Ministry of Health & Family Welfare,
- d) Non-official Members (15 pensioners Associations) :

2. The term of SCOVA being reconstituted through this Resolution will be of 2 years. The standing group members would serve for three terms of two years each (total 6 years) from the date of inclusion in SCOVA or till the pleasure of the Chairman, SCOVA, whichever is earlier. The Rotating group members would serve for one term of two years from the date of inclusion in SCOVA and would be eligible for re-nomination for one more term or till the pleasure of the chairman, SCOVA, whichever is earlier.

3. The SCOVA will hold its meeting as often as may be necessary. However, it will meet at least once in a year.

4. The SCOVA will function to promote the following objectives:

i) To provide a feedback on implementation of policies/programme of the department of pension and pensioners' welfare.

ii) To discuss and critically examine the policy initiatives; and

iii) To mobilise voluntary efforts to supplement the government action.

5. Travelling allowance and daily allowance to Non-official members for attending the meeting of SCOVA shall be regulated in accordance with the provisions of SR. 190 and orders 42/11/2014-P&PW (G) dated 19.5.2014.

6. The expenditure involved will be met from within the sanctioned budget grant of department of pension & pensioners' welfare.

## **Government Order**

### **Cabinet approves Terms of Reference of 8th Central Pay Commission**

Posted On: 28 OCT 2025 3:03PM by PIB Delhi The Union Cabinet, chaired by the Prime Minister Shri Narendra Modi, today approved the Terms of Reference of 8th Central Pay Commission.

The 8th Central Pay Commission will be a temporary body. The Commission will comprise of one Chairperson; One Member (Part Time) and one Member-Secretary. It will make its recommendations within 18 months of the date of its constitution. It may consider, if necessary, sending interim reports on any of the matters as and when the recommendations are finalized. While making the recommendations the Commission will keep in view the followings:

- i. The economic conditions in the country and the need for fiscal prudence;
- ii. The need to ensure that adequate resources are available for developmental expenditure and welfare measures;
- iii. The unfunded cost of non-contributory pension schemes;
- iv. The likely impact of the recommendations on the finances of the State Governments which usually adopt the recommendations with some modifications; and
- v. The prevailing emolument structure, benefits and working conditions available to employees of Central Public Sector Undertakings and private sector.

#### **Background:**

The Central Pay Commissions are periodically constituted to go into various issues of emoluments structure, retirement benefits and other service conditions of Central Government employees and to make recommendations on the changes required thereon. Usually, the recommendations of the pay commissions are implemented after a gap of every ten years. Going by this trend, the effect of the 8th Central Pay Commission recommendations would normally be expected from 01.01.2026. The Government had announced formation of the 8th Central Pay Commission in January, 2025 to examine and recommend changes in the Salaries and other benefits of Central Government employees.



**NC-JCM Staff Side Meeting:** An extended meeting of the Staff Side members of the National Council-JCM Standing Committee was held on 15 November 2025 in New Delhi. The meeting reviewed the Gazette Notification dated 03 November 2025 on the constitution and Terms of Reference (ToR) of the 8th Central Pay Commission (8th CPC) and discussed the collective response of employees' organisations.

**Key Points from the Meeting:** Members expressed concern that the 8th CPC ToR does not reflect the expectations of employees, unlike the 7th CPC which explicitly mentioned "expectations of stakeholders."

The meeting noted that the ToR excludes pension revision for 69 lakh existing pensioners and family pensioners, despite earlier statements by the Government that the 8th CPC would cover both salary and pension revision.

The Staff Side unanimously decided to seek amendments in the ToR and include pension-related issues and the longpending demand for restoration of the Old Pension Scheme (OPS).

The meeting also concluded that the ToR should clearly specify the date of effect as 01 January 2026, in line with the past four Pay Commissions. Representation to the Prime Minister: The Staff Side of JCM has written to the Hon'ble Prime Minister requesting the following amendments in the 8th CPC ToR:

1. Restore the phrase "expectations of stakeholders" in Clause 2. 5 of the ToR.
2. Include pension revision for all existing pensioners and family pensioners, as was done in the 7th CPC.
3. Restore the Old Pension Scheme (OPS) for employees recruited on or after 01.01.2004.
4. Delete the phrase "unfunded cost of non-contributory pension schemes" and replace it with a fair description of pension liabilities.
5. Explicitly fix the date of effect as 01.01.2026, continuing the 10-year revision cycle.
6. Grant Interim Relief of at least 20% of Basic Pay and Basic Pension due to rising cost of living.
7. Include additional pension-related provisions such as:
  - Commutation to be recovered in 11 years instead of 15.
  - 5% additional pension every five years after retirement.
  - Coverage of all pensioners under CCS (Pension) Rules, 2021

- b) whether the Government has finalised the Term of Reference (ToR) of dh Pay Commission which will lead to revision of salaries of Central Government employees and allowance of pensioners, if so, the details thereof and if not, the reasons therefor;
- c) whether the Government proposes to allocate fund for implementing the dh Pay Commission in 2026-2027 budget, if so details thereof and action taken thereon and the total expenditure likely to be incurred from the Government exchequer;
- d) whether the 8t h Pay Commission has consulted/is consulting all major stakeholders including Central Government Employee and pensioners associations, as well as State Governments before taking final recommendations, if so, the details thereof;
- e) the present status of Constitution and other proceedings regarding the setting up of 8th Pay Commission along with the total number of Central Government employees and pensioners benefited; f) whether the

Government proposes to consider the grievances of employees and pensioners due to delay in starting the functioning of 8th Pay Commission, if so, the details thereof; and

S) the time by which the Commission is likely to submit its recommendations and the time by which the Government implement them?

(a) to (c), (e) and (l): The 8th Central Pay Commission (CPC) has already been constituted. The Terms of Reference (ToR) of the 8th Central Pay Commission have been notified vide Ministry of Finance' Resolution dated 03.11.2025. The number of Central Government employees is 50.14 lakh and the number of pensioners is 69 lakh approximately. The date of implementation of the 8th Central Pay Commission shall be decided by the Government. Government will make appropriate provision of funds for implementing the accepted recommendations of 8th CPC.

(d): The 8th Central Pay Commission will devise methodology and procedure for formulating its recommendations.

(S): As specified in the Resolution notified on 03.11.2025, the 8th Central Pay Commission will make its recommendations within 18 months from the date of its constitution.

**RESOLUTION**, New Delhi, the 3rd November, 2025

**F. No. 01-01/2025-E.III(A).**—The Government of India have decided to appoint the Eighth Central Pay Commission comprising of the following:-

1. Chairperson - Smt. Justice Ranjana Prakash Desai

2. Member (*Part-Time*) - Prof. Pulak Ghosh

3. Member-Secretary - Shri Pankaj Jain

2. The terms of reference of the Commission will be as follows:-

a) To examine and recommend changes that are desirable and feasible in the emoluments including pay, allowances, and other facilities/ benefits, in cash or kind, having regard to rationalization, contemporary functional requirements and the specialized needs of various Departments, agencies and services in respect of following categories of employees:

(i) Central Government employees — industrial and non-industrial;

(ii) Personnel belonging to the All India Services;

(iii) Personnel belonging to the Defence Forces;

(iv) Personnel of the Union Territories;

(v) Officers and employees of the Indian Audit and Accounts Department;

(vi) Members of the regulatory bodies (excluding the RBI) set up under the Acts of Parliament;

(vii) Officers and employees of the Supreme Court;

(viii) Officers and employees of the High Courts whose expenditure is borne by the Union Territories; and

(ix) Judicial officers of the subordinate courts in the Union Territories.

**[Note:** In respect of judicial officers, the Commission shall adhere to the principle enunciated by the Supreme Court in its Judgement dated 24th August, 1993 in All India Judges' Association and Others V/s Union of India and Others, viz. that there shall be no link between service conditions of judges and administrative executive and that the service conditions of judges have to meet the special needs of the judiciary].

(b) To work out an emolument structure conducive to attracting talent to Government service, promoting efficiency, accountability and responsibility in the work culture.

(c) To examine the existing schemes of bonus with a view to improving performance and productivity and make recommendations on the general principles, financial parameters, productivity and performance linked parameters for an appropriate incentive Scheme to reward excellence in productivity and performance.

(d) To review the existing allowances and conditions of their admissibility and recommend their rationalization keeping in view the multiplicity of allowances.

(e)

(i) To review the Death-cum-Retirement Gratuity of employees borne on the National Pension System (including Unified Pension Scheme) and make recommendations thereon.

(ii) To review the Death-cum-Retirement Gratuity and pensions of employees not borne on the National Pension System (including Unified Pension Scheme) and make recommendations thereon keeping in view Para f(iii) below.

(f) To make recommendations on the above, keeping in view:

(i) The economic conditions in the country and the need for fiscal prudence;

(ii) The need to ensure that adequate resources are available for developmental expenditure and welfare measures;

(iii) The unfunded cost of non-contributory pension schemes;

(iv) The likely impact of the recommendations on the finances of the State Governments which usually adopt the recommendations with some modifications; and

(v) The prevailing emolument structure, benefits and working conditions available to employees of Central Public Sector Undertakings and private sector.

3. The Commission will devise its own procedure and may appoint such Advisors, Institutional Consultants and Experts, as it may consider necessary for any particular purpose. It may call for such information and take such evidence, as it may consider necessary. Ministries and Departments of Government of India shall furnish such information and documents and other assistance as may be required by the Commission. The Government of India trusts that State Governments, Service Associations and others concerned will extend to the Commission their fullest cooperation and assistance.

4. The Commission will have its headquarters in Delhi.

5. The Commission will make its recommendations within 18 months of the date of its constitution. It may consider, if necessary, sending interim reports on any of the matters as and when the recommendations are finalized.

Finally, on 8.12.2025 I received a call from Sr. Accounts Officer, Office of CCA Maharashtra & Goa inviting to attend the Pension Adalat scheduled on 9th December. I told him that, invitation is required in advance. So that we may book ticket for reaching the venue of Pension Adalat. He said, sir we were busy at Panaji for some other meeting therefore we could not give prior intimation.

At last moment Pension Adalat was attended by Smt Sadhana Shirolkar Secretary and Smt Vanita Narvelkar Vice President Goa Branch.

#### **IDA For BSNL Pensioners from 1st January 2026**

IDA from 1st January 2026 may be increased by 3.5%.

Total IDA may be 236.7%.

**Subject : Clarification regarding eligibility for payment of gratuity to the central government servant under central civil services (payment of gratuity under national pension system) rules, 2021 on resignation.**

Department of pension & pensioners welfare (DoPPW) has been receiving various references/RTI applications etc seeking information/clarification regarding eligibility for payment of gratuity to the central government servant under NPS on resignation.

2. The rule position with reference to the government employees covered under the central civil services (payment of gratuity under national pension system) rules, 2021 is as under :

Rule 22 - Regulation of retirement gratuity and death gratuity

22. Retirement gratuity or death gratuity - (1) A government servant, who has completed five years qualifying service and who -

(i) retires on attaining the age of superannuation or on invalidation, of

(ii) retires or is retired, in advance of the age of superannuation in accordance with rule 56 of the fundamental rules, 1922 or rule 12 of the central civil services (Implementation of National pension system) rules, 2021 or

(iii) on being declared surplus to the establishment in which he was serving opts for special voluntary retirement scheme relating to voluntary retirement of surplus employees or

(iv) on has been permitted to be absorbed in a service or post in or under a corporation or company wholly or substantially owned or controlled by the central government or a state government, shall on his retirement, be granted retirement gratuity equal to one fourth of his emoluments for each completed six monthly period of qualifying service subject to a maximum of 16-1/2 times the emoluments.

Rule 17 : Forfeiture of service on resignation :

(1) Resignation from a service or a post, unless it is allowed to be withdrawn in the public interest by the appointing authority, entails forfeiture of past service.

(2) A resignation shall not entail forfeiture of past service if it has been submitted to take up, with proper permission, another appointment, whether temporary or permanent, under the government where service qualifies.

(5) A resignation submitted for the purpose of rule 32 shall not entail forfeiture of past service under the government.

Rule 32 : Benefit on absorption in or under a corporation, company or body : -

(1) A government servant who has been permitted to be absorbed in a service or post in or under a corporation or company wholly or substantially owned or controlled by the central government or a state government or in or under a body controlled or financed by the central government or a state government shall be deemed to have retired from service from the date of such absorption and, subject to sub-rule (4), he shall be eligible, on such absorption, to receive retirement gratuity on the basis of the qualifying service and emoluments on the date of absorption in accordance with rule 22.

3. It is observed from the above that retirement gratuity after completing of 5 years of service is applicable only on retirement as detailed in Rule 22 above. It is also clear that resignation [(except technical resignation as mentioned under Rule 17 (2) above or deemed retired /absorption as mentioned in Rule 17(5) and rule 32 above)] forfeits past services and no gratuity is payable in such cases.

**Subject : Guidelines for referring the cases to department of pension & pensioners welfare (DoPPW) for advice/clarification/consultation.**

Department of pension & pensioners welfare (DoPPW) is the Nodal department for pension and pension related policy matters for central government employees. DoPPW has formulated and issued many rules like CCS (Pension) Rules 2021, regulations/OMs/guidelines etc. The implementation of these rules is the responsibility of the concerned ministry/department/office. Wherever any difficulty in interpretation/implementation in respect of any particular rule is found, they can seek advice/clarification from DoPPW. It implies that the concerned office should first examine the case with reference to the relevant rules/regulations and shall come to a tentative conclusion. Even thereafter, if any advice / clarification /consultation with reference to any specific rule(s) / point(s) is required, the case may be referred to DoPPW.

2. The rules notified by DoPPW are self-explanatory and have provisions/ clarifications for varied situations. It has, however, been observed that some ministries/departments/offices refer certain cases involving above rules to this department in routine manner without the cases being examined thoroughly at the first level in the respective ministry / department. Some offices refer such cases directly. This practice has resulted in situations where this department is required to examine such cases ab-initio on behalf of the concerned ministry/department even those cases that could ideally be resolved at their level or ministry/department without any need to refer to this department if examined properly by them initially.

3. As stated above, this department has already circulated detailed rules/regulation/guidelines, the authority for their implementation. Decision making in most of the cases rests with the concerned ministries/departments/ offices. This department vide OM of even number dated 12.12.2024 had circulated general guidelines regarding referring the cases to DoPPW for advice. However, it has been observed that still few offices do not follow these guidelines resulting delay in furnishing advice by DoPPW.

4. In view of the above and to avoid delays in decision making, the following fresh guidelines for referring the matter to DoPPW henceforth for advice/clarification/consultation are prescribed as under:

i. The employees of railways, statutory bodies, defence personnel, autonomous bodies, PSU/Banks etc are not covered under the rules notified by DOPPW. Hence, only the cases covered under the rules of DoPPW should be referred for advice.

ii. The cases should initially be examined at the level of concerned ministry/department/office thoroughly with reference to the provisions of the concerned rules / regulations.

iii. If, after such examination, a department still encounters difficulties, ambiguities or need otherwise, it may refer the matter to this department incorporating the following :

a. A comprehensive proposal detailing the background, examination carried out by the department and its tentative conclusion.

b. Specific references to the rule / provisions on which advice/clarification / consultation is required.

c. detail of the case if not specifically covered by the prevalent rules/ regulations. The justification of the exemption, if any, required.

d. While sending the proposal, the name, designation (telephone numbers and e-mail ids) of the concerned officers may also be indicated.

e. The proposal well in advance along with all relevant record preferably through e-file (where e-file system is functional) should be referred through the administrative Ministry / Department along with their comments with the approval of the secretary concerned. This is equally essential for the ministries/departments for maintaining uniform stand in all the similar cases concerning officers under their control.

**Subject : Clarification regarding submission of life certificates by both the parents in case of enhanced family pension payable to them under CCS (EOP) Rules, 1939/2023 - submission of Life certificate - reg.**

Department of pension & Pensioners welfare (DoPPW) has been receiving references seeking information / clarification regarding enhanced family pension payable to parents under categories 'D' & 'H' of CCS (EOP) Rules, 1939/Catetories 'C' & 'D' of CCS (EOP) Rules, 2023.

2. The Rule position with reference to the payment of enhanced family pension to parents under CCS (EOP) Rules is as under :

i. Family Pension for categories 'D' and 'E', Rule (2) (4) of schedule-II of CCS (EOP) Rules, 1939 provides as under.

(4) When the government servant dies as a bachelor or as a widower without, children dependent pension shall be admissible to the parents without reference to pecuniary cireumsatances at the rate of 75% of pay last drawn by the deceased government servant for both parents and at the rate of 50% of pay last drawn by the deceased government servant for a single parent and on the death of one parent dependent pension at the later rate shall be admissible to the surviving parent."

ii. Eligibility of members of the family for grant of family pension under category 'C' and category 'D' Rule 12 (5) of revised CCS (EOP) Rules, 2023 stipulates that

(a) Where a deceased government servant is not survived by a widow or widower or a child eligible for family pension or if the widow or widower and all children cease to be eligible for family pension, Family pension shall be payable to parents for life.

(ii) under category 'C' and category 'D' at the rate of seenty five percent of the family pension emited to a widow if only one parent is alive.

(b) The family pension, wherever admissible to parents will be payable to the mother of the deceased government servant failing which to the father of the deceased goverment servant. Payment of family pension to parents in category 'C' & category 'D' shall be without reference to the amount of their income from other sources."

3. The enhanced family pension in the above cases is @ 75% if both parents are alive and @60% if only one parent is alive. Presently there is no provision for submission of life certificates by both the parents in CCS (Pension) Rules for receiveing family pension at enhanced tate in such cases. Hence in the absence of such provision in rules, life certificates are not being submitted by both the parents resulting in continuation of payment of enhanced family pension at higher rate even after the death of one of the parents in few cases.

4. In view of above, it has been decided that henceforth life certificates in the cases as referred above will be submitted by both the parents every year to avoid the overpayment in case of demise of one of the parents.

DoPPW, however, keeps receiving reference / RTI applications etc seeking clarification whether the above referred on Payment of gratuity under CCS (pension) rules is applicable on societies, banks ports trusts RBI, PSU, autonomous bodies universities state governments etc and it not under which rules these organisations are governed.

3. It is stated that department of pension & pensioners welfare (DoPPW) is the ..... department for formulation of policies relating to pension and other retirement benefits of central government civil employees covered under the central civil services (pension) rules, 2021. These rules are not applicable on types of organisations as mentioned in para 2 above. It is further stated that any query on the subject including one i.e. under which rules such organisations are governed should be addressed to the concerned organisation / concerned administrative ministry department.

Step 6: Fill in the Application Form with details:

Step 7: Preview, Check all the details and Click Submit.

**Subject : Intimation of closure of CGHS wellness centre, Parel, Mumbai**

This is to inform that the CGHS wellness centre, Parel, Mumbai has been closed from 1st November 2025 in view of the inspection report submitted by the CGHS CMO (HQ Projects) and the communication received from the India Government Mint regarding the structural stability report from IIT, which declared the building as unsafe for occupation.

In consideration of the safety of both beneficiaries and staff, the decision to close the parel wellness centre has been taken with immediate effect.

A lot of effort was made to contact various state, central and autonomous organizations for alternate accommodation, however, no suitable space was found available due to which this decision to close was taken.

An urgent meeting of the zonal advisory committee (ZAC) and local advisory committee (LAC) was convened on 31st october 2025, wherein the members were apprised of the situation. It was also decided that suitable arrangements would be made to ensure uninterrupted medical services to the beneficiaries. Accordingly, beneficiaries of the parel WC will now be attached to the Byculla wellness centre (approximately 5 km away) and wadala wellness centre, to alleviate inconvenience to the beneficiaries.

A letter to MTNL curry rd is also being forwarded on urgent basis to allot space on rent for CGHS so that this WC can continue.

Subject: Migration to TMS 2.0 and implementation of Revised CGHS Rates (effective 00:00 hrs, 13.10.2025)-Instructions to Pensioner beneficiaries who are eligible for Credit

Reference: CGHS Office Memoranda on (i) on-boarding to NHA IT platforms dated 19.08.2025 and (ii) Revised CGHS Rates issued vide O.M. dated 03.10.2025.

The Central Government Health Scheme (CGHS) is migrating to the NHA platforms (TMS 2.0/UMP/HEM 2.0) and implementing Revised CGHS Rates with effect from 00:00 hrs (midnight) of 13.10.2025. To ensure a smooth, safe, and transparent experience, all CGHS Pensioner beneficiaries who are eligible for credit to follow the instructions below.

#### **A. Access to Care & Identification**

i. Care will not be denied due to referral issue date. All empanelled Health-Care Organisations (HCOs) have been instructed to provide treatment to eligible CGHS beneficiaries even for valid referrals issued before 13/10/2025.

ii. Use of Digital CGHS Card is valid. If physical CGHS card (Both plastic and paper cards are acceptable, provided the card's validity is clearly indicated.) is not available beneficiary may share a downloaded e-card from:

the CGHS website ([cghs.mohfw.gov.in](http://cghs.mohfw.gov.in)),

the My CGHS 2.0 mobile app, or

DigiLocker

A clear soft copy is acceptable at HCOs.

#### **B. Mobile Number, OTP Verification & Consent**

i. OTP verification on beneficiary's registered mobile number is mandatory in TMS 2.0 for claim submission. Accordingly, beneficiaries are requested to share the same with the HCO upon request.

Please ensure mobile number is updated in the CGHS database. If beneficiary's number is missing on the TMS 2.0 portal, beneficiary will be requested to provide the correct contact number so the HCO can proceed with registration. To update mobile number, contact the nearest CGHS Wellness Centre (WC).

If an error occurs on the TMS portal because of missing beneficiary's photograph/ward entitlement, beneficiary may contact the Office of concerned Additional Director (AD) City where the card is registered and have the photo uploaded and ward entitlement updated

#### **Sample OTP SMS (for awareness):**

*Dear User, use OTP 507978 to proceed with verification, if you have understood the Aadhaar consent.*

*Note: this OTP is set to expire in 10 minutes.*

ii. Under exceptional circumstances, the attendant's mobile number may be used for OTP verification. HCOs will record this in the TMS 2.0 portal along with the relation of the attendant.

#### **C. Geotagging, Feedback & Transparency**

i. Geotagged photo: HCOs have been issued guidelines for geotagging at the point of care. Beneficiaries are requested to co-operate when the HCO captures a geotagged photograph.

ii. Mandatory feedback at discharge: As part of quality monitoring, please fill the CGHS feedback form at discharge. This form will be uploaded by the HCO with the claim. Beneficiary/Patient's Attendant must clearly state if any amount was collected during admission. (Annexure 1)

#### **D. Billing Rules Beneficiaries Must Know**

i. Revised vs Old Rates (date-wise):

Services on/after 13.10.2025 (00:00 hrs) ! Revised CGHS Rates apply.

Services up to 12.10.2025 (23:59 hrs) ! Old CGHS Rates apply.

ii. Separate bill for inadmissible items:

If the HCO charges the beneficiary for inadmissible items (items not payable under CGHS rules), the HCO must issue a separate bill/receipt. (Annexure 2)

Such inadmissible items must not be included in the final bill to be claimed from CGHS.

No draft/temporary/running bills are acceptable. The HCO will upload a copy of any such separate inadmissible-items bill with the claim.

Beneficiary should collect and retain proper bills/receipts for any payments made.

#### E. Grievance Redressal & Misuse Prevention

i. Hospital-level grievance desk: Every empanelled HCO is required to maintain a grievance redressal mechanism. If needed, please approach the Nodal officer at the HCO (details to be displayed at the facility).

ii. Report any suspicious intimation: If any beneficiary receives an SMS/any intimation for a service which was not availed from HCO, inform office of the respective AD City where card is registered immediately for verification and action.

Any misuse of the CGHS card—by a beneficiary or an empanelled HCO—constitutes an offence and will attract action under applicable rules and law.

These measures protect beneficiaries, improve service quality, and prevent misuse of the CGHS scheme.

This advisory takes effect immediately and shall remain in force along with the referenced Office Memoranda till further orders.

**Subject : Furnishing of a model draft speaking order for disposal of Legal Notice/representations from TTAs and other non-executive employees appointed against vacancies advertised during the DoT period (i.e. Prior to 1.10.2000), seeking GPF and CCS (Pension) benefits at Par with DoT-Absorbed Employees-reg.**

It has already been informed vide this office letter dated 19.9.2025 and 17.11.2025 that a number of cases have been filed by the erstwhile TTAs, stenographers and other Non-Executives recruited against vacancies advertised by DoT but appointed in BSNL, seeking pensioner benefits under CCS (Pension) Rules, 1972 in view of OM dated 3.3.2023 issued by DoP&PW.

2. It is further observed that several similarly placed employees have submitted representations or sending Legal Notices seeking identical relief in various circles. In this context, it is intimated that the Hon'ble CAT, Ahmedabad, in a similar case has disposed of the OA (No. 276/2025) filed by the applicants vide order dated 4.7.2025, directing the respondents to examine and decide their representation in accordance with the extant rules and the applicants' service records, without expressing any opinion on the merits of the case. This office vide letter dt. 29.10.2025 has advised the Gujarat circle to dispose of the representations in that matter by way of speaking orders to each applicant and a model draft speaking order was also sent to the circle after vetting by the legal branch, BSNLCO.

3. In order to ensure uniformity and timely disposal of similar representations/legal notices across all circles, the said model draft speaking order is enclosed for a reference point (copy enclosed.) This model draft speaking order, formulated in consultations with the legal branch, BSNLCO, may enable the circles to dispose of the pending representations/Legal Notices received by them in the matter in a consistent manner and may also facilitate the adoption of a uniform stand by BSNL.

4. The circles are advised to dispose of the representations by issuing individual speaking orders and in case of legal Notice a suitable reply taking a cue from the model speaking order. The core legal reasoning, statutory references, and judicial precedents will remain identical in all orders, while the factual particulars pertaining to each representations will be verifies by the circle form the respective service records and incorporated in a standardized tabular format. The date(s), especially the date of advertisement/notification by the circle, the date of conducting the examination, mentioned in the model order be substituted with the facts in the specific cases. If any additional relief has been sought in any individual representation, the same may also be suitably incorporated and addressed while issuing the respective individual speaking order. The subject and the background of the speaking order may be suitably modified indicating the due disposal of the representation or the legal notice under consideration.

#### **VII Decision**

After detailed and careful examination of the representation dated ..... of Shri/Smt. ...., and having due regard to the extant rules, policies, service records and judicial precedents, it is conclusively established that :

- a. The DoP&PW O.M. dated 3.3.2023 has no applicability to PSU appointments and the applicant being an appointee of BSNL, it does not apply to him/her.
- b. The recruitment, examination, training, and appointment of the applicant were undertaken entirely by BSNL after 1.10.2000.
- c. The applicant has never been borne on the rolls of DoT/DTS/DTO and therefore, was never a government servant.
- d. Rule 37-A of the CCS (pension) Rules, 1972 applies only to absorbed Government employees transferred to BSNL on 3.9.2000 and has no application to post-corporatisation recruits.
- e. The applicant's service conditions, including retirement benefits, are governed solely by BSNL's own rules and the Employees' provident fund scheme.
- f. The applicant's provident fund and pensionary benefits are governed by the employees' provident Fund Act, 1952 and the employees' pension scheme, 1995, as applicable to BSNL employees appointed after corporatisation.
- g. The claim is barred by gross delay, laches, and acquiescence, as the alleged cause of action, if any, arose at the time of the applicant's appointment more than two decades ago. The plea of a continuing cause of action is misconceived. The applicant having voluntarily accepted BSNL employment and the EPF/EPS framework and served thereunder without protest, is estopped from asserting a contrary status at this belated stage.
- h. The applicant has failed to establish any legal or factual basis for his/her claim to be treated as an employee of the department of telecommunications or to seek benefits under the CCS (pension) Rules, 1972 and the GPF (CS) Rules, 1960. The applicant having been appointed in BSNL after 1.10.2000 is not entitled to benefits under the CCS (pension) Rules. 1972 or the GPF (CS) Rules. 1960.



#### **VALIDATION of CCS Pension Rules - Status of Supreme Court Case**

The petition has been filed jointly by NCCPA and Civil Pensioners challenging the Validation Clause has been officially admitted by the Hon'ble Supreme Court. The case is filed under Diary No. 60324/2025, registered as W.P.(C) 1057/2025. It was listed before the Bench of Justice P.S. Narasimha and Justice Atul S. Chandurkar on 17-11-2025 for admission.

The Court has directed that the case be clubbed with W.P.(C) 525/2025, and notice has been issued to the Government.

The case is categorised under Retirement Benefits & Pension matters. The next tentative listing, as per the computer-generated schedule, is 05-01-2026.

Subject : Advisory on processing digital Life Certificated (DLCs) in SAMPANN

It has been brought to the notice of this office that digital life certificates (DLCs) submitted via Jeevan Pramaan are being rejected due to mismatch in Date of Birth between service records and aadhaar details, further, the offices are insisting on submission of manual life certificate. In this regard the following guidelines are issued.

2. A user manual issued by this office during Jeevan Praman intergration with SAMPANN (Copy attached) already provides detailed instructions for handling DLCs under four circumstances as below :

- i. Both PPO and Aadhaar matched - Auto updated by the systems.
- ii. PPO matched but Aadhaar not matched - Acceptance / rejection at DH, AAO level.
- iii. PPO not matched but Aadhaar matched - Acceptance / rejection at DH, AAO level.
- iv. Both PPO and Aadhaar not matched - Acceptance / rejection at DH, AAO level.

3. Vide DOT HQ letter no. 16-65/2025-O& M dated 15.10.2025, a DO letter dated 6.10.2025 issued by CEO, UIDAI has clarified that Aadhaar is not a valid proof of citizenship or date of birth and must not be used for establishing the same. In view of the above and to avoid hardship to pensioners/family pensioners, it is hereby advised that all CCA offices shall not rely on Aadhaar details for establishing date of birth of pensioners while processing DLCs. The service records and PPO shall remain the primary basis for verification.

4. Further, in cases where the name of the pensioner or family pensioner recorded in service records/PPO does not exactly match the name in Aadhaar, the DH and AAO should exercise reasonable judgment and avoid rejecting the Digital Life certificate merely on account of minor discrepancies such as spelling variations, use of initials etc. Only substantive differences that clearly indicate a mismatch of identify should be treated as ground for rejection, with the guiding principle being to prevent unnecessary hardship to pensioners while ensuring the authenticity of records.

5. It is often seen that pensioners or family pensioners enter their original PPO number (issued before migration to SAMPANN) while submitting their Digital Life certificate, such DLCs should not be rejected for this reason alone. Instead, the DH/AAO should make reasonable efforts to trace the corresponding SAMPAN PPO number using the details of the original PPO and then update the DLC in line with the instructions provided in the user Manual.

6. All CCAs are requested to ensure strict compliance with this advisory and disseminate the same to all dealing officials/officers for uniform implementation.

Post offices refuse to issue the Certificate as required by CCA. And v) To issue the Minutes of Pension Adalat as issued by the Karnataka Circle, the copy of which was handed over to Sr. Accounts Office during the meeting itself.

**Subject: Suggestions For Fresh items for Agenda of 35<sup>th</sup> meeting of SCOVA scheduled as per guidelines.**

**Respected Madam,**

With reference to your Letter No. 42/11/2023-P&W(D)/E-9312 dated 17.10.2025, The following items suggested for Agenda of 35<sup>th</sup> meeting of SCOVA may be considered.

1. Union Cabinet approved the Terms of Reference of 8<sup>th</sup> Central Pay Commission on 28<sup>th</sup> October, 2025. The Gazette Notification for Terms of Reference of the 8<sup>th</sup> Pay Commission is awaited.

**We suggest to include the item ' Revision of Pension in the case of employees, who have retired prior to the date of effect of the recommendations' as included in the Gazette Notification for Terms of reference of 7<sup>th</sup> Central Pay Commission.**

2. Additional Wellness Centers at Pune & Pimpri Chinchwad area: The proposal of 5 additional Wellness Centers at Kothrud, Hadapsar, Pimpri, Lohagaon and Katraj area is pending. **It is suggested that the Wellness**

Centre may be sanctioned at Kothrud on priority as on the closure of Allopathic treatment is stopped at Wellness Centre Bajirao Road, the beneficiaries attached to it, are required to travel 15 Kms to reach Mukundnagar Wellness Center which was already overcrowded.

**Justification:**

At present there are only 9 CGHS Wellness Centers in Pune and Pimpri Chinchwad area. Last Wellness Center was sanctioned in Pune in the year 1986, when Pune City was having population of 12.03 Lakh and Pimpri Chinchwad was having population of 82000 in 1984.

Pune and Pimpri Chinchwad area are expanded since 1986 and spread far and wide covering new areas ie. Kothrud, Warje, Nigdi, Lohagaon, Kharadi, Hadapsar and, Katraj etc. Due to such huge expansion

Government has decided to develop these areas forming Pune Metropolitan Region Development Authority(PMRDA) as per notification in 2015. The population of PMRDA (covering area of 7256.46 Sq KMs) is 72.76 Lakh and estimated at 73.99 lakh in 2025.

**As per decision in 34<sup>th</sup> SCובה meeting; Action was to be taken by Ministry and Family Welfare/ CGHS. We wish to know the status of the proposal sent by Addl. Director as well as by Pensioners Welfare Associations.**

**3. Extension of CGHS facilities at Belagavi(Karnataka) is pending at CGHS Directorate in spite of justification in terms of the criteria.**

**Justification:** We addressed a request for extension of CGHS facilities at Belagavi with full justification on the basis of data of Central Govt. Working employees and Pensioners in the Belagavi District. As per data furnished there are 1654 working employees and 3480 pensioners. There will be more than 6000 CGHS Cards, which is more than criteria for opening of CGHS Wellness Centre.

**4. Formulation of the Policy of Empanelment of Private Hospitals for IPD treatment without opening CGHS Wellness Center at developed Districts Headquarters. The proposal of Narayana Multispecialty Hospital, Nanded is pending at CGHS Directorate.**

This item was discussed in the 34<sup>th</sup> SCובה meeting, it was decided being a policy matter to be examined separately. Most of the pensioners residing at developed District Head Quarters(Non CGHS area) opted for CGHS facilities on payment of lump sum amount. The proposals/demand for extending the CGHS Facilities at Nanded, Kolhapur, Sangli Miraj and Solapur are disposed by the CGHS directorate stating “As per new SIU report opening of new CGHS Wellness Centre involves creation of new posts of staff and has financial implications. Even with creation of minimum posts of staff would involve a recurring expenditure of Rs. 4.2 Cr.re per year and one time non-recurring expenditure of Rs 1Cr.”

**5. Additional Staff to manage the CGHS Wellness Center at Sambhajinagar in Maharashtra.**

CGHS had sanctioned/opened the CGHS Wellness Centre, Chhatrapati Sambhaji nagar(Aurangabad) and managed by Doctor 1, Pharmacist 1, Staff nurse 1 and MTS 1. It serves 5000 CGHS beneficiaries. The pensioners from nearby districts ie. Buldhana, Jalgaon, Jalana, Parbhani, Beed are also taking the benefit. Good number of CGHS beneficiaries have to go back at 2 pm, without consultation/ treatment. There is a demand of one Ayurvedic dispensary to meet the additional demand. Additional Director is not in a position to meet the demand due to shortage of staff.

**6. Additional Staff to manage the CGHS Wellness Center at Coimbatore.**

As per the minutes of the LAC of Wellness Center Coimbatore, held on 14.10.2025, there are 3824 primary CGHS Card holders and 9279 beneficiaries attached to CGHS, Wellness Center Coimbatore (Tamilnadu). The present staff strength is quite inadequate to cater to the needs of the CGHS beneficiaries

**7. Extension of Scheme of one time option For Coverage Under CCS(Pension) Rules (1972) 2021 for DOT employees, who were issued a appointment letter prior to 01.10.2000 and joined the duty after formation of BSNL.**

Government of India, vide OM No. **DOP&PW No. 57/04/2019-P&PW(B) dated 17<sup>th</sup> February, 2020** provided one time option to Government servants, who were declared successful for recruitment in the vacancies occurred before 01.01.2004, for coverage under Central Civil Services(Pension) Rules 1972 in place of National

Pension Scheme. Some employees were appointed by DOT prior to formation of BSNL on 01.10.2000 and due to necessary training(administrative reasons), joined the duty after 01.10.2000. They were treated as BSNL employee and covered under EPS.

**For Example:** Smt. Latika P Suryawanshi was employed on compassionate ground by Department of Telecom, O/O General Manager, Telecom District, Sangli vide Letter No. GMTS/ADMN/E-6/HPC/LPS/8 dated 14/02/2000. She was appointed by Department of Telecom, O/O General Manager, Kolhapur Telecom District, Kolhapur vide N. QS-191/2 dated 16/08/2000 and instructed her to report for 3 months training. She was paid the Stipend during training period. On completion of 3 months training, she joined the duty on 21/11/2000 as TOA(G) in BSNL and retired on superannuation on 31/05/2019.

**It is suggested that Scheme of one time option For Coverage Under CCS(Pension) Rules (1972) 2021 may be extended for such DOT employees**

**8. Transgender child may be considered as dependant on the Government**

**Servant/pensioner and eligible for second stage family pension.** Many transgender individuals face ongoing discrimination and lack of social acceptance, which can impact their education, employment and housing. Un employed transgender is wholly dependent on Government Servant/ Pensioners, on the death of Pensioner, it may be left without income to survive its life. it is necessary to provide eligibility for second stage family pension. Rule 50(6) of CCS (Pension) Rules, 2021 may be corrected to add this provision.

**9. Documents required as Proof of relationship with the deceased/missing Government servant/ pensioner at the time of sanction of second stage Family pension may be specified. Responsible officer may visit the residence to verify the facts of the claimant and submit the report in stead of asking the Succession Certificate.**

It is necessary to submit the document showing relationship with the Government Servant/pensioner along with Application for Second stage Family pension(Form -10). If the office record(Form 4 showing Details of Family) is not traceable, Head of office ask the claimant straightway to produce a Succession certificate, which is costly and time consuming affair. Due to this the cases remain pending for not less than a year.

**It is suggested that combination of Affidavit of Claimant and any two of the following documents may be sufficient to prove the relationship.**

**School leaving Certificate, Ration card having the name of Government Servant/pensioner and Claimant, PAN card or Voter Card**

**Secondly, Responsible officer may visit the residence to verify the facts of the claimant and submit the report. Department of Post follows this. This procedure may be followed by other Departments also.**

**10. Guidelines for conducting Pension Adalat:** Guidelines for conducting Pension Adalat were issued by DOP&PW vide OM dated 25.03.2011. It is observed that the Pension Adalats are not conducted strictly as per the schedule as per the guidelines. It is suggested to reiterate the guidelines with addition that minutes of the Pension Adalat should be addressed to Identified Pensioners Associations.

**11. Since Identified Pensioners Associations play a crucial role in helping pensioners/family pensioners and also act as an extended arms of DOP&PW, it is suggested that DOP&PW may issue the instructions to administrative departments that a) Identified PWAs should be given a chance to discuss the Pensioners issues as per the Agenda periodically and b) Correspondence received from the Identified PWAs should be acknowledged/replied.**

**12. Hand held device used by Postman for Life Certificate may be used only for doorstep service:** The pensioner visit the Post office for submission of Life Certificate, if Postman used the hand held devise for generation of Life Certificate, Rs. 70 are charged and collected from the pensioner. This was objected by us long back on behalf the pensioners visiting to Post Offices.

It is suggested that Desktop may be used for generation Life Certificate in Post Office and Handheld devices may be used only for doorstep service.

**13. Appointment of Nodal Bank or posting of CCA official in BSNL BA unit for satisfying the queries/ complaints of DOT/BSNL pensioners migrated to SAMPANN.** DOT had issued the orders long back to

open one window for pensioners at the BSNL SSA units, but no such window is provided. Service Centre for the assistance of SPARSH pensioners are provided by the Department of Defence. **We suggest There should be at least one Service Centre/one CCA official at each District Headquarter.**

**Madam, We hereby request your to consider these items for discussions in 35<sup>th</sup> SCOVA meeting. Thanking you for consideration of these items for Agenda.**

## Branch report

The 38th Annual General Body Meeting of the Coimbatore Branch of the Pune-based 'All India Central Government Pensioners' Association' was held on 13-12-2025 at the Gujarati Samaj, North Coimbatore, under the chairmanship of President Shri. N. Srinivasan. Shri. H.F. Chaudhari, General Secretary of the All India Association, and Shri. G.N. Kulkarni, CHQ President, attended as special guests.

In his welcome address, Shri. A. Panchanathan, Branch Secretary requested clarifications on doubts prevailing with other Associations regarding the recently constituted 8th Central Pay Commission. He also urged for the status on grant of additional pension at the ages of 65, 70, and 75 at the rates of 5%, 10%, and 15% respectively, and also about the demand for increasing the current 'Monthly Medical Allowance' to Rs 3,000/. Joint Secretary Shri T. Subramanian requested General Secretary a briefing on the Central Government's 'Validation Act-2025' and TOR of 8th CPC. Organizing Secretary Shri T.S. Venkatachalam condemned the 'Validation Act-2025', stating that the government's intent behind it is to snatch away the rights of pensioners.

General Secretary clarified that Hon'ble Finance Minister, Mrs Nirmala Sitharaman clarified in Rajya Sabha on 27th March-2025 that Validation of Pension rules is a legislative formality to confirm existing practices, not to alter benefits for current central government or defense pensioners. 6th Central Pay Commission recommended the distinction between Pre 1.1.2006 and post 1.1.2006 retirees. Which was accepted by then Government. 7th Pay Commission has brought the partial parity between pre 1.1.2016 and post 1.1.2016 retirees. Secondly, The meeting with NJCM and Identified Pensioners Association was held under chairmanship of Shri V. Srinivas Secretary DOP&PW. Which was attended by our General Secretary. Wherein Secretary clarified that 5th CPC has made the distinction between Pre 1.1.1996 and Post 1.1.1996 retirees. 6th CPC has continued the similar distinction between Pre 1.1.2006 and Post 1.1.2006 retirees. Hon'ble Supreme Court has ruled in pending matter that Govt. don't have authority to make such distinction. That's why Govt has to validate the existing practice. As such there is no change and As per the recommendations of Pay Commission the pension of existing pensioners will be revised.

Regarding 8th CPC, after going through the Terms of Reference notified by Ministry of Finance on 3.11.2025 and reply of Hon'ble MOS, Ministry Of Finance, Shri Sanjay Chaudhary on 8th December 2025, General Secretary Shri H. F. Chaudhari stated that the recommendations of the 8th Pay Commission would benefit all existing pensioners. He further mentioned that the proposal for an increase in Medical Allowance to Rs. 3000/- and reducing the period for restoration of commuted pension from 15 years to 12 years have been referred to the Pay Commission for consideration.

Joint Secretary Shri T. Subramanian provided an accurate Tamil translation and explanation of the General Secretary's English speech. Working President Shri M. Sudhakaran addressed the gathering about the 8th Central Pay Commission. More than 350 pensioners from various Central Government departments including Postal, RMS, Telecom, BSNL, Government of India Press, All India Radio, CBI, CPWD, Income Tax, Customs, Defence, Railways, Passport, Survey of India, and Central Govt. Water Board, participated in the event. Treasurer Shri V. Chandramohan presented the Annual Report and Financial Statement for the year ended 31-03-2025 which were unanimously accepted.

The Association's office bearers and executive committee members were elected unanimously, including Shri N. Srinivasan as President, Shri A. Panchanathan as Secretary, Shri T. Subramanian as Joint Secretary and Shri V. Chandramohan as Treasurer. Finally, Executive Committee member Shri Mani proposed the vote of thanks, and the AGB meeting concluded with the National Anthem.

२५ मार्च २०२५ रोजी वित्त विधेयका अंतर्गत CCS पेन्शन नियमांचे वैधकरण करण्यात आले व इव्या वेतन आयोगाच्या संदर्भ अटीसंबंधात स्पष्टीकरण:

२५ मार्च २०२५ रोजी वित्त विधेयका अंतर्गत पेन्शन नियमांचे वैधकरण करण्यात आले. त्याद्वारे सरकारला निवृत्त कर्मचाऱ्यांमध्ये निवृत्ती दिनांकाचे आधारावर फरक करण्याचा अधिकार आहे यावर शिकामोर्तब केले. NCCPA व इतर संघटनांनी याचा तीव्र निषेध नोंदविला व सर्वोच्च न्यायालयात याविरुद्ध याचिका दाखल केली आहे.

तसेच सरकारने ३.११.२०२५ रोजी जारी केलेल्या ८ व्या वेतन आयोगाच्या संदर्भ अटीमध्ये विद्यमान निवृत्त कर्मचाऱ्यांच्या पेन्शन रिहीजनचा उल्लेख नाही. असे बरेच संघटनांकडून सागण्यात आले व आंदोलनही करण्यात आले. आपल्या असोसिएशन तर्फे मात्र खालील भूमिका घेण्यात आली.

वित्त विधेयका अंतर्गत २५ मार्च २०२५ रोजी लोकसभेत CCS पेन्शन नियमांचे वैधकरण करण्यात आले. त्याद्वारे निवृत्तीवेतनधारका मध्ये निवृत्तीच्या दिनांकाचे आधारावर तफावत करण्याचा अधिकार सरकारला आहे असे म्हटले आहे. काही खासदारांनी लोकसभेत त्वारित विरोध दर्शविला. तसेच पेन्शनर्स असोसिएशनने आक्षेप नोंदविला. मा. वित्त मंत्री श्रीमती निर्मला सीतारामन यांनी राज्यसभेत २७ मार्च २०२५ रोजी स्पष्ट केले की हे केवळ विद्यमान नियमांचे वैधकरण करण्यात आले. यामुळे सध्या मिळत असलेल्या पेन्शनमध्ये कोणताही बदल होणार नाही. त्यांनी पुढे सांगितले की, द्व्या वेतन आयोगाने शिफारस करतानाच ०१.०१.२००६ पूर्वी व नंतर निवृत्त झालेल्या कर्मचाऱ्यांमध्ये फरक केला होता. त्यावेळचे सरकारने आयोगाचे शिफारशीनुसार पेन्शनमध्ये वाढ केली होती. इव्या वेतन आयोगाने मात्र पेन्शन रिहीजन करताना अंशतः समानता आणली आहे. त्यांनी पुनः सांगितले की हे केवळ विद्यमान नियमांचे वैधकरण आहे.

अधिकृत पेन्शनर्स असोसिएशन्स व National JCM चे मागणीनुसार पेन्शन व पेन्शनर्स विभागातर्फे रविवार दिनांक २९ मार्च २०२५ रोजी मा. सचिव व्ही. श्रीनिवास यांचे अध्यक्षतेखाली विशेष बैठक घेण्यात आली. त्यामध्ये आपल्या असोसिएशन चे महासचिव श्री एच. एफ. चौधरी हे उपस्थित होते. त्यांनी तसेच इतर सदस्यांनी उपस्थित केलेल्या प्रश्नावर मा. सचिव यांनी स्पष्ट केले की हे केवळ विद्यमान नियमांचे वैधकरण आहे, पेन्शनमध्ये कोणताही बदल करण्यात आला नाही. ५ वा केंद्रीय वेतन आयोगाने ०१.०१.१९९६ पूर्वी व नंतर निवृत्त झालेल्यांमध्ये पेन्शन निर्धारित करताना फरक केला होता. तसेच द्व्या वेतन आयोगाने सुधा १.१.२००६ पूर्वी व १.१.२००६ नंतर निवृत्त झालेल्यांमध्ये फरक केला होता. सर्वोच्च न्यायालयाने एका प्रकरणात (S-30 Pensioners Association Vs Union of India) सरकारला असा फरक करण्याचा अधिकार नाही असे म्हटले आहे. त्यामुळे च सरकारला वित्त विधेयकाद्वारे सरकारला असा फरक करण्याचा अधिकार आहे हे स्पष्ट करण्यासाठीच पेन्शन नियमांचे वैधकरण करावे लागले. यापुढे ही वेतन आयोगाचे शिफारशीनुसार पेन्शनर्स चे पेन्शन रिहीजन होणार आहे. पेन्शनर्स असोसिएशन्स तर्फे या आशयाचे लेखी स्पष्टीकरण देण्याची मागणी करण्यात आली.

केंद्रीय कार्यकारिणीचे बैठकीत वरील सर्व बाबींचा साधक बाधक विचार करून...

घाईघाईत आंदोलनात सहभागी न होण्याचा निर्णय घेतला व आठव्या वेतन आयोगाचे पुढील वाटचालीवर बारकार्झे लक्ष ठेवण्याचे ठरविले. बैठकीत चर्चा झालेनुसार मा. सचिवातर्फे स्पष्टीकरण देण्यात आले नाही. म्हणून वित्त मंत्री व सचिव (पेन्शन) यांना पेन्शन नियमांच्या वैधकरणाचे पुनरावलोकनाची मागणी करणारे पत्र पाठवले.

केंद्रीय मंत्रीमंडळाने १७ जानेवारी २०२५ रोजी ८ व्या केंद्रीय वेतन आयोग स्थापन करण्यास मंजुरी दिली. मात्र सरकारातर्फे इव्या वेतन आयोगाचे गठन व संदर्भ अटी ठरविण्यात विलंब करण्यात आला. त्यामुळे आपल्या असोसिएशन तर्फे १४ जून २०२५ रोजी मा. कॅबिनेट सचिवांना पत्र पाठविण्यात आले. केंद्रीय मंत्रीमंडळाने २८ ऑक्टोबर २०२५ रोजी ८ व्या वेतन आयोगाचे गठन व आयोगाच्या संदर्भ अटी (Terms of Reference) मंजूर केल्या. व ३ नोव्हेंबर २०२५ रोजी वित्त मंत्रालयातर्फे राजपत्रित अधिसूचनेद्वारे कळविण्यात आल्या. त्यातील

e (ii) अटींनुसार विद्यमान पेन्शनधारकांबाबत काही अटींसह उल्लेख करण्यात आला. काही संघटनांकडून विद्यमान पेन्शनधारकांबाबत स्पष्ट उल्लेख करण्यात आला नाही, असे सांगण्यात आले. त्यामुळे पेन्शन धारकांचे मनात गोंधळ निर्माण झाला. ८ डिसेंबर २०२५ रोजी लोकसभेत प्रश्न क्रमांक १३४७ ला उत्तर देताना वित्त मंत्रालयाचे मा. राज्यमंत्री श्री. पंकज चौधरी यांनी विद्यमान पेन्शनधारकांना सुद्धा वेतन आयोगाचा फायदा होणार आहे हे सांगून पुष्टी केली आहे.

उत्तरादाखल मा. राज्यमंत्र्यांनी सागितले की.. सरकारतर्फे ८व्या वेतन आयोगाचे गठन करण्यात आले आहे. वित्त मंत्रालयाच्या दिनांक ३.११.२०२५ ठरावाद्वारे ८व्या केंद्रीय वेतन आयोगाच्या संदर्भ अटी कळविण्यात आल्या आहेत. सध्या सुमारे ५०.१४ लाख केंद्रीय सरकारी कर्मचारी व सुमारे ६९ लाख पेन्शनधारक आहेत. ८व्या वेतन आयोगाच्या शिफारशीची अंमलबजावणी कधीपासून करायची हे सरकार ठरवेल तसेच स्वीकारलेल्या शिफारशीची अंमलबजावणी करण्यासाठी सरकार निधीची योग्य तरतूद करेल.

**निष्कर्ष:** ८वा वेतन आयोग विद्यमान केंद्रीय सरकारी निवृत्त कर्मचाऱ्यांच्या पेन्शन रिहीजनबाबत विचार करणार आहे. हे स्पष्ट आहे. आपली संघटना यावर बारकाईने लक्ष ठेवणार आहे. सभासदांनी इतर बातम्या व व्हिडिओ चा विचार न करता आपल्या गृपवर प्रसारित बातम्यावर विश्वास ठेवावा.
