G S Speaks:

Hon'ble Minister of Finance, Smt Nirmala Sitaraman presented the Budget for 2024-25 on 23rd July, 2024. There is no change in INCOME Tax under Old regime, where pensioners get the exemptions /deductions for Savings under 80C and exemptions on Interest etc. Finance Minister announced several attractive benefits aimed at providing tax relief to salaried individuals and pensioners under new tax regime.

The central government approved Unified Pension Scheme (UPS) on 24-08-2024 for central government employees, which will be effective from April 1, 2025. It applies to only those who joined service on or after 1-1-2004 and are covered under the National Pension System.

CWC Meeting of AICGPA Hq Pune was held on Saturday 03-08-2024 at Pune. I am happy to inform that Amended Memorandum of Association and Rules and Regulations for ratification. It was decided to hold the AGM Of AICGPA Hq. Pune at Satara also to compile the membership register, which may be used to publish the Telephone directory of the members of Association.

DOP&PW has launched Nation-wide Digital Life Certificate Campaign 3.0, in 700 cities and towns covering all district HQs, from November 1st to 30th, 2024. The objective of this Campaign is to promote increased use of Face Authentication Technology and other DLC modes with a target of reaching out to all pensioners, including those in the remotest corners of the country.

In view of the numerous grievances against the empaneled Hospitals, CGHS has issued the instructions to be followed by HCOs to provide better services to the CGHS beneficiaries.

Circle Level Postal Pension Adalat was held under Chairmanship of Shri Abheejit Bansode, Director Postal Services (HQ). on 20/08/2024 at 15.00hrs in the conference Room of CPMG, Maharashtra Circle,Shri Ramachandran. P Account Officer, looking after Pension Cases was present. It is informed by official side that, the number of grievances at Circle level are reduced considerably due to holding off pension adalats at all levels. DPS agreed to hold the meetings in future to discuss and solve the pending grievances of the pensioners...

The case of Pension Revision in Delhi High Court was heard on 8th August 2024. Addl. Solicitor General mentioned that BSNL/ MTNL absorbed employees cease to be Central Govt. Employees consequent upon the absorption in BSNL/ MTNL in accordance to Sub Rule 4 of Rule 37(A) of CCS Pension Rules, therefore they are not entitled to revison of pension according to 7th CPC. Mr Kirtiman Singh, told court that BSNL/MTNL pensioners are entitled to Pension Revision only on wage Revision of BSNL/ MTNL employees according to 7th CPC.

3rd PRC. Hon'ble Minister of Telecom
replied to MP vide letter dated 23 rd August,
2024 that Pension revision is intrinsically
linked with pay revision. Due to current
financial condition of BSNL it has not been
possible to agree with pay revision as per
3 rd PRC. Accordingly pension revision
without pay revision is also not possible.

Union Budget 2024-2025

While presenting the Union Budget 2024-2025 in Parliament on 23rd July, 2024, Hon'ble Minister for Finance & Corporate Affairs, Smt. Nirmala Sitharaman announced several attractive benefits aimed at providing tax relief to salaried individuals and pensioners who choose the new tax regime.

New Tax Regime : The new tax regime rate structure has been revised to provide salaried employees with significant benefits, offering up to Rs 17,500/- in income tax savings. This revision aims to make the tax system more favorable for middle-income earners. This revised structure not only aims to simplify the tax regime but also to offer considerable relief to salaried individuals and pensioners. In another measure to reduce tax uncertainty and disputes, a thorough simplification of reassessment has been proposed. Assessments can now be reopened beyond three years, up to five years from the end of the year of assessment.

Deductions and Exemptions : The standard deduction for salaried employees is increased from Rs. 50,000 to Rs. 75,000 for those opting for the new tax regime.

Similarly, the deduction on family pension for pensioners was enhanced from Rs.15,000 to Rs. 25,000.

Short Term Capital Gains : Short-term capital gains on specified financial assets shall be taxed at a rate of 20% instead of the previous rate of 15%. All other financial assets and non-financial assets will continue to be taxed at their applicable tax rates, maintaining consistency in the broader tax framework.

Long-Term Capital Gains : Long-term gains on all financial and non-financial assets will attract a tax rate of 12.5%. To benefit the lower and middle-income classes, increasing the limit of exemption of capital gains on certain financial assets from Rs. 1 lakh to Rs. 1.25 lakh per year has been proposed. This increased exemption limit will apply for FY 2024-25 and subsequent years.

The rate for other long-term capital gains on all assets has been rationalized to 12.5% without indexation (Section 112). Previously, this rate was 20% with indexation.

Simplification for Charities and of TDS : The Finance Bill introduces two distinct tax exemption regimes for charities. To further simplify the TDS process, the 5% TDS rate applicable to various payments is reduced to 2%. Additionally, the 20% TDS on repurchase of mutual fund or UTI units has been eliminated. The TDS rate levied on e-commerce operators has also been significantly reduced from 1% to 0.1%.



Cabinet approves Unified Pension Scheme On : 24 AUG 2024

The Union Cabinet, chaired by the Prime Minister Shri Narendra Modi, approved the Unified Pension Scheme (UPS).

The salient features of the UPS are :

1. Assured pension : 50% of the average basic pay drawn over the last 12 months prior to superannuation for a minimum qualifying service of 25 years.

2. Assured minimum pension : @10,000 per month on superannuation after minimum 10 years of service.

3. Assured family pension : @60% of pension of the employee immediately before her/his demise.

4. Inflation indexation : on assured pension/family pension and assured minimum pension

Dearness Relief based on All India Consumer Price Index for Industrial Workers (AICPI-IW) as in case of service employees.

5. lump sum payment at superannuation in addition to gratuity.

1/10th of monthly emoluments (pay + DA) as on the date of superannuation for every completed six months of service this payment will not reduce the quantum of assured pension.

Unified Pension Scheme (UPS) Vs National Pensioin Scheme (NPS)

New Pension Scheme (NPS) was launched for employees appointed wef. 1.1.2004. NPS is a defined contribution scheme, where both the employee and employer contribute a percentage of the employee's basic salary. On retirement Employee receive fixed percentage of corpus accumulated.

Pension depends on the accumulated corpus and how much of it is used to purchase an annuity.

Unified Pension Scheme (UPS) is an idea aimed at providing fixed monthly pension/family pension

Let's Check the calculations(approximately) for both the National Pension System (NPS) and the Unified Pension Scheme (UPS), assuming an employee having 25 years of service with an average basic pay of Rs. 50,000.

NPS Calculation

1. **Employee Contribution**: 10% of 50,000 = 5,000 per month

2. **Employer Contribution**: 18.5% of 50,000 = 9,250 per month

3. **Total Contribution per Month**: 5,000 + 9,250 = 14,250

4. **Annual Contribution**: 14,250 × 12 = 1,71,000

5. **Service Duration**: 25 years

Lump Sum amount on retirement: 60% of corpus = Rs. 60,00,000/-

- **Monthly Pension from 40% of Corpus**: 40,00,000/-

- Approximately pension (5%) = 20,000/-p.m.

UPS Calculation

- **Pension : 50% of Average basic pay : Rs. 25,000 per month

- **Lump Sum payment at superannuation=

(1/10th of Monthly Emoluments(Pay + DA) for every completed six months of service

Monthly Emoluments: Rs. 1,50,000 (50,000 + 1,00,000 (Assume DA 200%))

Lum Sum payment: Rs. 15000 x 50(completed six months)

= Rs. 750000/-

Comparison:

Monthly Pension:	NPS**: Rs. 20,000	- **UPS**: Rs. 25,000
Lump Sum Payment:	NPS**: Rs. 60,00,000/-	- **UPS**: Rs. 7,50,000/-
Summary:		

NPS tends to offer higher lump sum benefits due to the higher contributions and accumulated corpus. However, the exact annuity rates and returns on NPS can vary, and the pension amounts are subject to changes based on the returns and annuity plan chosen at retirement.

- **UPS** provides higher pension compared to the potential benefits from NPS.

Each scheme has its own merits, and the choice between them might depend on factors such as job stability, preferences for pension security, and investment risks.

Therefore it is necessary to check out the benefits under UPS before submitting the option.

Subject : Comprehensive Guidelines for the Nation-wide Digital Life Certificate Campaign 3.0, November 1st to 30th , 2024

Office Memorandum

The undersigned is directed to say that submission of Life Certificate is an important activity to be carried out by pensioners every year in the month of November (with special provision for pensioners aged 80 years and above to submit their Life Certificates in the month of October) to ensure continuity of their pension.

- 2. To enhance 'Ease of Living' of Central Government pensioners, this Department engaged with UIDAI & MeitY to develop a Face-Authentication technology system based on UIDAI Aadhaar database whereby it is possible to submit Life Certificate from any Android based smart phone. This is in addition to other modes of submitting Digital Life Certificate, such as through bio-metric device/iris scanner, Video-KYC, LC through the Gramin Dak Sevaks by using the App of India Post Payments Bank and Door-step service by the consortium of Public Sector Banks.
- 3. With a view to spread awareness amongst all the Central Government pensioners as well as the Pension Disbursing Authorities for use of DLC through Face Authentication Technology, DoPPW had organized two Nation-wide Campaigns in collaboration with Banks, Pensioners' Welfare Associations, DoT, CGDA, UIDAI & MeitY. The first such campaign was held in 37 cities in the month of November 2022, resulting in use of DLC by approx. 35 Lakh Central Government Pensioners across India. The second campaign was held at 600 locations in 100 cities in November, 2023 and resulted in DLC submission by more than 45.56 Central Government pensioners.
- 4. DoPPW shall now be conducting a Nation-wide DLC Campaign 3.0 in 700 cities and towns covering all district HQs, from 1st to 30th November, 2024. The objective of this Campaign is to promote increased use of Face Authentication Technology and other DLC modes with a target of reaching out to all pensioners, including those in the remotest corners of the country. The SOP regarding the technique of issuing DLC through Face Authentication is attached for reference.
- 5. In order to conduct this Campaign, DoPPW shall obtain the support of the following stake-holders:
- India Post Payments Bank (IPPB)
- Pension Disbursing Banks
- Pensioners' Welfare Associations
- Department of Telecommunications
- Ministry of Defence (for their own pensioners)
- PIB & DD (for media support)
- UIDAI & MeitY (for technical support)
- Ministry of Railways
- 9. Campaign Period activities (1st November 30th November, 2024)
- Launch of Nationwide DLC Campaign 3.0.
- DLC camps in identified cities/towns as per schedule. In all other places, Banks/Establishments shall keep the facility open.
- Daily updation of data centrally by MeitY of the progress of the Campaign on the DLC Portal.
- Release of PIB statements and tweets for every city by respective nodal officers. This shall be monitored by the DoPPW official in-charge of that particular State/UT. The links of PIB, tweets as well as DD coverage will be shared by the Nodal officers on the portal/social media group.
- Release of Nationwide DLC campaign booklet and film by DOPPW.
- 10. Role of different stake-holders w.r.t. the Nationwide DLC Campaign 3.0:
- ***** Role of Department of Pension & Pensioners' Welfare

- Issue guidelines to all stake-holders containing details of the campaign.
- Prepare and circulate common All-India banner of the Nationwide DLC Campaign 3.0 to all stake holders.
- Nomination of Nodal Officers for each State/UT.
- Visit of DoPPW nominated officials to different locations to monitor & inspect the drive.
- Coordinate meetings with all stake-holders in different States/UTs including with the Registered Pensioners' Associations.
- Monitoring of the campaign and uploading details of Nodal Officers, cities and locations of camps on DLC Portal.
- Creation of a social media group comprising all the nodal officers for posting of pictures of different site locations and number of tweets.
- Training of different stake-holders along with MeitY & UIDAI officials in Face Authentication and DLC methods.
- Conduct an awareness drive at the appropriate time through newspapers, television, FM radio, Social media, SMS messages, Short films, regarding the DLC campaign and Doordarshan (Prasar Bharati).
- Role of Pensioners' Welfare Associations
- PWAs to nominate officials to make home/hospital visits for Pensioners who are unable to move to Campaign locations.
- Conduct a rigorous awareness drive of the Campaign among all their members as well as apprise their RWAs (Resident Welfare Associations) regarding the Campaign and the Face Authentication methodology for generating LC.
- Coordinate with the local Bank/Defence (SPARSH)/Railways/PIB officials for conducting a seamless DLC Nationwide campaign.
- Mobilize pensioners to visit the camps.
- Inform the concerned DoPPW official of the State about any local issues being faced by the Pensioners in giving LC.
- Prepare a media plan of the Campaign and send pictures to DoPPW on the mail ID doppw-dlc@gov.in
- ***** Role of Department of Posts/India Post Payments Bank (IPPB)
- Department of Posts in collaboration with India Post Payments Bank (IPPB) will hold camps in all the districts across India.
- Details of the camps may be shared with DoPPW.
- A Nodal officer may be nominated, for coordination at central level and state level.
- Details of the nodal officers to be communicated to DoPPW for plotting on DLC Portal.
- Wide publicity should be given to this campaign by spreading awareness through banners, social media, SMS.
- Short videos of 30 seconds may be taken of pensioners above age of 90 years generating their DLC.
- Pictures and success stories of DLC generation to be sent to DoPPW on the mail ID doppw-dlc@gov.in
- Training of Nodal officers on DLC through Biometric, with special emphasis on Face Authentication.

Subject : Grant of Notional Increment to the employees who retired on 30th June/31st December -Regarding

Office Memorandum

Several representations from retired employees and advocates notices on behalf of retired employees regarding extending grant of notional increment on 1st July / 1st January to the employees retired a day before it became due i.e. on 30th June/31st December, are being received in the department citing, Hon'ble supreme court order dated 11.04.2023 in Civil Appeal No. 2471 of 2023 in the matter between the Director (Admn. and HR) KPTCL & Ors. Vs. C.P. Mundinamani & Ors. and other cased including departmental employees.

2. DoPT vide OM No. 19/2/2018 -Estt(Pay-1) dated 3.3.2021 and OM No. 1453545/2021-Estt(Pay-I) dated 24.6.2021, had directed to defend such cases where cases had been filed for extension of such benefits. In fact, subsequent to the above Hon'ble supreme court order dated 11.4.2023, no instructions have been issued as on date by DoPT or DoE on this issue.

3. In the similarly placed case of one of the constituent unit, based on the advise rendered by DoPT, DoLA and DoE, and administrative decision was taken by the competent Authority in the Department to implement the court orders in r/o concerned applicants. Thereafter, wherever clear decision on the subject matter have been received from Hon'ble Tribunals or High Courts, the decision have been implemented.

4. Since, then several more representations are being received from similarly placed retired employees seeking extention of similar benefits in their cases. However, the department in the absence of any clear orders from the nodal ministries (i.e. DoPT or DoE) cannot implement the same across the board unless there is a decision on the same from Hon'ble CAT or High court.

5. In view of the above, all the constituent units, are hereby directed;

(i) to take necessary action w.r.t. compliance of the orders of the Hon'ble Tribunals/courts i.r.o. concerned retired employees subject to fulfilment of the other condions. Such cases may be referred to the nodal sections in DAE before necessary implementation.

(ii) Not to extend benefits on individual representations of the employees (who have not moved any court of law) or notices of Advocated, and inform such individuals that the request cannot be considered in absence of any orders from nodal ministries concerned.

(iii) As, no further orders have been received from DoPT, such new filed cases have to be defended in the court of law as per DoPT OM dated 3.2.2021 and 24.6.2021.

Subject : Guidelines for Issue of CGHS Card to serving employees and pensioners-reg.

In continuation of this Ministry's OM No . S.11012/3/2011-CGHS(P) dated 29.12.2011, the undersigned is directed to issue the following guidelines, in view of technological changes and change in payment methods of CGHS Contribution, for issuing of CGHS cards to serving employees and pensioners, as follows:

A. Serving Employees : a. Serving employees shall mandatory apply for a new CGHS card online (www.cghs.nic.in) to generate a temporary reference number. After online submission of the application form, they should take a printout of the same and submit the hard copy duly signed and photographs affixed thereon,

to the department currently employed, for processing and onward submission to the concerned Office of Additional Director, CGHS for issuing the cards. One copy is to be forwarded to the Additional Director of the concerned City and the other copy is to be retained by the Employer Department of the Central Government (hereinafter referred to as 'sponsoring authority) for CGHS benefits.

b. The requisition shall be sponsored by the Head of Department/Head of Office of the employee.

c. A Specimen copy of the application form for the New CGHS Card is enclosed at Annexure-1.

d. CGHS shall scrutinize the application based on the documents provided :

i. Pay Slip indicating the pay scale and CGHS deduction.

ii. Aadhaar Card/PAN card or any other valid document as per RBI guidelines, as ID Proof for Self and Dependent Family Members.

iii. Disability Certificate of Dependant (If applicable) as per OM No.4-24/96- C&P/CGHS(P)/EHS dated 07th May 2018. (Enclosed at **Annexure-2**)

iv. Photographs of self and Dependant Family Members.

The Standard Operating Procedure is enclosed at Annexure-3.

B. Pensioners : a. CGHS card(s) will be issued to eligible pensioners and family pensioners, drawing pension from Central Civil Estimate and his/her dependent family members, when the pensioner is not availing the Fixed Medical Allowance (FMA).

b. The pensioners also has the option for availing Fixed Medical Allowance with a CGHS card (IPD Card) by paying the full subscription, however, the CGHS 'IPD only' card shall be valid only for 'cashless' indoor treatment at CGHS Empanelled Private Hospitals/designated Government Hospitals. The beneficiary of 'IPD only' CGHS card shall also be eligible for reimbursement of expenses incurred for indoor treatment at any Government/Private Hospital only in case of a Medical Emergency.

c. The pensioners can submit his/her duly filled application form for the new Pensioner CGHS card, in the new Card Application Form (Annexure 3) to the Additional Director of CGHS city concerned.

d. The applications shall be accompanied with payment of CGHS Contribution on Bharat Kosh, along with the Challan generated from Bharatkosh as proof of payment.

e. The contribution (equivalent to 120 times i.e 10 years of existing CGHS contribution rate, at the time of retirement). The existing rates shall be as per the details provided below :

f. CGHS shall scrutinize the application based on the documents provided:

i. Self-attested PPO/ Provisional PPO or Last pay certificate

ii. Aadhaar card ID/PAN card or any other valid document as per RBI guidelines as ID proof for Self and dependent family members

iii. Disability Certificate of Dependant (If applicable)

iv. Photographs of self and dependent Family Members.

v. Copy of Bharat Kosh Challan for CGHS subscription paid vi. Proof of availing/non-availing FMA (if applicable).

The Standard Operating Procedure is enclosed in **Annexure-3**.

g. Retiring employees have the option to apply for a pensioner card along with pension papers 6 months before the date of Retirement (Online as a pensioner new card). The office shall observe the same procedure as for a serving employee for getting his/her CGHS card(s) prepared.

C. Consequent to verification of CGHS Card, the electronic form of CGHS card shall be accessible to the beneficiary using the option of 'Beneficiary Login' on CGHS Website, myCGHS app & Digilocker app for Android/iOS-based mobile devices. The electronic CGHS card shall be at par with CGHS plastic Card for availing benefits. The authenticity of CGHS card can be verified using the option of 'Verify beneficiary' available on CGHS Website (www.cghs.nic.in).

D. For the issue of a new CGHS plastic card upon mutilation, renewal or loss of the CGHS Card, application Form AA or BB (**Annexure 4 & 5**) along with the Bharatkosh Payment challan for **Rs. 100**/- shall be submitted for issuing a new card to the concerned Additional Director. To encourage the CGHS beneficiaries to use digital CGHS cards, it has also been decided that No fee shall be levied, in case the beneficiary opts for renewal/reissue of card without a fresh printed plastic card.

E. The Instructions issued for the CGHS beneficiaries from Member of Parliament, Ex-Member of Parliament; eligible Autonomous Institutions, Air India and PIB accredited Journalists shall remain as per extant rules.

F. The CGHS Beneficiary shall inform CGHS immediately, if there is any change in dependency criteria of his family members included in the CGHS Card. If he fails to intimate and if CGHS comes to know of the change, then the CGHS facility is liable to be withdrawn and the CGHS shall be free to write to the appropriate authority for recommending action under Service Rules or Pension Rules.

These guidelines issues with the approval of the competent authority and these guidelines shall be effective from one month from the date of issue.

Numerous grievances have been reported at MoHFW and at this office against the functioning of HCOs. To provided better services to the CGHS beneficiaries, the following instructions are to be followed strictly by all HCOs failing which necessary action will be intiated in accordance with the MoU.

1. Cashless CGHS facility is obligatory for all Pensioners & CGHS staff. There is no provision to take deposit from the pensioners & CGHS staff at the time of admission.

2. Name of the Nodal officer & contact number are to be prominently displayed. Any change of nodal officer or the contact number of the Nodal officer must be communicated to CGHS office and necessary changes must be made in the display by the repspective HCO.

3. Establish a dedicated CGHS Kiosk (Help Desk) For the convenience of CGHS beneficiaries.

- 4. Memo for emergency cases is not required.
- 5. Rubber stamp is not required on OPD/Admission memo.
- 6. Double billing is stictly prohibited.
- 7. At any cost there should not be harassement of CGHS beneficiaries.
- 8. CGHS original card should not be retained by HCOs during the treatment.

9. Quotation for unlisted investigations(s)/procedure(s) should be given to the beneficiaty on request. If the said test/procedure is not done at the concerned HCO, the same may be given in wiriting.

10. Retired Air India employees with valid CGHS card are eligible for cashless treatment at all CGHS empanelled HCOs.

11.CGHS beneficiaries aged 75 years and above shall be permitted to seek direct OPD consultation from all empanelled HCOs without referral from CGHS wellness centre. (Extended to aged 70 years)

12. CS (MA) beneficiaries and their dependent family members can get treatment at CGHS rates.

13. Prescriptions should strictly adhere to the government's policy by being a generic format.

In case of any complaint regarding excess billing /advance payment/harassment of CGHS beneficiaries is received in this office, necessary action will be initiated as per MoA. Please submit compliance report within two weeks that all the above guidelines are followed scrupulously.

CASHLESS TREATMENT FOR CGHS PATIENTS

LOK SABHA: UNSTARRED QUESTION NO. 1930 TO BE ANSWERED ON 2ND AUGUST, 2024

1930. SHRI S VENKATESAN:

Will the Minister of HEALTH AND FAMILY WELFARE be pleased to state:

(a) whether the Government is aware of the issues/difficulties being faced by Central Government Pensioners in getting Cashless treatment under CGHS;

(b) whether it is true that Empanelled Private Hospitals are reluctant to give treatment on Cashless basis for CGHS patients forcing them to remit the Charges and get it reimbursed later through CGHS and if so, the details thereof alongwith the reasons therefor; and

(c) the steps/measures taken/proposed to be taken by the Government to ensure Cashless treatment for employees/pensioners under CGHS and the details of action taken against errant hospitals in the matter?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (SMT. ANUPRIYA PATEL)

(a) to (c) As per MoU signed between CGHS and empanelled Health Care Organizations (HCOs), all Central Government pensioners and other eligible beneficiaries along with their dependents having a CGHS Card can avail cashless health services through NHA's IT platforms at CGHS empanelled hospitals and diagnostic centres. Central Government Pensioners facing difficulties in getting cashless treatment have been provided facility to submit their grievances through various means like email to authorities, PG portal, Local Advisory Committees/ Zonal Advisory Committee meetings with Additional Directors of CGHS cities.

Several steps have been taken to ensure Cashless treatment for employees/pensioners under CGHS, which are:

The steps taken by the department are primarily focused on the timely payment of Empanelled Hospitals. In the month of September 2023, the Department had decided to make all CMO In charges as Sanctioning Authorities (Three Hundred Forty-Six in total). This decision has enabled the department to reduce the pendency of payments from 5-6 months to the current payment times of 20-25 days.

A committee was constituted with the task for the revision of CGHS package rates. The committee has submitted the report.

Upon receiving any complaint, CGHS officials expeditiously resolve the issue by intervening in the matter through nodal officers appointed at every CGHS empanelled HCOs.

The show cause notices are issued and penalties are imposed on errant HCOs, as per the provision of MoA like forfeiting 15% of PBG, recovery of overcharged amount from pending bills etc.

HCOs are directed to attend regularly held Zonal Advisory Committee (ZAC) meetings to discuss and resolve the outstanding issues.

Instructions are issued to HCOs for strict compliance with CGHS guidelines/rules issued by Ministry/ Department from time to time

ii. He/she should be in sound health - both mentally and physically.

It may be noted that the honorium and reimbursement payable to the inquiry officers shall be governed by DoPT O.M. No. 168597747466 dated 16.11.2022.

2. All willing and eligible retired officers may apply by 30.8.2024 in the prescribed proforma to the undersigned. A copy of above referred DoP&Ts O.M. are annexed herewith for reference.

Respected Sir,

AICGPA Hq. Pune is the oldest pensioners Association formed by P&T pensioners in 1947 in Pune. Considering its activities, achievements and network, DOP&PW Delhi recognized it as identified Pensioners Association and a Standing Group member of SCOVA constituted in September, 2023. We represent most of the Postal/DOT/BSNL pensioners in South MP, Maharashtra, North Karnataka and Some districts of Tamilnadu.

Sir, In accordance with DOT, OM dated 20/02/2014, the BSNL retired employees who are in receipt of Central Civil Pension from Central Civil Estimates are eligible for joining CGHS. Most of the DOT as well as BSNL retirees in the Cities having the CGHS facilities joined CGHS by paying one time subscription. But due to the paucity of CGHS Wellness Centers at nearby location, some of the CGHS beneficiaries have to travel some 15-20 Kms to reach to the dispensary, which is troublesome for aged pensioners. CGHS authorities seek for Govt accommodation suitable for Wellness Center at reasonable price.

BSNL management has marked spare accommodations for leasing/ renting to Central/State Government/ Public Sector/Scheduled Bank. CGHS authorities are ready to hire but they say BSNL is charging huge amount for accommodation which is not found reasonable as per their guidelines.

In view of the Central Government Scheme for health care for Pensioners, DOT/BSNL may consider to rent out the Spare accommodation for CGHS Wellness centre at reasonable rate mutually agreed upon on priority.

A reply in line of the demand shall be obliged.

It is brought into your notice that the Minutes of Meeting held on 16/07/2024 are not issued so far even after 1 and half months passed also the compliance on the individual grievances submitted in our agenda has not been issued.

With reference to your office letter No. CCA/MH&GOA/Qtly Meeting/24 dated 22/07/2024, we herby submit the following Agenda- items for consideration.

A. Common issues:

- 1. Delay in disbursement of pension for the month of July and August 2024. Association has been receiving complaints from pensioners about the delay in disbursement of monthly pension. This problem was already discussed in the meeting held on 16th July, 2024, but there is no improvement. In august, most of the pensioners complained that they did not receive the SMS of pension credit till 1st September, 2024, especially pensioners having account with Canara Bank and Union Bank Of India. No information was shared by CCA, Maharashtra & Goa to calm the sentiment of the pensioners.
- 2. Excess recovery of Income Tax: There are complaints that while disbursement of Pension for the month of July, 2024 and August, 2024, Income Tax is recovered in excess of dues. For example:

Shri D. G. Kulkarni, PPO No. 402018041238743, through Email.

Smt Vibhavari Kakade , PPO No. 402007021205162 Rs. 8000/-

Smt. Kharat Meenakshi PPONo. 402020012205570 Rs. 8000/-

Secondly, Shri Subhash Keshaorao Patankar, Div.Engineer Retd. PPO No. 402012031204000 complained that Rs.13462 per month have been deducted for 4 months from March 24, April 24, May 24 and June 24 against Income Tax (Total 13462×4 =Rs.53848) by CCA. Whereas, As per message received Rs.1430 only is deposited with Income tax dept.

B. Individual Grievances:

1. Smt D. Kameshwari, wife of late D. Jagannadhan, Resident Audit Officer Retd. was migrated to SAMPANN in the month of December, 2023. She did not receive the pension for the month of November 2023. Union Bank of India advised her to approach CCA, Maharashtra.

- 2. Smt. Savitri Chidambar Kulkarni, Family Pensioner was migrated on 20/09/2023 PPO No., 402012011144071. Pension was stopped from September,2023. She had submitted DLC on 28-02-2024. He Completed 80 years on 14 December 2023. Additional pension has not been disbursed as yet. In the absence of Form 16, he could not file ITR for FY 2023-24.
- 4. Shri Yadav Surendra Narsayya, Perner No. 99306206 . BSNL Pune has issued Revised Final Retirement order vide No. MHPUN-11/19(ii)/1/2024-Admin Pune/67 dated 30/05/2024 in supersession of earlier order. The copy of the same was sent through Email on 30/05/2025. BSNL has also released the payment of exgratia. His provisional pension is stopped from July-202. Regular pension is not authorized as yet. Shri. M.M.Syed , Asst. Eng. Telecom Factory Mumbai, Retired on 01-11-1989 PPO No. 561989111116546 yet to get his pension revision according to 7th CPC. Further his pension also reduced. The details already shared through E-mail addressed to CCA Maharashtra and Goa by pensioner on 20/01/2024. CCA Mumbai has sent his case to CCA Maharashtra and Goa.
- **5.** Revision of Pension in respect of Shri. A.R.Bharambe, Akola PPO No. 402015061226184: His pay has been revised as JTO (Officiating), He submitted all the details. He did not receive revised pension/ Arrears.

०१.०१.२००७ पासून 2nd PRC च्या शिफारसीनुसार नियम 37 A च्या तरतुदींनुसार निवृत्तिवेतन सुधारणा आली. तथापि, ०१.०१.२०१७ पासून निवृत्तीवेतन पुनरावृत्तीच्या बाबतीत, सुरुवातीला डीओटी ने निराधार भूमिका घेऊन, नियम 37 A अंतर्गत नमूद केलेल्या तरतुदींचे पूर्ण उल्लंघन करून, पेन्शन पुनरावृत्ती बीएसएनएल कर्मचाऱ्यांचे वेतन सुधारणेशी निगडित आहे. असे सांगण्यात आले.

वैधानिक नियम 37 A च्या उपनियम 8 नुसार, हे निःसंदिग्धपणे नमूद केले आहे की बीएसएनएल/एमटीएनएल मध्ये सामील झालेले कर्मचारी सरकारमधून सेवानिवृत्त झाले आहेत असे मानले जाते व त्यांच्या सेवा आणि पेन्शनची गणना या नियमांनुसार केली जाईल. तसेच बीएसएनएल/एमटीएनएल मध्ये सामिल झालेल्या कर्मचाऱ्यांच्या वेतनातून FR 116 आणि FR 117 A च्या तरतुर्दींनुसार, त्यांच्या IDA वेतनश्रेणीच्या आधारावर पूर्णत: पेन्शनचे योगदान वसूल केले व सरकारकडे जमा आहे.

वरील तरतुदींवरून हे स्पष्टपणे स्पष्ट होते की बीएसएनएल/एमटीएनएल मध्ये सामावून घेतलेल्या कर्मचाऱ्यांनी त्यांच्यासाठी सरकारी पेन्शनबाबत दायित्व पूर्णत: पूर्ण केले आहे आणि त्यांची पेन्शन पुनरावृत्ती बीएसएनएल/एमटीएनएलतील कार्यरत कर्मचाऱ्यांच्या वेतन/वेतन पुनरावृत्तीशी जोडलेली नाही. त्यामुळे CCS (पेन्शन) नियम, २०२१ च्या नियम 37 A च्या आधारे १.१.२०१७ पासून पेन्शन पुनरावृत्तीची मागणी, वेतन पुनरावृत्ती वेगळे करणे पूर्णपणे योग्य आणि न्याय्य आहे.

दूरसंचार विभागालाही या गोष्टींबद्दल खात्री पटली म्हणून अंतर्गत आणि इतर संबंधित मंत्रालयांसोबत दीर्घकाळ चर्चा केल्यानंतर ऑगस्ट २०२२ मध्ये DOT फाईलमधील नोट्सनुसार पेन्शन सुधारणेसाठी संमती दिली. व सर्व बीएसएनएल/एमटीएनएल पेन्शनर्स असोसिएशनसोबत १०-१०-२०२२ रोजी DOT ने बैठक बोलावली होती. या सभेत तत्कालीन सदस्य (सेवा) श्री. महेश शुक्ला यांनी सांगितले की,

- (a) पेन्शन पुनरावृत्ती वेतन पुनरावृत्तीपासून वेगळे केली जाईल.
- (b) पेन्शन सुधारणा 3rd PRC च्या शिफारशीनुसार केली जाईल.
- (c) संभाव्य विसंगती टाळण्यासाठी, २०१७ नंतरच्या सेवानिवृत्तांना नवीन वेतनश्रेणींवर काल्पनिक वेतन निश्चिती दिली जाईल.

DOT द्वारे ऑफर केलेले शून्य टक्के फिटमेंट हा पेन्शनर्स असोसिएशनला मान्य नव्हता. सविस्तर चर्चेनंतर, DOT ने शेवटी आश्वासन दिले की सुधारित प्रस्ताव अधिक फिटमेंटसह सादर केला जाईल. त्यानुसार नवीन प्रस्तावाची प्रक्रिया सुरू करण्यात आली. २१ मार्च २०२३ रोजी जॉईंट फोरमचे प्रतिनिधी सदस्य (वित्त) आणि सदस्य (सेवा) यांना भेटले, तेव्हा त्यांनी स्पष्टपणे सांगितले की सुधारित प्रस्ताव अंतिम टप्प्यात आला आहे आणि ते माननीय मंत्र्यांच्या फिटमेंटच्या मंजुरीची वाट पाहत आहेत. कदाचित एप्रिल 2023 च्या पहिल्या आठवड्यात ते शक्य होईल. दुर्दैवाने DOT ला ज्ञात असलेल्या कारणांमुळे त्यानंतर काहीही झाले नाही.

गेल्या ९१ महिन्यांपासून प्रलंबित असलेल्या पेन्शन रिव्हिजन साठी अन्यायकारक विलंब झाल्याने बीएसएनएल/एमटीएनएल पेन्शनधारकांना गंभीर त्रास सहन करावा लागला आहे, कारण त्यापैकी बहुतांश पेन्शनर्स वृद्ध आहेत आणि त्याहूनही वाईट, म्हणजे मोठ्या संख्येने पेन्शनधारक त्यांचे कायदेशीर हक्क न मिळाल्याने हे जग सोडून गेले आहेत. म्हणून या वयात सुद्धा खालील टप्प्यात आंदोलन करण्याचा निर्णय घ्यावा लागला.

पहिला टप्पा : २ जुलै २०२४ रोजी बीएसएनएलच्या सर्व स्थरावरील कार्यालयासमोर निदर्शने करुन निवेदन देण्यात आले. दुसरा टप्पा : ५ सप्टेंबर २०२४ रोजी सर्व भारतभरातील सीसीए कार्यालयासमोर निदर्शने करुन निवेदन देण्यात आले. तिसरा टप्पा : १२ नोव्हेंबर २०२४ रोजी जंतर मंतर नवी दिल्ली येथे धरना कार्यक्रम आयोजित करण्यात आला आहे.
