GS SPEAKS

I am pleased to inform you that 73rd Annual General Body Meeting of our Association will be held at Shri Kalika Devi Mandir Sansthan Bhaktniwas, Old Agra Road, Nashik - 422002 on 11.10.2025 at 2.30 PM. Branch Presidents/Secretaries are requested to remain present with the delegates, participate and make it grand successful.

Central Government pensioners are required to submit the Life Certificate in November every year to continue the pension. The Pensioners aged 80 years may submit Life certicate in October also. Pensioners can generate the Digital Life Certificate through Jeevan Pramaan App using SMART Mobile. They need not physically visit their Pension Distributing Authority.

Cabinet approved the formation of Eighth Central Pay Commission on 17th January, 2025. But the Commission is not constituted as yet. We have addressed the issue of Delay in Constitution of 8th CPC Commission and Notification of Terms of Reference for 8th CPC to Cabinet Secretary, Govt. India on 24th June, 2025 and also in the meeting under chairmanship of Secretary(Pension). We have already submitted the items for inclusion in the Terms of Reference for 8th CPC. We will keep a close watch on Constitution of 8th CPC, Terms of Reference, Recommendations of the Commission and the Govt's decision on pensionary benefits.

In success of our efforts for empanelment of Private Hospitals in NON CGHS area, the Application of Pvt. Hospital in Nanded has been scrutinized by Addl. Director CGHS Pune and forwarded to Director(CGHS Hq), New Delhi for approval.

On the approval of MOF, Department of Expenditure, Ministry of Heath & Family Welfare vide order dated 17.09.2025 sanctioned the 88 posts for opening 22 new Alopathic CGHS Additional Wellness Centers including Wellness Center at NAVI Mumbai. Addl. Directors (CGHS) were required to submit the requisitions for filling up the posts of the staff required.

57th Pension Adalat was held under chairmanship Ms. Jayati Samaddar, GM Finance on . 15/09/2025. GM Finance Agreed to i) accept the applications of Pension Adlat through Email, ii) Issue Instructions to Regional Offices to hold the Pension Adalat twice in the year and submit the report to Circle Office iii) Issue instructions for processing the cases of Grant of Notional Increments.

In respect of the Writ petition regarding Revision of Pension of BSNL-MTNL Pensioners pending Delhi High Court, DOT has filed additional Affidavit on 19.08.2025 clarifying that OM dated 12.05.2017 issued by DoP&PW

consequent to recommendations of the 7th CPC revising the pension/family pension of ex Government employees are not applicable to the BSNL/MTNL pensioners.

Meeting of Joint Committee on Pay revision of Non-Executive BSNL employees was held on 3rd September, 2025 Management side offered the Pay Scales discussed in November, 2022. Staff side stated that they are ready to accept the Pay Scales offered in November, 2022, However fitment should be at par with fitment for executives subject to , protection of Pay loss, no stagnation in 2026 & 2027. Staff side also stated that these pay Scales must not be taken as basis at the time of next revision. We hope that the Agreement would be signed with these Pay Scales.

Government Order

OM. No. 1/23120 12-P&PW(E), Dated: 13th September, 2012, Government of India, Ministry of Personnel, Public Grievances & Pensions, Department of Pension & Pensioners' Welfare, New Delhi

In accordance with the instructions issued vide this Department's OM No.38/37/08-P&PW(A) dated 21.5.2009, 11.8.2009,25.6.2010 & 28.9.2010 and OM No.1/19/11-P&PW(E) dated 3.8.2011, additional pension/family pension to old pensioners/family pensioners is allowed on the basis of the date of birth/age recorded in the Pension Payment Order (PPO) or other office records. Only in case the details regarding date of birth/age are not available in the PPO/office records, additional pension/family pension to old pensioners/family pensioners has been allowed on the basis of certain documents i.e. PAN Card, Matriculation certificate. Passport, CGHS Card, Driving Licence, Voter's ID Card and Aadhaar Number issued by UIDAI.

- 2. During his service and at the time of retirement, a Government servant is required to give details of his family, including date of birth of its members, in Form 3. Date of birth/age of the members of family mentioned by the Government servant in Form 3 was not mandatory to be verified by the Head of Office. It is felt that in some case, the date of birth/age of a family pensioner, as recorded in the PPO/office records might be incorrect.
- 3. Some representations have been received in this Department regarding the hardship being caused to old family pensioners in getting the additional pension on account of incorrect recording of the date of birth/age in the PPO. They have been requesting for allowing the change of date of birth in ~he PPO on the basis of the documents prescribed in the various OMs mentioned in Para I above.
- 4. The matter has been considered in this Department in consultation with the Ministry of Finance, Department of Expenditure and the following decisions have been made:
- i) Since the date of birth of the Government servant is recorded in the PPO on the basis of the service records and the date of superannuation etc. also is determined on the basis of this date of birth, there is no question of allowing change in the date of birth of the retired/deceased pensioner in the PPO.
- ii) The request for change of date of birth/age of the family pensioner (parents and spouse) in the PPO may be submitted by a pensioner/family pensioner to the Head of the Department of the organisation where the Government servant had last served along with at least one of the documents mentioned in Para 1 above and a declaration on a non-judicial stamp paper regarding the correct date of birth of the family pensioner. The Head of the Department may allow the change in the date of birth of the family pensioner if he is satisfied that the conditions indicated in this Department's OM No.38/37/08-P&PW (A) dated 21.5.2009 have been fulfilled and that a bona-fide mistake has been made in recording the date of birth in the PPO.
- iii) No other document will be accepted for allowing the change in date of birth/age of the family pensioner in the PPO.
- iv) In order to avoid any possibility of recording an incorrect date of birth in the PPO, in future, the Government servant may be required to submit one of the documents indicated in Para 1 above as proof of date of birth of spouse or parents along with the details of family in Form 3. In the case of children certificate of birth from the Municipal authorities or from the local panchayat or from the head of a recognised school if the child is studying in such a school or from a Board of Education may be accepted.
- 5. As regards pensioners/family pensioners belonging to the Indian Audit and Accounts Departments, these Orders issue after consultation with the Comptroller and Auditor General of India.
- 6. This issues with the concurrence of Ministry of Finance, Department of Expenditure vide their J.D. No 428/E.V/2012, dated 27/8/2012.

Subject: Change of name of spouse Advice of Department of Pension and Pensioners' Welfare.

The undersigned is directed to refer to this Department's OM No. 3(2)/2022- P&PW(H-7942) dated 6.10.2022 regarding change of name of spouses (copy attached). The advice contained in the aboe mentioned OM dated 6.10.2022 as under:

(i) There is no separate procedure prescribed in the CCS (Pension) Rules, 2021 or CCS (Pension) Rules, 1972 for change of name / surname in the PPO of Government employees or spouse after retirement. The PPO is issued on the basis of service record/service book of the employees and the maintenance of service book is concerned with DoPT.

- (ii) Further, this matter was discussed in the inter-ministerial Review meeting of pending grievances in CPENGRAMS, held under the chairmanship of Director (PW), Department of Pension & Pensioners' welfare. Ministry of Statistics & programme implementation were informed that they may follow DoPT's OM No. 190016/187 Estt. dated 12th March, 1987 for change of name of family pensioners also. In case the Ministry of Statistics & Programme implementation feels that there is some discrepancy in the documents submitted by the complainant family pensioner in support of her application for change of name in the PPO, they may sort it out with her directly and ensure that the request for change of name fulfils the conditions of DoPT's OM No. 190016/187-Est. dated 12th March 1987.
- 2. All Ministries / Departments are requested that the above provisions may be brought to the notice of the personnel dealing with the pensionary benefits in the Ministry/Department and attached /subordinate offices therunder for compliance.

Subject: Comprehensive Guidelines for the Nation-wide Digital Life certificate campaign 4.0, November 1st to 30th, 2025

The digital empowerment of pensioners is the stated policy objective of the government of India. In this regard, a Nationwide Digital Life certificate campaign is coordinated by the Department of Pension & Pensioners welfare annually from the 1st to 30th November. The large scale campaign is executed in collaboration with Public sector Banks, India Post payments Bank, UIDAI, MeitY, Pensioners welfare associations and stake holder departments of ministry of defence, Ministry of railways and department of posts. In the last three years, more than 4.50 crore DLCs have been generated by pensioners belonging both, to the state governments and central government. The DLC campaign 4.0 is proposed to be held in November 2025 in 2000 cities/ towns across India.

- 2. In order to conduct this Campaign, DoPPW shall obtain the support of the following stake-holders:
- India Post Payments Bank (IPPB)
- Pension Disbursing Banks
- Pensioners' Welfare Associations
- Department of Telecommunications
- Ministry of Defence (for their own pensioners)
- Ministry of Railways
- All Ministry/Departments
- State governments through their treasuries/Pension Disbursng offices.
- Employees provident Fund Organization
- PIB & DD (for media support)
- UIDAI & MeitY (for technical support)
- 3. Nation wide DLC campaign 4.0 Features:
- There shall be a common All-India banner of the Nationwide DLC campaign to be shared separately by DOPPW.
- DoPPW shall nominate its Nodal officers for the states. These Nodal officers shall tie up with the campaign Nodal officers of the different stake-holders, as given above for the respective states/UTS.
- The campaign duly executed through DLC camps would be held at all districts Headquarters in collaboration with IPPB and pension disbursing banks. Hence, there may be a city/town which would have multiple camps either of two or more banks or of IPPB, CGDA, M/o Railways and Banks.

- The cities have been identified and multiple locations within each city shall be identified by Banks and other stakeholders.
- Camps will be organized at the identifies multiple locations in each city, shortlisted for the campaign by the banks/CGDA/M/o Railways/IPPB/State government(s).
- Each bank shall nominate its nodal officers for each state/UT who shall coordinate with the Banks nodal officer for each city for the campaign. DoPPW shall coordinate with the state Nodal officers only.
- IPPB shall coordinate with the state Nodal officers only.
- IPPB shall nominate Nodal officers for each district across India.
- M/o Defence, M/o Railway, D/o Telecommunications and EPFO shall appoint their own Nodal officers, accordingly dovetailing the locations as covered by DoPPW.
- UIDAI and MeitY shall also nominate Nodal officers for technical support for each state/UT.
- PIB & DD shall nominate its Nodal officers for publicity in each State/UT.
- From September, 2025 onwards wide publicity is to be carried out through social media, print media and by all stakeholdrs.
- The Banks associating with the campaign will hold camps on all days of the monthe of November, 2025.
- IPPB/CGDA.M/o Railways/State government(s) acciating with the campaign in a particular state shall hold camps on designated days of November, 2025 and communicate details of the same to DoPPW.
- MeitY will give real-time support on the progress of the campaign.
- A social media group of all the Nodal officers shall be created by DOPPW for real time sharing of information during the Campaign.
- 4. **A separate DLC portal with** URL https://ipension.nic.in/dlcportal/ is available wherein details of Nodal officers at state and city level shall be registered. All inputs related to the campaign such as URLs of tweets and PIB notes/press releases are to be entered in this portal. The user manual for the DLC protal is attached for reference.
- 5. Campaign Period activities (1st November 30th November, 2025)
- Launch of Nationwide DLC Campaign 4.0.
- DLC camps in identified cities/towns as per schedule. In all other places, Banks/Establishments shall keep the facility open.
- Daily updation of data centrally by MeitY of the progress of the Campaign on the DLC Portal.
- Release of PIB statements and tweets for every city by respective nodal officers. This shall be monitored
 by the DoPPW official in-charge of that particular State/UT. The links of PIB, tweets as well as DD coverage
 will be shared by the Nodal officers on the portal/social media group.
- Release of Nationwide DLC campaign booklet and film by DOPPW.
- 6. The role of Ministries/Departments/Banks and state Governments are at Annes. 1. The SOP regarding Face Authentication technique is at Annex. 2. User Manual for DLC Portal is at Annex. 3.

The remaining pensioner's may continue to submit their Life Certificate from .lstNovember 202510 3dh November 2025.

- 2. In view of the upcoming activity of submission of Digital Life certificate by pensioners to start from 1 Oct, 2025, it is requested to do the following:
 - a) Activate all the Jeevan Pramaan Centre IDs which are currently inactive in your respective Circle.
- b) Establish the Jeevan Pramaan Centres in the Head Post Offices wherein it has not been established, get their Jeevan Pramaan IDs created and ensure that all Jeevan Pramaan Centre IDs are activated positively.
- 3. Kindly bring this to the notice of all the concerned. An action taken report in this regard may please be submitted to this division by 12th September 2025.

Subject: Guidelines for Pensioners Welfare Associations (PWAs) including Grant-in-Aid

The undersigned is directed to say that a committee was constituted on the subject mentioned above. After the deliberations of the said committee, comprehensive guidelines have been framed for Evaluation of identified Pensioners' Welfare Associations (PWAs), Grant-in-Aid and for identification of new Pensioners' Welfare Associations, which are as under:

- 1. Department of Pension & Pensioners' Welfare has, at present, 57 identified Pensioners Welfare Associations (PWAs) with it, which play a crucial role in helping pensioners and also act as an extended arm of the Department. The Pensioners' Associations make a valuable contribution in various ways, such as:
- i) Catering to welfare of all Civil/Railways/Defence/Postal/Telecom pensioners who have their registered offices in States/Union Territories all over India.
- ii) Since it is not possible for DoPPW to reach out to the pensioners spread across the country, due to lack of subordinate offices at field level, they work as extended arms of the Department. They have a number of affiliate associations, reaching out to pensioners in the remotest corners of the country.
- iii) These Associations make a valuable contribution for circulating the OMs, orders, guidelines issued by the Department through print media, WhatsApp groups and other means.
- (iv) They resolve a number of doubts of pensioners at their level by providing clarification of OMs / Circulars issued by the department as well as information and guidance on pension and other retirement related matters.
 - (v) They facilitate redressal of pensioner's grievances by registering their grievances on grievance portal.
 - (vi) They liaise with offices of Government of India w.r.t. pensioners' grievances.
- (vii) They play an active role in helping pensioners to submit Digital Life Certificates. For this purpose, they hold regular camps and visit old/ sick/ incapacitated pensioners at their homes / old age homes and at the hospital.
- (viii) They organize various campaigns in keeping with national initiatives such as Swatchhata Abhiyan, Hindi Pakhwada, Azadi Ka Amrit Mahotsava, Visiting Old Age Homes, Hospitals, Schools etc.
 - (ix) They assist DoPPW in their various ventures / initiatives by mobilizing pensioners in large numbers to

spread awareness / for publicity. The Nationwide Campaigns where camps were held across the country in November 2022, 2023 and 2024 to spread awareness of Digital Life Certificates and technique of Face Authentication method is an example in this regard.

- 2. The Department gives annual Grant-in-Aid (GIA) to the identified PWAs and is in the process of increasing the number of Pensioners Associations in near future. During various meetings held with Pensioners' Welfare Associations (PWAs) and during SCOVA meetings, the matter regarding increase in Grant-in Aid to the PWAs as well as flexibility in the areas of expenditure of the GIA has been raised by the Associations.
- 3. Further, with the specific objective to facilitate redressal of Pensioners grievances and provide detailed information and guidance on pension and other retirement related matters through various stake holders, by reaching out to pensioners in remotest parts of the country, particularly in the unrepresented states, the Department intends to register more Central Government Pensioners Associations who fulfill the eligibility criterion.
- 4. Based on the recommendations of the committee, the following decisions have been taken for implementation of Grant-in-Aid and other issues pertaining to Pensioners' welfare Association. (PWAs).

A. Role of PWAs:

With Citizen centric approach of government of India, PWAs should play a more proactive role in ensuring pensioners welfare, adoption of e-governance and strong monitoring mechanisms as detailed below:

- i. Organizing awareness programs for pensioners based on OMs/guidelines issued by DOPPW.
- ii. Facilitate pensioners in redressal of pensioner's grievances through CPENGRAMS portal.
- iii. Facilitating pensioners in submission of Digital life certificate during Nation-wide facilitating pensioners in submission of digital life certificate during Nation-wide DLC campaigns launched by DoPPW.
 - iv. The Pensioners' welfare associations should have dedicated official e-mail ad website.
 - v. The pensioners associations should have whats app groups covering all members of the associations.
- vi. The Pensioners' Associations should have their association twitter handle and actively view all tweets of the department for participation and information.
- vii. The Pensioners' associations should release monthly journal/magazines which showcase meetings campaigns, activities by the association and OMs/circulars, programs/workshops of DoPPW.
- viii. The pensioners' welfare associations should have adquate office space for daily working and meetings for 12 to 15 pensioners. Rest room facilities should also be available in the office space area.
 - ix. The pensioners welfare associations should have various committees on welfare, health, legal, etc.
- x. The pensioners' welfare associations should have governing structure like governing body, executive body, etc.
 - xi. The pensioners' welfare associations should have by laws as per the tempate approved by DoPPW.
- xii. The pensioners' welfare associations should have adequate IT infrastructure (computers/Printers/Sacnners etc.) telephone & internet connection.
- xiii. The pensioners' welfare associations should have at least 1 office Assistant/Data entry operator, hired as per minimum wages act, for maintaining records and helping association in discharging their function.
 - xiv. The pensioners' welare associations should have 01 sweeper/MTS for maintaining cleanliness.
- xv. The pensioners' welfare associations should have a defined system of identification of affiliates and providing them with financial and administrative support.
- xvi. All pensioners' welfare associations should have a sustainable self-financing model apart from grants by DoPPW.

B. Criteria for identification of new Pensioner's welfare associations (PWSs)

Selection of new penisoners' welfare associations will be based on the criteria laid down by the department and a committee duly constituted for this purpose will identify the new PWAs. In this regard, the following criteria, which also include existing guidelines, are recommended as under:

- i. Total membership of the association should be not less than 100.
- ii. Audited accounts for last three years should be provided.
- iii. Annual activities report for last three years should be provided.
- iv. The pensioners' welfare associations should be registered under the relevant government act.
- v. While identifying new PWAs, the department will give preference to PWAs in the unrepresented States/ UTs. Every year a maximum of 1 PWA will be identified per unrepresented state/UT, based on the highest membership. This will be done to ensure that there is an pensioners in the remotest parts of the country. PWAs are required to inform the service category (Civil/Defence/DoT/DoP/ Railways/others) of the pensioners they are representing. The minimum membership for a PWA will be 100 members.
- vi. The PWA has to give a certificate to the effect that information provided by them for availing GIA is correct. Furnishing of false information will lead to debarment of that PWA from this department for a period of three years and no GIA will be sanctioned.
- vii. Physical verification of the PWA with regard to office sapce and other documents will be conducted by an officer from the department before identifying the PWA for grant-In-Aid to be sanctioned by this department.

C. Criteria for De-registration of Association

- The PWA which is not active or has been closed in any circumstances.
- The PWA which does not actively participate in the meetings or VCs organized by DoPPW.
- PWA which has not participated in any workshop or event hosted by DOPPW.
- PWA which gets a score of less than 50 as per score sheet for Evaluation of Pensioners' Welfare Associations (as mentioned in Para 4 E) for a continuous period of two years.

D. Process of availing GIA

The process of availing GIA involves the following steps:

- Pensioners' associations are required to fromulate an Annual Action Plan and also to submit their performance-cum-Achievement Report on the activities undertaken during the year.
- Grant-in-Aid sanctioned on annual basis on providing of a Utilization certificate of the grant sanctioned in the previous year and on submissiopn of duly audited accounts.
- The associations have to register on Niti Aayog's Dapan website and obtain a unique ID number before applying for grant-in-Aid.
- A GIA application portal "Anudaan" is hosted by DoPPW for receiving and processing the application from the pensioners' associations registered with NGO Darpan portal of NITI Aayog.
- The protal can be accessed by pensioners associations and all the applications for grant-in-aid are submitted through "Anudaan" portal.
- All expenses incurred by associations are required to be booked online by using PFMS and a Utilizations are required to be booked online by using PFMS and a Utilization certificate is required to be generated for the Grant-in-Aid provided in the previous year.
- After registration, the pensioners' associations may apply for grant in aid on Anudaan, for which uploading of the utilization certificate of the previous year on the protal is mandatory.
 - GIA is released by the department after verification.

E. Criteria for sanction of Grant-in Aid.

- PWAs to be made more vibrant, dynamic, result-oriented and effective in serving pensioners across the nook and corner of the country. The amount of grant-in-aid to PWAs from the financial year 2025 2026 onwards will depend on various criteria and the amount of grant -in -aid will be assessed according to the fulfillment of eligibility criteria of the concerned Association.
- This criteria pertains to (a) Organizational structure of PWA, (b) Participation in various initiatives and (c) Welfare activities conducted for members. The score sheet based on these criteria is as below:

A. Organizational structure of PWA

- A.1. Membership
- A.2 Having own Website (yes/No)
- A3. Mode of communications with members (mail/whatsapp groups/ Magazines)
- A4. Regular meeting with members secretary). Annual General Meeting
- A5. Fully updated record of members
- A6. PWA serving in unrepresented states

B. Participation in various initiatives

- B1. National / DoPPW initiatives (Har ghar Tiranga, Swachhta Abhiyan, Yoga Day etc)
- B.2 Active participation in all meetings held by DOPPW

C. Welfare activities conducted for members

- C1. Health Camps
- C2. Health care support-assisting members by providing medical service
- C3. Doorstep Banking assisting members in availing banking facilities
- C4. Training programs DLC, CGHS, family pension and other pension related matters
- C5. Publications
- C6. Registration of grievances on CPENGRAMS on behalf of members
- C7. Resolution of grievance at field level (Banks, PAOs, Treasuries etc.)
- C8. Participation in DLC Camps-No. of DLCs generated
- All indentified Pensioners' welfare associations will submit their utilization certificates for Grant-In-Aid disbursed during the previous financial year and apply for grant -in-aid for the current financial year well in time. Along with this application, information for eah criteria needs to be provided along with documentary proofs as specified against each criteria in the score sheet in order to ensure timely disbursement of Grant-in-Aid.
- All identified pensioners' welfare associations will be evaluated every year on the basis of these criteria and grant-in-aid will be sanctioned accordingly.

F. Monitoring mechanism for pensioners' welfare associations

- Pensioners' Associations have to submit monthly report which includes number of meeting, tweets, website updation, issues faced by them.
 - Publish Annual Report on the basis of monthly book or magazines.
- DoPPW will conduct pensioners awareness programs and associations have to participate and mobilize pensioners for the awareness programs. The expenditure regarding pensioners awareness workshop will paid by DoPPW.
- DoPPW will conduct monthly meeting through video conferencing with the entire pensioners' associations. The participation in VCs is mandatory for all the associations.
- 5. The above guidelines are applicable for existing registered PWAs identified by DoPPW and for new PWAs to be identified by DoPPW in future. These Guidelines will be reviewed once every two years.

Terms of Reference for 8th CPC forwarded by Secretary Staff Side NC(JCM) through Department of Personnel & Training

- A. To examine the existing structure of pay, Allowances and other benefits/facilities, retirement benefits like pension / gratuity and other terminals benefits etc. to the following categories of employees:-
 - 1. Central Government employees-industrial and non-industrial.
 - 2. Personnel belonging to All India services.
 - 3. Personnel belonging to the Defence Forces and Para Military Forces.
 - 4. Personnel called as Grameen Dak Sewaks belonging to the Postal Department
 - 5. Personnel of Union Territories.
 - 6. Officers and employees of the Indian Audit and Accounts Department.
 - 7. Officers and employees of the Supreme Court.
 - 8. Members of Regulatory bodies (excluding RBI) set up under Act of Parliament.
 - g. Employees of Central Government Autonomous Bodies and Institutions.
- B. To work out the comprehensive revised pay packet for the categories of Central Government Employees mentioned in (A)above as on 1.1.2026.
- C. The Commission will determine the Pay structure, benefits, facilities retirement benefits, welfare matters etc taking in to account to provide the minimum wage as a "Decent and dignified Living Wage" with reference to the recommendation of the 15th Indian Labour Conference (1957) with modifications in the Dr. Aykroyd

formula considering the developments and life requirements which has undergone changes in last 65 years and also the various Judgments of Hon'ble Supreme Court Judgments on fixing the minimum wages as on 1.1.2026. The Commission also consider to increase the consumption units from 03 family units to 3.6 family units as recommended by an expert committee constituted by Ministry of Labour and Employment to determine the National Minimum Wage Policy in the year 2019.

- D. The 8th CPC should consider the merger of non-viable Pay scales such as Level 1 with Level -2 and level 3 with Level 4 and Level 5 with Level 6.

Proceedings of Meeting with Dy DAP Nagpur on 28.08.2025

SarvaShri H. F. Chaudhari, General Secretary, G. G. Nerkar Org. Secretary and Shyam Kawale Treasurer Bhandara Branch met Shri Gaurav Raut, Dy. DAP Nagpur on 28.8.2025 at 2.30pm.

Shri Raut could spare only 15 minutes as he had to board a flight to attend meeting at CPMG office, Mumbai. We specifically requested him about pending NPS-OPS cases as referred by DAP to Postal Directorate, it may be required to talk with the Directorate to resolve the long pending cases. He agreed to look into all the issues reported through our correspondence. He directed Sr. Accounts Officer (Pension), Mrs Srividya to discuss the issues in detail.

Discussions with Sr. AO

Regarding NPS to OPS issues, she has prepared the status on the cases referred by us; which are not normal and required to be referred to Directorate.....

Shri. V. A. Pawar, Ex-postman was retired on superannuation on 30.9.2018. He was authorized gratuity of Rs. 2,63,154/- (Since the pensioner was covered under NPS) vide postal/NPS/2018/MH/84633/DCRG/Group

F/6432 dated 23.10.2018. As per option exercised by the official he was coverd uner OPS vide dte orders dated 17.2.2020. Hence PPO was issued vide POSTAl/2018/MH/84633/3019 to 3021 dated 13.9.2024. As per Nps Itr no NP/NPS to OPS/Sangli Dn Cased/1931 dated 17.1.2024. He was asked to refund Rs. 550583.71/towards 60% corpus. However he requested to revover the amount from pension arrears. Therfore the case was referred to directorate.

Shri V. M. Kumbhar, Postman was retired on 31.5.2017 under NPS. Howver in accordance with DoP&PW OM no. 57/04/2019-P&PW(B) dated 17.2.2020. He had been brought udner OPS. But before submmision of the pension papers the the official was expired on 14.5.2023. Hence Sangli division forwarded the case for sanction of family pension on 7.10.2024. While processing the case, NPS section was asked whether the claimant had refunded 60% of corpus. NPS section has sought clarification from Directorate on the following points.

- 1. Rate of interest at which the refund of corpus fund should be made
- 2. Refund of 40% of corpus spent on purchase of annuity
- 3. Refund of pension paid from the date of retirement from NPS

The clarification is awaited from directorate.

I requested to Sr. Accounts Officer to check with Tamilnadu Circle also, how do they settle such cases.

Regarding pension revision on account of Notional increment

it is informed that DAP received in all 49 cases of third-party(ie. who had not gone to the Court) mostly from Akola and Amravati Division and 44 cases of the pensioners who had gone to the court and benefits are to be given as per the judgement.

On raising the issue there may be so many cases pending at other divisions and Circle/DAP may issue the necessary instructions. She agreed to talk with DAP and do the needful.

Regarding pending case Of Shri B. J. Ambalkar, she enquired with Yevatmal division, it is informed that his Service Book is not available to process the case of counting Induction training period.

Sri Shyam Kawale has also brought into the Notice long pending second stage Family pension cases. She agreed to look into, if the required details of the cases are provided to her.

Subject : Guidelines for allowing medical facilities under CGHS/CS(MA) Rules, 1944, to dependent transgender children/sibilings irrespective of age - Reg.

In compliance with the provisions of the transgender persons (Protection of Rights) Act, 2019, it has been decided to allow medical facilities under Central Government employees (serving/pensioner) irrespective of age, subject to the following conditions:

Sub: Record of discussion of the reconstituted Joint Committee on wage revision for Non-Executive employees w.e.f. 01.01.2017 in BSNL held on 1.9.2025 and 3.9.20205.

The 12th meeting of the reconstituted Joint committee was held on 1.9.2025 in the Library Roomn 6th floor, Bharat Sanchar Bhawan, Janpath, New Delhi. The following were present in the meeting:

PGM (SR) welcomed all members from the management and new member from staff side. Thereafter, Chairman who joined the meeting online welcomed all participants. It was once again intimated that pay scales proposed in November 2022 can only be offered by Management. Staff side was informed that these scales are already intimated to D0T by other section.

GS, BSNLEU once again referred to three points submitted in the meeting held on 30.6.2025.

GS, NFTE stated that staff side is hopeful to sign agreement, if the demands submitted on 30.6.2025 are considered.

2.1 Discussions held on 01.09.2025

Management Side:

- 1. Demands of staff side has been captured in MOM held on 30.6.2025
- 2. Pay scales of November 2022 can only be offered.
- 3. Fitment should be at 0%

Staff Side

- 1. Fitment should be at par with executives.
- 2 Shorter pay scales accepted by them in the present wage revision, must not be taken as the basis for the revision of pay scales in the next wage revision. Assurance to this effect must he provided by the Management.

2.2 Discussions held on 03.09.2025

Management Side

1. Pay scales of November 2022 can only be offered.

In the last wage revision, the pay scales of executives were approved before agreement on wage revision of Non-executives. Therefore, the agreement cannot be signed at this stage as it does not comply with DOT instructions dated 27.4.2018 read with Para 2 (iv) of DPE guidelines dated 24.11.2017.

Staff Side

stated that it is ready to accept the pay scales offered in November 2022. However.

- 1. Fitment should be at par with executives.
- 2. Pay loss may be protected.
- 3. There should not be any stagnation in 2026 & 2027.
- 4. Shorter pay scales accepted by them in the present wage revision, must not be taken as the basis for the revision of pay scales in the next wage revision. Assurance to this effect must be provided by the Management.

Vote of thanks was conveyed by Sr. GM & CLO (SCT).

Regarding revision of pension of BSNL/MTNL pensioners

In the High Court of Delhi at New Delhi, Shri Rakesh Jain, ACCA, DOT filed additional Affidavit on behalf of Petitioner on 19.8.2025

The Present affidavit is being filed to bring on record subsequent developments on the issue under consideration in the present matter.

Bharat Sanchar Nigam Limited (BNL) was formed on 1.10.2000 by conversion of the erstwhile department of teleecom. Services (DTS) and department of telecom. Operations (OTO) into a public sector undertaking (PSU). The government employees in these two Departments were first transferred en-masse to BSNL on deemed deputation basis. These employees were later given option to either continue to be in Government Service or to seek permanent absorption in BSNL. Those employees who opted for absorption in BSNL, Presidential Orders were issued in their favour laying down comprehensive terms and conditions of their absorption in BSNL with effect from 01.1,0.2000 in accordance with Rule 37-A of CCS (Pension) Rules, 1972. The absorbed employees of BSNL were given higher IDA pay scales as compared to their counter parts in Government Service receiving CDA pay scales.

- 4:- After absorption in BSNL, these employees ceased to be Government servants and they were deemed to have retired from Government service from the date of their absorption as per Sub-rule 4 of Rule ibid. The absorbed employees of BSNL, who retired or retiring after 01.10.2000 are getting pension and dearness relief thereon in IDA pattern as per Rule 37 (16) of CCS(Pension) Rules, 1972.
- 5. The Answering Respondent respectfully submits that the case of the Respondents is inter alia that even though there is no change in the pay scale, they are never the less entitled to an enhancement in pension. The Respondents inter alia base their case on the OM dated 12.05.2017 which was issued pursuant to the 7th CPC. As submitted herein before, the Respondents herein are not government servants and the CPC

recommendations are ipso facto not applicable to them. The Respondent being ex-employees of BSNL were governed by the pay scale provided for in the IDA pattern and not the CDA pattern. Contrary to the case of the respondent the OM dated 12.5.2017 has been issued in continuation of the OM dated 04.08.2016 providing for the various options for pensioners benefits for Government Servants only.

6. It is respectfully submitted however, that the Respondents herein had in fact filed an Original Application before the Ld. CAT at Ernakulam seeking the extension of the benefit of OM dated 12.05.2017 to them. The aforementioned OA was titled, All India BSNL Pensioners Welfare Association and Shri. P. Vadivel (DoB - 18.11.1942, DoE- 19.7.1962 & DoR -30.11.2002) bearing OA No.180/00346/20 18 with following prayer:

"To direct the respondents to extend to the pre-2006 DoT absorbed BSNL IDApensioners, the benefit of Annexure-5 OM (DoPPW OM dated 12.05.2017), revise their pension by applying the pension formula of 50% of the last pay drawn or 50% of the last ten month average pay which ever is advantageous to them and disburse all the consequential benefits to them with arrears and interest."

7. Without prejudice to the submission of the Petitioner that on this ground alone the OA before the Ld. Tribunal at Delhi was not maintainable, and should have been rejected on that ground alone, by judgment and order 30.10.2109 Ld. CAT Ernakulam Bench the aforementioned OA was rejected. Copy of Order dated 30.10.2019 in OA No.180/00346/20 18 is annexed herewith and marked as Annexure - P1.

Aggrieved thereby, the Respondents herein challenged the said order before the Hon'ble High court of Kerala vide OP No. 60/2020 which was partially allowed vide judgment dated 7.2.2025. Copy of judgment dated 7.2.2025 in OP No. 60/2020 is annexed herewith and marked as Annexure - P2.

9. The Union of India, thereafter challenged the said Order before the Hon'ble Supreme Court vide SLP bearing Diary No. 39478/2025. When the matter was taken up before the Hon'ble Supreme Court it was brought to its attention that clarifications dated 17.07.2018 and 27.03.2025 have been issued by DOP&PW which unambiguously and expressly stated that the OM dated 12.05.2017 had no application whatsoever to IDA pensioners such as the Respondents herein. The relevant portion of the said clarification dated 17.07.2018 is reproduced hereunder:

"It is correct that the OMs dated 04-08-2016 and dated 12-05-2017 issued by this Department for revision of pension w.e.f 01-01-2016 are applicable to Central Government Civil Pensioners drawing pension on CDA pattern and are not applicable to the BSNL absorbee pensioners getting pension under IDA pattern. It may be stated that similar orders issued by this Department for revision of pension of Central Govt. Civil Pensioners based on the recommendations of 6th Central Pay Commission were also not applicable to the BSNL absorbee pensioners under IDA pattern. However, DoT had issued separate orders for revision of pension of the absorbee pensioners of BSNL w.e.f 01-01-2007 based on the recommendations 2nd Pay Revision Committee.

In its subsequent clarification dated 27.3.2025 also, DoP&PW has re-iterated that - "Vide DoP&PW OM dated 17.7.2018, it has already been clarified that the OM dated 12.5.2017 issued by DoP&PW for revision of pension w.e.f. 1.1.2016 are applicable to Central Government civil Pensioners drawing pension on CDA pattern and are not applicable to the BSNL absorbee pensioners getting pension under IDA pattern."

Further, it is also submitted that the IDA Pay Scales applicable in BSNL are revised by the Deptt of Public Enterprises, Ministry of Finance for all the Central PSUs through a separate mechanism of Pay Revision Committee(PRC); which is different from the Central Pay Commission. As the Pension is the derivative of the Pay, so after revision of the IDA Pay Scales, revision of Pension of IDA Pensioners is examined separately by the Administrative Ministry. Therefore, OM dated 12.5.2017 issued by DoP&PW regarding revision of pension of CDA Pensioners is not applicable to the BSNL absorbee combined service IDA Pensioners.

Copies of OMs dated 17.07.2018 and 27.03.2025 issued by DoP&PW are annexed herewith and marked as ANNEXURE - P3 &P4.

10. Keeping in mind the aforesaid, the SLP was withdrawn with liberty to approach the Hon 'ble High Court of Kerala and place the said clarification for its consideration in as much as, the said clarification was admittedly not before it when the Order/Judgment dated 07.02.2025 was passed. Liberty was further given to approach the Hon'ble Supreme Court in case the Union was aggrieved by any orders passed by the Hon'ble High Court subsequent thereto. Copy of order dated 08.08.2025 of the Hon'ble Supreme Court is annexed

herewith and marked as Annexure - P5.

The aforementioned subsequent developments as well as clarification dated 27.3.2025 are being placed on record for the consideration of this Hon'ble court. The petitioner respectfully submits that the contentions of the respondents that they are in anyway entitled to the benefit of OM dated 12.5.2017 is completely negated once again in view of the express and unambiguous contents of the clarification dated 27.3.2025.

It is pertinent to mention that the DoP&PW's OM dated 12.05.2017 is in continuation of their OM dated 04.08.2016. Para 7(a) of the letter clearly indicates that when the Goven1ment servant on permanent absorption in PSUs continue to draw pension from the Government separately, the pension of such absorbees will be updated in terms of these orders. Accordingly, para 12 of the OM dated 12.05.2017 is applicable for the pensioners who are drawing monthly pension from the government on permanent absorption in PSUs on pro rata basis in CDA pattern based on their service in Government only. Therefore, OM dated 12.5.2017 issued by DoP&PW consequent to recommendations of the 7th central pay commission (CPC) revising the pension/family pension of ex-government employees are not applicable to the applicants.

The Para No. 4 & 12 of the OM dated 12.5.2017 cannot be read in isolation, withour understanding the subject, and the context. And the subject of this OM makes it very clear that it is related to the seventh central pay commission and the context is revision of pension. Even the exhibit attached with the OM as Annexure-1 mentions only the central pay commissions (CPCs) only. So, its clauses cannot be made applicable to anybody who is not covered under central pay commission like the IDA pensioners. Therefore, OM dated 12.5.2017 issued by DoP&PW regarding revision of pension is not be applicable to BSNL absorbee penswners.

Respected Sir,

We wish to bring into your notice the abnormal delay in settlement of grievances of the following pensioners. Three of them were included in the Agenda of Quarterly meeting with PWAS.

1. Smt. Vijayalaxmi Eknath Jadhav wife of late E. A. Jadhav retred as Sr. SDE Coaxial Belagavi, South Telecom Region. Old PPO No. TA/C-203/Pension/9-299 New PPO no on migration 401995082145471.

The Family pensioner had submitted her grievance regarding less drawal of Family pension for the months from August 2024 to March, 2025 in Pension Adalat held at Pune on 25.03.2025. it was then intimated that being a transfer case, the case will be forwarded to Tamilnadu Circle.

As Family pensioner approached us, we submitted her grievance through our Agenda submitted for the meeting with PWAs held on 28th May, 2025. It was observed that her grievance of less drawl of pension raised in Pension Adalat, was not settled as yet. **Moreover she has not received the monthly pension from March, 2025 onwards.**

2. Smt Sanjiwani Purushottam Argade wife of late Purushottam R. Argade, expired on 6.11.2016, was receiving Family pension from Model Colony Sub Post office, Pune(Account No 7710603721) prior to migration.

On migration to SAMPANN on 22nd August 2022, her DLC was not accepted and Pension was stopped.

Family pensioner approached us. It was observed that the her Family pension was migrated in favor of pensioner Purushottam R. Argade with new PPO No. 401991011036113.

Her grandson addressed a mail (<u>nimisharg 30@yahoo.in</u>) on 15.04.2024 to Accounts Officer(Pension) (cca.mhgoa@gmail.com) requesting to update Mobile no and other information as per KYP and credit the arrears for the months from December, 2023 and January, 2024 with attachments the following documents .

- 1. KYP Form, 2 Copy of Aadhar Card, 3. Copy of PAN Card
- 3. First Pension Order / Old PPO
- 4. Death Certificate of Late Shri Purushottam R Argade

Thereafter, She was receiving the Family pension up to February, 2025 regularly. Her Family pension is again stopped from March, 2025. She submitted the DLC on 24.03.2025, but the same was not accepted.

On query with Accounts Officer (PDA), It is told and confirmed from the pensioners details in SAMPANN that it shows the data of pensioner "Purushottam Ramchandra Argade" only. Therefore the DLC in favor of Sanjiwani Purushottam Argade is not updated and Family pension is held up.

It is necessary to update the data in SAMPANN in favour of Smt. Sanjiwani Purushottam Argade, the Family pensioner. Mobile No. 9975526495. So that her DLC submitted by the Family pensioner on 24.03.2025 would be accepted and Family pension would be drawn.

The copies of the above documents are attached herewith for ready reference.

- 3. Grant of Notional Increment case of Shri. S.S.Bhosale PPO No. 402022031211792. We brought into notice his case through our Agenda submitted for the meeting held on 28th May, 2025. AGM(Admn) O/O GMTD, Solapur has submitted all the required documents vide letter dated 03/06/2025. The revision of pension after taking one notional increment is not authorized as yet.
- 4. Shri C. C. Amdare, CAO, Retd. PPO No. 402008081206534. His Commuted portion of pension was restored in August, 2023. But the amount of commuted pension was deducted from the monthly pension of July 2024 and August, 2024. He applied for the refund of the amount of on 2/08/2024 but the effect is not given in the month of August, 2024.

We raised the issue through our Agenda for the meeting with PWAs held in September, 2024. He again represented the grievance on 14/09/2024 to draw the pension for September, 2024 taking into account the

refund of Rs. 7130/- Copy of order for revision of pension showing the dates of restoration is attached herewith for ready reference.

Sir, We hereby request you to look into the matter and arrange to settle these pensioners grievances Thanking you, With regards!

Sub: issue a common order based on the order of ITAT Chandigarh Bench and to refund the excess TDS recovered from the retirees by BSNL and paid to the Income Tax department to avoid rejection of such claims by the concerned A.Os.

We AICGPA,HQ ,Pune Indentified Pensioners Association by DOP&PW, representing DoT/BSNL pensioners would like to draw your kind attention towards the order of Income Tax Appellate Tribunal Division Bench, 'SMC' Chandigarh dated 30.05.2025 in the case of Shri Harish Kumar, a BSNL VRS 2019 retiree vs The ITO, Ward 5(5), Chandigarh. (A copy the order is attached herewith for ready reference), wherein it has been ruled that "when the claim of the Assessee relating to the first installment has been accepted by the Ld. CIT(A), there was no question to reject the claim of the Assessee in relation to second installment of compensation received by the Assessee".

Earlier too, several IT tribunals/courts had held that an assessee retired under a VRS scheme is entitled to the exemption under Section 10(10C) of the Act and also rebate under Section 89 of the Act in respect of the amount received in excess of Rs. 5,00,000 on account of voluntary retirement. But BSNL authorities refused to allow the rebate under Section 89 of the IT Act and recovered TDS for the entire ex-gratia less the relief of Rs.5,00,000.

Now, as per the above order, there is specific order in respect of a BSNL VRS 2019 retiree has been issued by the Income Tax Appellate Tribunal Division Bench, 'SMC' Chandigarh, all the similarly placed BSNL retirees who received the ex-gratia in two installments in two different years will start submitting requests, claiming the rebate under Section 89 of the Act, as per ITAT Chandigarh Bench order.

We, therefore request you to arrange to issue a common order based on the order of ITAT Chandigarh Bench and to refund the excess TDS recovered from the retirees by BSNL and paid to the Income Tax department to avoid rejection of such claims by the concerned A.Os.

पेन्शन अदालत श्रीमती जयती समदर, महाव्यवस्थापक (वित्त), सीपीएमजी महाराष्ट्र मंडळ मुंबई यांच्या अध्यक्षतेखाली दिनांक १५.०९.२०२५ रोजी रात्री ११.४५ वाजता आयोजित करण्यात आली. श्री रामचंद्रन, वरिष्ठ लेखा अधिकारी हे देखील उपस्थित होते. प्राप्त व निकाली काढलेल्या प्रकरणांची सविस्तर माहिती असलेले कार्यवृत्त लवकरच प्रसिद्ध केले जाईल.

पेन्शन अदालतनंतरची बैठक : एच. एफ. चौधरी (महासचिव) आणि के. एस. कुलकर्णी (सहायक महासचिव) यांनी महाव्यवस्थापक (वित्त) यांच्याशी स्वतंत्र बैठक घेतली.

सर्वप्रथम, मार्च २०२५ मध्ये झालेल्या पेन्शन अदालतमध्ये चर्चेप्रमाणे अधिसूचनेतील आवश्यक दुरुस्त्या केल्याबद्दल आम्ही महाव्यवस्थापक (वित्त) यांचे आभार मानले व खालील प्रमुख मुद्दे मांडले.

- १. पेन्शन अदालतच्या अधिसूचनेमध्ये अर्ज ईमेलद्वारे स्वीकारले जातील याचा स्पष्ट उल्लेख असावा.
- २. पेन्शनअदालत व आज होणाऱ्या बैठकीचे वृत्तांत पाठविण्यात यावे.
- ३. आम्ही माहिती दिली की, डीओपी अँड पीडब्ल्यू, नवी दिल्ली यांच्या निर्देशानुसार विभागीय पातळीवर पेन्शन अदालत नियमितपणे आयोजित केली जाते. उदाहरणार्थ, आमच्या सचिवांकडून मिळालेल्या माहितीनुसार नागपूर क्षेत्रीय कार्यालयाने या वर्षी पेन्शन अदालत आयोजित केलेली नाही.

- ४. ओटीबीपी/बीसीआरसाठी प्रशिक्षण कालावधीची गणना करण्यासंबंधी प्रकरणे विभागीय स्तरावर प्रलंबित आहेत, कारण संबंधित कर्मचाऱ्यांची सेवा पुस्तिका उपलब्ध नाही. उदाहरणार्थ, श्री बी. जे. आंबळकर, सेवानिवृत्त पोस्टमास्तर, एचएसजी, यवतमाळ यांचे प्रकरण प्रलंबित होते. त्यांना सेवा पुस्तिका सापडत नसल्याचे कळविण्यात आले होते.

वरिष्ठ लेखा अधिकाऱ्यांनी माहिती दिली की श्री आंबळकर यांचे प्रकरण विभागाकडून निकाली काढण्यात आले आहे. आम्ही यावर प्रतिक्रिया दिली की, अशा सर्व प्रलंबित प्रकरणांचा निपटारा करावा आणि सेवा पुस्तिका उपलब्ध नसल्यामुळे प्रकरणे प्रलंबित ठेवू नयेत. महाव्यवस्थापक (वित्त) यांनी आमच्या मताशी सहमती दर्शवली.

५. सांगली शाखेच्या सिचवांनी उल्लेख केलेल्या एनपीएस ते ओपीएस रूपांतरणाच्या प्रकरणांची माहिती देण्यात आली. सद्यस्थितीत उपलब्ध मार्गदर्शिकेशी जुळत नसल्यामुळे ही प्रकरणे डाक संचालनालयाकडे स्पष्टीकरणासाठी पाठविण्यात आली आहेत.

उदाहरणार्थ – श्री. व्ही. ए. पवार, माजी पोस्टमन, ३०.०९.२०१८ रोजी निवृत्त झाले. त्यांना दिनांक १७.०२.२०२० रोजीच्या संचालनालयाच्या आदेशानुसार ओपीएस अंतर्गत पेन्शन देण्याचे कळविले आहे. दिनांक १७.०१.२०२४ रोजीच्या एनपीएस ते ओपीएस पत्रानुसार, पीएसएला ६०% कॉर्पस म्हणजेच ५, ५०, ५८३.७१ रुपये वसूल करण्यास सांगितले होते. पेन्शनरला १३.०९.२०२४ रोजी पीपीओ जारी करण्यात आला. तथापि, श्री. पवार यांनी पेन्शन थकबाकीतून रक्कम वसूल करण्याची विनंती केली. म्हणून यावरील मार्गदर्शक सूचनांसाठी प्रकरण डाक संचालनालयाकडे पाठविण्यात आले आहे. आम्ही जीएम फायनान्स यांना प्रकरणाचा निपटारा जलदगतीने करण्याची विनंती केली आहे.

मुख्य पोस्ट मास्तर जनरल, महाराष्ट्र परिमंडळ यांच्याशी भेट: आम्ही श्री अमिताभ सिंग, सीपीएमजी यांच्याशी १० मिनिटांची भेट घेतली. त्यांनी स्कोवा बैठकीत झालेल्या चर्चेची माहिती आणि मंडळस्तरीय पेन्शन अदालतचा निष्कर्ष विचारला. आपल्या असोसिएशन तर्फे नाशिक येथे १२.१०.२०२५ रोजी आयोजित खुल्या सत्रात उपस्थित राहण्याच्या विनंतीवर त्यांनी सकारात्मक प्रतिसाद दिला आणि आमंत्रण पाठवावे असे सांगितले. महाव्यवस्थापक (वित्त) आणि सीपीएमजी यांच्याशी झालेल्या दोन्ही बैठकीत अत्यंत सौहार्दपूर्ण चर्चा झाली.

चंदीगड येथील आयकर न्यायाधिकरणाने व्हिआरएस-२०१९ अंतर्गत निवृत्त झालेल्या कर्मचाऱ्यांना इन्कम टॅक्स परताव्या बाबत निकाल: ३०-०५-२०२५ रोजी चंदीगड येथील आयकर न्यायाधिकरणाने (Tax Tribunal) व्हिआरएस-२०१९ अंतर्गत निवृत्त झालेल्या कर्मचाऱ्याला Ex-gratia जी रक्कम मिळाली आहे. त्या रकमेतून कापलेला आयकर परतफेडीबाबत एक निकाल देण्यात आला आहे.

न्यायाधिकरणाने त्यांच्या निकालात म्हटले आहे की, खरं तर, करदात्याला मिळालेल्या अशा रकमेचा कोणताही भाग करपात्र नाही. म्हणून, आम्ही करदात्याचे अपील मान्य करतो आणि आम्ही पुढे असे मानतो की करदात्याने दावा केलेल्या वरील भरपाईच्या संदर्भात भरलेल्या कराचा परतावा/समायोजन करण्याचा करदात्याला हक्क आहे.

न्यायाधिकरणाच्या वरील निकालानुसार, व्हिआरएस-२०१९ अंतर्गत निवृत्त झालेल्या कर्मचाऱ्याला Ex-gratia म्हणून मिळालेल्या रकमेतून आयकर कापण्यात आला असेल तर त्याचा परतावा मिळणार आहे. तो निकाल फक्त ज्या कर्मचाऱ्यांनी Tax Tribunal कडे अर्ज केला होता त्यानाच लागू आहे.

या निकालाबाबत आपल्या असोसिएशन च्या केंद्रीय कार्यकारिणी तर्फे चर्चा करण्यात आली. त्यात असे ठरले की चंदिगड Tax Tribunal चा निकाल असल्यामुळे तो सर्वाना आताच लागू होणार नाही. म्हणून ह्याबाबत आपल्या असोसिएशन तर्फे Chairman CBDT, New Delhi ला दिनांक २५ जुलै २०२५ रोजी पत्र पाठविण्यात आले.

जोपर्यंत सरकारकडून हा निकाल तत्सम कर्मचाऱ्यांना लागू करण्याबाबत आदेश येत नाही, तोपर्यंत वाट पहावी लागणार आहे. असे ही ठरले की.. ज्या सभासदांना या निकालाचा फायदा होऊ शकतो, त्यांनी आपापल्या सी ए (Chartered Accountant) शी संपर्क साधावा. त्यांचेमार्फत आधिचे इन्कम टॅक्स रिटर्न सादर केले असल्यामुळे ते आपणास जरूर सहाय्य करतील.

बीएसएनएल नॉन एक्झिक्युटिव्ह कर्मचाऱ्यांचे वेतन सुधारणेबाबत:

आपणास कल्पना आहे. बीएसएनएल मधे सामील झालेल्या सेवानिवृत्ताचे पेन्शन रिव्हीजन चे प्रकरण दिल्ली हायकोर्टात प्रलंबित आहे. अशा परिस्थितीत बीएसएनएल कर्मचाऱ्यांचे वेतन सुधारणेसाठी सुरू असलेल्या वाटाघाटीचा आढावा घेणे महत्वाचे आहे.

६ ऑगस्ट २०२५ रोजी सीएमडी बीएसएनएल आणि कर्मचारी संघटनांच्या पदिधकारी यांच्यात विविध ज्वलंत मुद्द्यांवर महत्त्वाची बैठक झाली. त्या बैठकीत तिसऱ्या वेतन सुधारणा सिमती (3rd PRC) अंतर्गत वेतन सुधारणेबाबत सुरू असलेल्या वाटाघाटीच्या मुद्द्यावर चर्चा करण्यात आली. ३०.०६.२०२५ रोजी झालेल्या वेतन वाटाघाटी सिमतीच्या बैठकीत नॉन एक्झिक्युटिव्ह कर्मचाऱ्यांच्या मान्यताप्राप्त संघटनांनी त्विरत करार करण्याची उत्सुकता दर्शविली होती. वेतन वाटाघाटी सिमतीच्या बैठकीत झालेल्या चर्चेदरम्यान, कर्मचारी पदाधिकारी गटाने फिटमेंट फॉर्म्युला आणि स्थिरतेच्या समस्यांवर मात करण्यासाठी ४ वेतनश्रेणी अपग्रेड करण्याबाबत विचार मांडले होते. परंतु, तेव्हापासून औपचारिक बैठक झालेली नाही हे दुर्दैवी आहे. याबाबत सीएमडी बीएसएनएल यांनी तात्काळ हस्तक्षेप करून लवकरात लवकर वेतन सूधारणेबाबत करार करावा अशी विनंती करण्यात आली. यावर सीएमडी बीएसएनएल यांनी सकारात्मक प्रतिसाद दिला, त्यानुसार त्यांनी संचालक (एचआर) यांना योग्य ती कारवाई करण्याचे निर्देश दिले.
