#### **GS Speaks:**

On behalf of CWC members, I am happy to announce that 69thAGM of our Association will be held on 21st October, 2021 at Phadake Hall, 1785 Sadashiv Peth, Pune 411030. The Notice for AGM was issued on 25th August, 2021 and dispatched to all Branch Secretaries for circulation amongst the members, Office bearers and Organizing Secretaries. The meeting will be organized with subject to government rules applicable at the relevant time. We are bringing out a Multicolour Calender-2022 on the occasion of celebration of 75th year of our Association. You may contribute for the Advertisement with Best compliments for the celebration of 75th year. All Secretaries/Members are requested to cooperate to hold the AGM at grand success.

Government has issued the order for granting the DA to central Govt. pensioners at the rate of 28% subsuming the additional instalments due from 01.07.2020, 01.01.2021 which were feezed. In respect of BSNL pensioners also, MOF, DPE has issued the order for granting IDA at the rate of 170.5% subsuming the instalments arising on 01.10.2020, 01.01.2021 and 01.04.2021. These rates are applicable from 1st July, 2021. The orders for the additional instalment due from 01.07.2021 are expected soon.

Keeping in view that the Central Govt. Employees who retired during the period from 01.01.2020 to 30.06.2020 have been allowed lesser amount of DA and the gratuity and cash payment in lieu of leave are one time retirement benefits admissible, Govt decided that in respect of employees who retired from 01.01.2020 to 30.06.2020 will get notional DA @21%, employees who retired from 01.07.2020 to 31.12.2020 will get notional DA @24% and employees who retired from 01.01.2021 to 30.06.2021 will get notional DA @28% for the calculation of gratuity and leave encashment. Such order is expected for BSNL employees, who retired from 01.10.2020 to 30.06.2021.

Hon'ble GAUHATI HIGH COURT in Writ Petition(C) 4224/2016 vide ORDER dated 15.03.2018 held that the additional quantum of pension as per Section 17B of the Act in the first slab(From eighty years to less than eighty five years) would be available to a retired judge from the first day of his 80th year in stead of on completion of the 80 years of age. Hon'ble Supreme Court dismissed Special Leave Petition (Civil) Diary No. 18133/2019 dt 8.09.2019. BPS has

addressed a letter requesting to implement the said judgment in case of all similarly placed persons and amend Para 4 of DOP&PWNo.38-37-08-PPW(A)-11.08.2009 accordingly.

Department of Posts has modified the procedure regarding separate pension account If any pensioner wants to get pension through Post Office Saving Accounts the Pension Disbursing authority has to ensure that Saving account provided by the pensioner is either a single Savings Account in his/her name or a joint account opened with his/her spouse.

You may be aware that we had addressed for the letter to CMD BSNL to extend the concessional FTTH/BHARAT Air Fibre connection to the serving/retired employees. We are happy to inform that BSNL Corporate office issued the Circular dated 5.07.2021 to grant 40% Concession on plan charges subject to ceiling of Rs. 300 in respect of FTTH/BHARAT Air Fibre connection to the serving/retired employees.

While welcoming new Hon'ble Minister Of Communications, Shri Ashwini Vaishnaw ji, we have brought into his notice the long pending issues in respect of BSNL pensioners i.e. Anomaly in the pension of DOT employees absorbed in BSNL and retired between 01.10.2000 and 30.06.2001. Nonpayment of Medical Bills / Medical Allowance to DOT employees absorbed and retired from BSNL and Revision of Pension with effect from 01.01.2017.

#### Rajya Sabha Unstarred Question No. 430 asked by Shri. Neeraj Dangi, to be answerd on 22.07.2021 Calculation of Commuted Pension

Will the **PRIME MINISTER** be pleased to state:

(a) the formula for calculating the commuted pension for employees of Union Government while deciding the recovery period of commuted pension for employees; (b) the rate of interest for FD, when 14 year was decided as the recovery period for commuted pension of employees; (c) whether this recovery period is justified in the present scenario when the rate of interest for FD is 5-6 per cent only, if so, the details thereof; and (d) whether Government is willing to revise this period of recovery of commuted pension, if so, by when and if not, the reasons therefor?

# ANSWER : MINISTER OF STATE IN THE MINISTRY OF PERSONNEL, PUBLIC GRIEVANCES AND PENSIONS AND MINISTER OF STATE IN THE PRIME MINISTER'S OFFICE. (DR. JITENDRA SINGH)

(a) to (d): The lump sum commuted value of pension payable to a pensioner, who applies for such commutation, is calculated in accordance with the Table of the values appended to the Central Civil Services (Commutation of Pension) Rules, 1981. A copy of the Table, presently applicable for calculating the commuted value of pension, is at Annexure. The commuted amount of pension is restored on completion of 15 years from the date the reduction of pension becomes operative.

The existing Table of the values for calculation of lump sum commuted value of pension was incorporated in the Central Civil Services (Commutation of Pension) Rules, 1981 in implementation of the recommendations of the Sixth Central Pay Commission vide Department of Pension & Pensioners' Welfare O.M. No. 38/37/08-P&PW(A) dated 2nd September, 2008. This Table is based on LIC (94-96) Ultimate Tables and rate of interest of 8%. While recommending the aforesaid Table, the Sixth Central Pay Commission did not recommend any change in the period of 15 years for restoration of commuted pension. The Seventh Central Pay Commission also did not recommend any change in the said period for restoration of commuted pension.

Hon'ble High Court of Delhi, vide order dated 17.01.2019, dismissed a Writ Petition No. 1222/2015 seeking reduction in the period for restoration of commuted pension. An SLP(C) No. 8852/2019 filed against the said order of Hon'ble High Court of Delhi was also dismissed by Hon'ble Supreme Court on 15th April, 2019. At present, in view of the above, there is no proposal to revise the period of restoration of commuted pension.

#### RAJYA SABHA UNSTARRED QUESTION NO. 2045 (TO BE ANSWERED ON 05.08.2021) NOTIONAL INCREMENT FOR PENSIONERS

#### ANSWER

#### MINISTER OF STATE IN THE MINISTRY OF PERSONNEL, PUBLIC GRIEVANCES AND PENSIONS AND MINISTER OF STATE IN THE PRIME MINISTER'S OFFICE

#### (DR. JITENDRA SINGH)

(a): CAT, Allahabad Bench in its Order dated 26.2.2021 in O.A. No.330/00146/2020 has, interalia, observed that the matters relating to pay fixation are governed by uniform policy of the Government and therefore any judgment in these matters are always in rem and cannot be interpreted as judgment in personam.

Department of Revenue, Respondent No. 1, has informed that the Order dated 26.2.2021 in O.A. No.330/ 00146/2020 has been challenged vide Writ Petition WRIA 7911/2021 before Allahabad High Court, Allahabad.

(b): Several judgments/orders on the matter of grant of notional increment to those Central Government servants who have retired on 30" June/31\*' December, have been pronounced by Courts/CATs. The order dated 23.07.2018 and dated 08.08.2019 of the Supreme Court relating to the judgement dated 15.09.2017 of High Court of Madras in W.P. No.15732 of 2017 in case of P. Ayyamperumal was considered as 'in personam' and not 'in rem'.

On the other hand, in a similar case on the same subject matter, vide judgement dated 29.03.2019, while dismissing the SLP(C) Dy. No.6468/2019 in the case of Uol vs. Sakha Ram Tripathi, the Supreme Court has kept the questions of law open.

Further, in the matter of Ministry of Railways wherein CAT, Bengaluru Bench have allowed grant of notional annual increment to an employee who superannuated from service on 30.06.2014, the Supreme Court, in SLP(C) No.4722/2021, vide order dated 05.04.2021, has stayed operation of the said Order dated 18.12.2019.

#### No. 42/07/2021-P&PW(D), Dated : 22th July 2021, from Government of India, Ministry of Personnel, Public Grievances & Pension, Department of Pension & Pensioners Welfare, New Delhi 110003 Subject : Revised rates of Dearness Relief to Central Government Pensioners/Family Pensioners w.e.f. 01.07.2021

The undersigned is directed to refer to Ministry of Finance (Department of Expenditure) Office Memorandum No. 1/1/2020-E-II(B), dated 23.04.2020, vide which instalments of Dearness Relief to pensioners/family pensioners due from 01.01.2020, 01.07.2020 and 01.01.2021, were frozen and to say that the President is pleased to decide that the Dearness Relief admissible to Central Government pensioners/family pensioners shall be enhanced from the existing rate of 17% to 28% of the basic pension/family pension (including additional pension/family pension) with effect from 1<sup>st</sup> July 2021. The increase subsumes the additional instalments arising on 01.01.2020, 01.07.2020 and 01.01.2021. The rate of Dearness Relief, earlier determined vide this Department's OM No. 42/04/2019- P&PW(D) dated 21.10.2019, shall remain at 17% of basic pension/family pension for the period from 01.01.2020 till 30.06.2021.

2. These rates of Dearness Relief will be applicable to:

i. Civilian Central Government Pensioners/Family Pensioners including Central Government absorbed pensioners in PSU/Autonomous Bodies in respect of whom orders have been issued vide this Department's OM No. 4/34/2002-P&PW(D) Vol. II dated 23.06.2017 for restoration of full pension after expiry of commutation period of 15 years.

ii. The Armed Forces pensioners/family pensioners and Civilian pensioners/ family pensioners paid out of the Defence Service Estimates.

#### **Government Order**

- iii. All India Services pensioners/family pensioners.
- iv. Railway pensioners/family pensioners.
- v. Pensioners who are in receipt of provisional pension.

vi. The Burma Civilian pensioners/family pensioners and displaced pensioners/family pensioners from Pakistan, in respect of whom orders have been issued vide this Department's OM No. 23/3/2008-P&PW(B) dated 11.09.2017.

- 3. The payment of Dearness Relief involving a fraction of a rupee shall be rounded off to the next higher rupee.
- 4. Other provisions governing grant of Dearness Relief in respect of employed family pensioners and reemployed Central Government Pensioners will be regulated in accordance with the provisions contained in this Department's OM No. 45/73/97-P&PW (G), dated 2.7.1999, as amended from time to time. The provisions relating to regulation of Dearness Relief where a pensioner is in receipt of more than one pension will remain unchanged.
- 5. In the case of retired Judges of the Supreme Court and High Courts, necessary orders will be issued by the Department of Justice separately.
- 6. It will be the responsibility of the pension disbursing authorities, including the nationalized banks, etc. to calculate the quantum of Dearness Relief payable in each individual case.
- 7. The offices of Accountant General and authorised Pension Disbursing Banks are requested to arrange payment of Dearness Relief to pensioners/family pensioners on the basis of these instructions without waiting for any further instructions from the Comptroller and Auditor General of India and the Reserve Bank of India in view of letter No. 528-TA, II/34- 80-II, dated 23/04/1981, of the Comptroller and Auditor General of India addressed to all Accountant Generals and Reserve Bank of India Circular No. GANB No. 2958/GA-64 (ii) (CGL)/81 dated the 21°\* May, 1981 addressed to State Bank of India and its subsidiaries and all Nationalised Banks.
- 8. In their application to the persons belonging to Indian Audit and Accounts Department, these orders are issued under Article 148(5) of the Constitution and after consultation with the Comptroller & Auditor General of India.
- 9. These issues in pursuance of Ministry of Finance, Department of Expenditure's OM No. 1/1/2020-E. I1(B) dated 20" July, 2021.

# No. 1 (5)/E.V/2020, Dated : 7th September 2021, from Government of India, Ministry of Finance, Department of Expenditure, New Delhi

# Subject : Central Government employees retired during the period from January, 2020 to June, 2021 calculation of Gratuity and Cash payment in lieu of Leave regarding.

The undersigned is directed to refer to this Ministry's O.M. No.1/1/2020-E.11(B) dated 23.04.2020, read with O.M. No.1/1/2020-E.II(B) dated 20.07.2021, in regard to payment of Dearness Allowance (DA) during the period from 01.01.2020 up to 30.06.2021 and to say that in terms thereof while the rate of DA during the said period shall remain at 17% of basic pay, the same has been enhanced to 28% of basic pay subsuming additional instalments arising on 01.01.2020(4%), 01.07.2020 (3%) & 01.01.2021(4%) payable w.e.f. 01.07.2021.

- 2. As per the existing provisions contained in Central Civil Services (Pension) Rules 1972, DA on the date of retirement or death is reckoned as emoluments for the purpose of calculation of gratuity. Also, as per the existing provisions contained in CCS (Leave) Rules 1972, pay admissible on the date of retirement plus DA on that are reckoned for the purpose of calculation of cash payment in lieu of leave.
- 3. In view of the provisions of the aforesaid orders of this Ministry dated 23.04.2020 and 20.07.2021, calculation of gratuity and cash payment in lieu of leave in respect of Central Government employees who retired on or after 01.01.2020 and up to 30.06.2021 are required to be made based on the rate of DA at 17% of basic pay.
- 4. Keeping in view that gratuity and cash payment in lieu of leave are one-time retirement benefits admissible to employees on retirement and employees who retired during the period from 01.01.2020 to 30.06.2021 have been allowed lesser amount than what would have been calculable but for the aforesaid orders of this Ministry dated 23.04.2020 and 20.07.2021, the matter has been considered sympathetically with a view to allowing the same to such employees.
- 5. Accordingly, the President is pleased to decide that in respect of Central Government employees who retired on or after 01.01.2020 and up to 30.06.2021, the amount of DA to be taken into account for calculation of gratuity and cash payment in lieu of leave will be deemed to be as under:

Employees retiring during the period	Notional Percentage of Dearness Allowance (DA) for calculation purpose
From 01.01.2020 to 30.06.2020	21% of basic pay
From 01.07.2020 to 31.12.2020	24% of basic pay
From 01.01.2021 to 30.06.2021	28% of basic pay

- All other conditions as stipulated in CCS (Pension) Rules 1972 and the orders of Department of Pension & PW vide O.M. No.7/5/2012-P&PW(F)/B dated 26.08.2016 in respect of employees borne on National Pension System (NPS) and CCS (Leave) Rules 1972, shall continue to be applicable while calculating gratuity and cash payment in lieu of leave respectively.
- 7. In their application to the persons belonging to India Audit and Accounts Department, these orders are issued under Article 148(5) of the Constitution and after consultation with the Comptroller and Auditor General of India.

# No. FS-14/1/2020, Dated : 4th August 2021, from Ministry of Communications, Department of Posts (F.S.Division), New Delhi

# Subject : Regarding withdrawal /Loan/closure / premature closure of account through authorized person.

This office is receiving various representations from the depositors that due to old age or illness they are unable to attend post offices for withdrawal or loan or closure or premature closure of their accounts.

- 2. Keeping in view of difficulties faced by the Senior Citizens or people suffering with illness, the issue was taken up with Ministry of Finance and keeping the provisions in Rule 1 of 'Government Savings Promotion General Rules-2018' in mind, competent authority has decided that in case of extreme exigencies (i.e. Senior Citizens or illness of account holder or suffering from physical infirmity or is with differently-abled conditions) the withdrawal or loan or account closure or premature closure may be allowed through authorized person.
- 3. Keeping in view of the safety of depositor's hard-earned money, the following procedure shall be followed for operation of account including withdrawal/loan/closure/premature closure of account through authorized person'

- i) The account holder(s) shall write an application in Form-12 to the postmaster concerned, for operation of account viz. withdrawal / loan / closure or premature closure of account etc.
- ii) In the application form (Form- I2), the depositor shall authorize a literate person for operation of his/her account.
- iii) Signature of the authorized person shall be attested by the account holder(sj. In case of Joint B Account, any one of the account holder(s) can attest the signature of the authorized person.
- iv) Authorized person shall not be an SAS/MPKBY agent or employee working in PO Savings Bank Branch in the post office concerned'
- v) The account holder shall fill the withdrawal form (sB-7) / closure form (sB-7A) / account premature closure form (SB-7B) / Application for Loan (SB7C) as the case may be in his/her writing and signed'
- vi) Self attested copy of ID and address proof of account holde\_r(s) and authorized person shall also be enclosed. If any account holder(s) authorize a person for more than one transaction viz. withdrawal / loan / closure, on any day, -in such case, only one Set of KYC documents and photo may be obtained. However. Form-I2 shall be obtained for each account'
- vii) Authorized person shall submit passbook, authority letter (Form- 12), withdrawal form (SB-7) / closure form (SB-7A) / account premature closure form (sB-7B) / Application for Loan (sB-7C) as the case may be and KYC documents of account holder and authorized person at concerned post office'
- viii) The counter PA shall tally signature of account holder(s) available in withdrawal form (SB-7) / account closure tbnn (SB-7A) / account premature closure form (SB-78) / Application for Loan (sB-7C) and Form-12 with signature available in Finacle and SB-3/AOF.
- ix) After tallying signature and documents, counter PA shall submit the case to Supervisor for approval.
- x) Supervisor shall also check and verity documents as well as signature of the account holder(s1 with office record and if he/she is satisfied' he/she shall write order on top of the application as "authorization accepted" and sign. xi)In case the postmaster is not satisfied about the genuineness of the request of the account holder, he/she may depute a responsible official to physically verify the request of account holder for withdrawal or loan or closure or premature closure of his/her account before effecting payment'
- xii) Thereafter, counter PA/Supervisor shall follow the process for withdrawal/Loan/Account closure/Account premature closure, as the case n-ray be as prescribed in the rules.
- xiii) The payment shall be made by account payee cheque or credit in to PO Savings Account or Bank Account of the account holder(s). No cash payment, irrespective of amount, shall be given to the authorized person except in case of withdrawal from Saving Account.
- xiv) Signature of authorized person should be taken in acquaintance part of withdrawal form (SB-7) / account closure form (SB-7A)/Account premature closure form (SB-7B) / Application form Loan (SB-7C). After closure of account, account payee cheque or ECS outward receipt, passbook shall be handed over to the authorized Person.
- xv) The authority letter (Form-12) along with KYC documents, are to be attached with the voucher and submitted to SBCO.
- xvi) SBCO branch shall check that no cash payment is made in cases of accounts closed by authorized persons irrespective of amount and all documents are in order.

Note:-PO Savings Account holders can avail Cheque/ATM/e-Banking/ m-Banking/IPPB Account linking facility to withdraw amount from their PO Savings Account as per their convienience. All the Post offices should provide Cheque/ATM/e-Banking/ m-Banking/IPPB Account linking facility to avoid inconvenience to account holders for SB withdrawal

- 4. It is further clarified that for submission of authorization letter in Form-12, physical presence of the account holder(s) is not mandatory. It can be accepted from the authorized Person also.
- 5. It is requested to circulate these amendments to all concerned for information, guidance and necessary action.

#### Subject : Clarification on Modified Assured Career Progression (MACP) Scheme reg.

This refers to various references received from administrative units and service associations seeking clarification on the following point of reference as to what will be the modalities for financial upgradation under MACP Scheme and pay fixation thereon, if a Central Govt. employee having availed the benefit of financial upgradation under MACP Scheme is promoted to Postman/Mail Guard or Postal/Sorting Assistant or Inspector Posts cadre (i.e. to the post which carry higher Grade Pay / pay Level in Pay Matrix than what is available under MACPS and have the element of direct recruitment) through Limited Department Competitive Examination (LDCE) immediate after availing the benefit of MACP, In terms of para-4, para-28(B)/27(B) of recent consolidated guidelines and DoP&T OM No. 35034/3/2015-Estt.(D) dated 08.09.2020.

2. The matter has been examined and it is clarified that if a Central Govt. employee who is promoted to either Postman/Mail Guard or Postal/Sorting Assistant or Inspector Posts cadre (i.e. to the post which carry higher Grade Pay / pay Level in Pay Matrix than what is available under MACPS and have the element of direct recruitment) through Limited Department Competitive Examination (I,DCE) immediate after availing the benefits of 1<sup>st</sup> financial upgradation under MACP Scheme (not TBOP/BCR Scheme), the benefit of 2nd financial upgradation under MACP Scheme (in the next Grade Pay w.r.t. Grade Pay / pay Level held by Government servant) shall be admissible to him/her on completion of 20 years service from direct entry grade in terms of para-28(B) of OM dated 19.05.2009 & para-27(B) of OM dated 22.10.2009, if otherwise, admissible and the employee fulfils the other eligibility conditions.

In such cases, fixation on such regular promotion immediate after availing the benefit of financial upgradation under MACP, shall be subject to the provisions of para'4 of the OM on MACP Scheme as this Directorate OM No. 20-27/2015-SPNII dated 20.08.2018 stands withdrawn vide OM No. 20-27/2015-SPN-II dated 29.06.2021). As such, no pay fixation benefit with increment would be available and only difference of grade pay would be available or shall be placed in the level to which he/she is promoted at a cell in the promoted level equa! to the figure being drawn by him/her on account of MACP. If no such cell is available in the level to which promoted, he/she shall be placed at the next higher cell in that level. Provided the Basic Pay on promotion to these posts where entry pay for direct recruits appointed on or after 01.01.2006, as per Section-II of Par-A of First Schedule of CCS (RP) Rules, 2008, becomes applicable by virtue of the provision of the element of direct recruitment in... the relevant recruitment rules, shall not be less than such entry pay w.e.f. 01.01.2006 in terms of D/o Expenditure OM No. 8-23/2017-E.IIIA dated 28.09.2018 as clarified vide DoP&T OM No. 35034/3/2015-Estt.(D) dated 08.09.2020. Further in 7 CPC pay structure, the pay cannot be less than the first stage of the relevant level to which promoted as provided vide Department of Expenditure OM No. 1-6/2016-IC dated 03.08.2017.

If a Central Govt. employee, who was appointed (direct entry) as Postal Assistant (in the corresponding scale to Grade Pay Rs.2400/-) on 01.09.1997 and - granted 1<sup>st</sup> financial upgradation under MACP Scheme w.e.f. 01.09.2008 (in Grade - Pay Rs.2800/-), earns 1st regular promotion through LDCE to Inspector Posts cadre on 01.09.2010 in Grade Pay Rs.4600/- / Level-7 and completes 20 years of service on 01.09.2017, the 2<sup>nd</sup> financial upgradation under MACPS in the Level-8 of Pay Matrix (in the next Grade Pay w.r.t. Grade Pay / pay Level held by Government servant) will be granted on completion of 20 years of service i.e. 01.09.2017. The modalities shall be as follows:-

The remaining pensioner's may continue to submit their Life Certificate from 1<sup>st</sup> November 2021 to 30th November 2021...
- 3. In view of the upcoming activity of submission of Digital Life certificate by pensioners to start from 1 Oct, 2021, it is requested to do the following :

a) Activate all the Jeevan Pramaan Centre IDs which are currently inactive in your respective Circle.

b) Establish the Jeevan Pramaan Centres in the Head Post Offices wherein it has not been established, get their Jeevan Pramaan IDs created and ensure that all Jeevan Pramaan Centre IDs as well as Common Service Centres (CSCs) are activated positively by 20<sup>th</sup> Sept, 2021.

- 4. The official guidelines from Department of Pension and Pensioner's Welfare (DoP&PW) regarding submission of DLCs when received shall be circulated in due course.
- 5. This issues with the approval of competent authority.

# No. 17/03/2021-P&PW(Coord)E7179, Dated : 6th August 2021, from Government of India, Ministry of Personnel, Public Grievances & Pension, Department of Pension & Pensioners Welfare, New Delhi 110001 Subject : Guidelines for timely and qualitative disposal of Pensioners' Grievances-reg.

The undersigned is directed to say that the Department of Pension & Pensioners' Welfare (DoPPW) has provided a single window interface for all Central Government pensioners to register their grievances pertaining to any of the Central Government Ministry/Department/Organisation, which is thereafter forwarded online to the concerned Ministry/Department/ Organisation for redressal through the CPENGRAMS Pertal. :

- 2. In 2019, Pensioners' grievance redressal system was expanded with the objective to provide easy access to pensioners who are living in remote areas and have no proper access to the Internet for registration of their grievances or not conversant with online technology. Accordingly, an Integrated Grievance Cell & Call Centre was inaugurated on 20th June, 2019 for pensioners enabling pensioners to register their grievance by calling on the toll free number 1800-11-1960. The Call Centre Executives register the grievance on CPENGRAMS, after taking inputs from pensioners, and thereafter it is forwarded to the concerned Ministry/ Department/Organization online for redressal. Department of Pension & Pensioners' Welfare also coordinates with different Ministries/Departments to resolve the grievances of the elderly pensioners and keep the pensioners informed about the progress of their grievances till disposal through this online system CPENGRAM.
- 3. The purpose of grievance redressal machinery is not only to allow easy access of Govt Machinery for pensioners but also disposal of the grievances expeditiously while maintaining the quality in redressal of the grievances. Keeping in view of the above objective, DoPPW has put in place a system of holding regular review meetings with Ministry/ Department/ Organization having large pendency of grievances. In order to ensure quality in disposal of Grievances, DoPPW is periodically analyzing closed Grievances and re-registering cases, wherever it is observed that Grievances were closed by the offices without taking appropriate final action. Though time and again specific guidelines/instructions have been issued to the Ministries, a need is felt to consolidate all instructions/guidelines and revise the time limit for redressal of grievances specially for the priority target groups i.e. family pensioners and super-senior pensioners in order to promote good governance and to ensure that the pensioners /family pensioners get their rightful entitlements.

#### All Ministries/Departments are advised to follow the guidelines given below for redressal of the Grievances

- i. In accordance with the Central Civil Services (Pension) Rules, 1972, every office is responsible for pension sanction, revision and payment of retirement benefits to its employees. Therefore, every grievance related to pension and other retirement benefits shall be redressed by the concerned office from where the employee retired or served before his/her death.
- ii. Every grievance shall be disposed of within the ambit of extant rules. In case of a grievance falling outside the ambit of rules, a speaking order shall be issued indicating the rule position.
- iii. All Ministries/Departments/Organisations shall strictly adhere to the time limit of 45 days to resolve the pensioners' grievances. If the grievance pertains to a family pensioner/super-senior\_pensioner (aged 80 years and above) the dead-line to resolve the grievance shall be 30 days.
- iv. Every grievance shall be closed only after its final resolution. If a grievance pertains to subordinate/attached office, the case may be forwarded by the Ministry/ Department to the concerned office but it should not be closed until final action is taken. The responsibility lies with the concerned Ministry/ Department to follow up the matter with subordinate/attached units for final resolution. Every Nodal Officer should undertake a weekly review of pending grievances in the portal.
- V. The grievance shall not be closed for the want of any documents from the pensioner/family pensioner. The office may contact the concerned pensioner on the mobile number or email as available in the CPENGRAM Portal in order to ensure speedy and satisfactory disposal of grievances.
- vi. Ministry/Department/Organization shall dispose of the grievances after indicating that it 1st 'Accepted' or 'Rejected' or 'Partially Accepted.' In case grievance is disposed of in favour of pensioner, the option 'Accepted' shall be indicated. In other cases, a speaking order shall be passed giving reasons for rejection/partial acceptance and also uploaded in the portal.
- vii. Re-registered cases should be disposed of by Appellate Authorities nominated in every Ministry/Department/ Organization for the purpose.
- viii. Ministries/Departments/Organisations shall identify core grievance prone areas and streamline their systems to eliminate root cause of grievances. Cases delayed beyond the dead-line should be analysed and addressed promptly.
- 4. All the Ministries/Departments are requested to bring the above instructions to the notice of the all concerned under their administrative control for compliance.

Every Central Government pensioner has to submit Annual Life Certificate in the month of November for further continuation of pension. It has been observed that a large number of Central Government pensioners physically visit bank branches for this purpose.

- Earlier, as a measure to enablean additional exclusive window to very senior pensioners, this Department, vide its OM No. 1/20/2018-P&PW/(E), dated 18.07.2019, allowed the pensioners in the age group of 80 years and above, to submit Annual Life Certificate from 1st October onwards, instead of 1\*' November onwards, every year.
- 3. The different modes available to a pensioner for submission of Annual Life Certificate are once again summarized for Pensioners' awareness. An Annual Life Certificate can be submitted manually or digitally as per convenience of the pensioner
- i. Life certificate can be recorded by Pension Disbursing Banks (PDAs), if the pensioner physically appears before the PDA.
- Ii. Personal appearance of a pensioner will not be required, if the pensioner submits the life certificate form signed by any 'designated official.''In accordance with para 14.3 of the Scheme Booklet issued by CPAO, a pensioner who produces a life certificate in the prescribed form signed by persons' specified is exempted from personalappearance. A list of designated officials specified for signing the Life Certificate as per the scheme booklet of CPAO is attached at Annexure.

- Iii. Pensioners can submit Life Certificate online from home through Jeevan Pramaan Portal. The process of submission of Digital Life Certificate through "Jeevan Pramaan" may be seen at https://youtu.be/ cERwM\_U7g54. UIDAI has provided details of all biometric devices which are permissible for capturing biometrics of a person. Pensioners may visit the site www.uidai.gov.in to get information of all such devices.
- Iv. India Post Payments Bank(IPPB) of Department of Posts along withMeity have successfully launched the initiative of the Department of Pension & Pensioners' Welfare: "Doorstep Service for submission of Digital Life Certificate through Postman" in November 2020. In order to make this facility available across the country, DoOPPW roped in the India Post Payments Bank (IPPB) to utilize its huge network of Postmen and Gramin Dak Sevaks in providing doorstep facility to pensioners for submission of life certificate digitally. IPPB is utilizing its national network of more than 1,336,000 access points in Post Offices and more than 1,89,000 Postmen & Gramin Dak Sevaks with smart phones and biometric devices to provide Doorstep Banking Services. For leveraging this facility through Mobile, a pensioner has to download "Postinfo APP" from Google Play store. The process of submission of Digital Life Certificate through Postman may be seen at https://youtu.be/cERWM U7g54.
- V. DoPPW was also instrumental in roping in an Alliance comprising 12 Public Sector Banks which do "Doorstep Banking" for its customers in 100 major cities of the country under Ease of banking reforms. PSB Alliance has introduced the service for collection of Life Certificates under the umbrella of Doorstep Banking. DSB Agent shall visit the doorstep of Pensioner to render the service. Service can be booked by the pensioner through any of the 3 channels i.e. Mobile App, Website or Toll Free Number.
- Mobile App i.e "Doorstep Banking (DSB)" can be downloaded from Google Playstore.
- Pensioners can access through Web Browser I.e https://doorstepbanks.com/& https://dsb.imfast.co.in/ doorstep/login
- Through Toll free Number:- 18001213721, 18001037188
- 4. All Pension Disbursing Authorities are requested to take note of this OM for compliance and give wide publicity of the same amongst pensioners. This issues with the approval of the competent authority.

In view of the Corona Virus Disease(COVID-19), all out efforts are made by the Government to contain its impact by instituting measures at community as well as at individual level.

- 2. In this regard the undersigned is directed to draw attention is the OM of even number dated 27.03.2020, 29.04.2020, 29.05.2020, 24th August 2020, 30th September 2020, 29.12.2020 and 15.04.2021 vide which an option has been provided to CGHS beneficiaries getting medicines for Chronic diseases, to purchase medicines based on the prescription held (prescribed by CGHS Medical Officers/CGHS Specialists / other Govt. Specialists/ Specialist of empanelled hospital) till 31st July 2021, irrespective of Non-Availability certificate from CGHS or otherwise. However, several representations are received in the Ministry seeking extension of the period in view of the COVID-19 Pandemic and resurgence of active cases.
- 3. The matter has been reviewed by the Ministry and it is now decided, in continuation of the earlier OM on the subject, that CGHS beneficiaries getting medicines for Chronic diseases shall be permitted to purchase medicines based on the prescription held (prescribed by CGHS Medical Officers/CGHS Specialists other Govt. Specialists/ Specialist of empanelled hospital) till 31st October, 2021 on the same conditions as per the earlier OM dated 27.03.2020. It is also clarified that the CGHS Wellness Centres are functional and CGHS beneficiaries also have the option to collect medicines through CGHS Wellness Centres as per normal practice, instead of purchasing from market.
- 4. Issued with the approval of Integrated Finance Division, MoHFW vide CD No.1018 dated 10.08.2021.

# Subject : Policy for provision of Concessional FTTH Connections to Serving/Retired employees of BSNL.

Approval of Management Committee of BSNL is hereby conveyed for Concessional FTTH Connection facility to Serving/Retired Executive as well as Non- Executive Employees in BSNL Area only:

a) Concessional FTTH/ Bharat Air Fibre connection may be offered to BSNL serving as well as retired employees subject to 40% concession on plan charges with ceiling of Rs. 300/- per month (For example — a concession of Rs240/- in plan 599, and a concession of Rs300/- in plan 1200).

Concession shall be only on Plan and not on any value added service over the plan. FTTH/Air Fibre plan of FMC of 599 or above shall only be available in this concessional scheme.

- b) In case of MTNL area, the existing guidelines for providing the concessional broadband only (for below JAG level serving employees) would continue.
- c) In case of concessional FTTH connection, the concession shall be allowed only in plan charges and the concerned employee will require to bear cost/rent of the OLT/modem, activation, installation or any other charges as applicable to an ordinary subscriber. However, no security deposit will be required from serving employees. Retired employees shall be required to deposit prescribed Security Deposit.
- d) The policy for JAG and above, serving executives may continue as per circular No. 02/2018- PHA dated 04.09.2018. However, such employees may take only one FTTH connection i.e either as per order dated 04.09.2018 or under this policy with 40% concession limited to Rs 300/-.
- e) FTTH Connections already working in private capacity or availed under 10% concession scheme (as per CFA Cell Circular R&C-CFA No. 67/20-21 dated 15.01.2021) may be allowed to be migrated to eligible concessional plan if requested by the employee.
- f) The facility of providing concessional FTTH connection to the spouse of an eligible retired BSNL employee after the death of such employee may not be provided in this policy.
- g) The provision of FTTH shall be subject to its feasibility.
- h) Concessional FTTH connection shall be in lieu of (i) the concessional broadband, (ii) existing RSTC/CTC landline connection and (iii) Bharat Fibre services availed under 10%. concession scheme (as per CFA Cell Circular R&C-CFA No.67/20-21 dated 15.01.2021) and they will be withdrawn upon provisioning of the FTTH connection under this policy.
- i) GSM in lieu of RSTC/CTC provided in TNF area as per this office order dated 03.01.2020 shall also be withdrawn after provisioning of FTTH.
- j) Other terms and conditions shall be governed as per existing Rules and guidelines issued for serving/ concessional connection for serving/retired employees.

The undersigned is directed to refer to DPE's OM No W-02/0039/201 7-DPE(WC)- GL- XVI/20 dated 19.11.2020, wherein DA rates w.e.f. 01.10.2020 have been frozen for Executives and Non Unionised Supervisors of CPSEs following IDA pay pattern till 30.06.2021.

2. In modification of this Department's O.M. of even No. dated 17.08.2020, the rate of DA to the executives and non-unionized supervisors of CPSES (2007 pay revision) is increased from 159.9% to 170.5% w.e.f. 01.07.2021 (Calculation Sheet is attached at Annexure).

The increase subsumes the - additional installments arising on 01.10.2020, 01.01.2021 and 01.04.2021. The rate of Dearness Allowance for the period from 01.10.2020 till 30.06.2021 shall remain at 159.9%.

- 3 The above rate of DA i.e. 170.5% would be applicable in the case of IDA employees who have been allowed revised pay scales (2007) as per DPE O.Ms. dated 26.11.2008, 09.02.2009 & 02.04.2009.
- 4. All administrative Ministries/Departments of the Government of India are requested to bring the foregoing to the notice of the CPSEs under their administrative control for necessary action at their end.

- a. Disposal of the grievances expeditiously while maintaining the quality in redressal of the, rievances. in order to ensure quality in disposal of grievances, DoPPW is periodically analyzing closed Grievances and re-registering cases, wherever it is observed that ? Grievances were closed by the offices without taking appropriate final action. To consolidate all instructions/guidelines and revise the time limit for redressal of grievances specially for the priority target groups i.e. family pensioners and super-senior pensioners in order to promote good governance and to ensure that the pensioners/family pensioners get their rightful entitlements.
- b. Every grievance shall be disposed of within the ambit of the extant rules. In. case of a gnevance falling outside the ambit of rules, a speaking order shall be issued indicating, the rule position.
- c. All Ministries/Departments/Organisations shall strictly adhere to the time limit of 45 days to resolve fhe pensioners' gnevances. if the grievance pertains to a family pensioner/ Super-senior pensioner (aged 80 years and above) the dead-line to resolve the grievance shall be 30 days.
- d. The grievance shall not be closed for the want of any documents from the pensioner/ family pensioner. The office may contact the concerned pensioner on the mobile number, or email as available in the CPENGRAM Portal in order to ensure speedy and Satisfactory disposal of grievances.

All Circle Heads/Unit Heads at BSNL CO are requested to take immediate necessary action and expedite disposal of all the Pensioners' Grievance cases'as per the guidelines 'mentioned in above referred letter.

# Sub : Enhancement of old age related pension from the first day of 80th year, that is to say, the date after a pensioner completes 79 years.

Ref : (1) Judgement passed by the Hon'ble High Court of Gauwahati in the Writ Petition (c) No. 4224 of 2016 dt 15.03.2018 and the order of the Hon'ble Supreme Court on Special Leave Petition (Civil) Diary No. 18133/2019 dt 8.09.2019 &

(2) letter No. P/A/Pension/163/2021, Original Side Bombay dt 01.07.2021-07-08 from Shri Sushil M Kochey, Registrar, Original Side, High Court, Bombay addressed To, The Secy to the Gol, Ministry of Law & Justice, (Department of Justice) (copy attached).

Sir., The Hon'ble High Court of Gauwahati in the Writ Petition (c) No. 4224 of 2016 dt 15.03.2018 inter alia interpreted the word "from" appearing in the scale set out in Section 17-B of the High Court Judges (Salaries and Conditions of Service) Act 1954.. Based on the interpretation and after applying the law laid down by the Supreme Court in the cases referred to in its decision, the Gauwahati High Court has held that the additional quantum of pension or family pension is available to a retired Judge in case of the first slab from the first day of his 80th year, that is to say, the date after he completes 79 years. On the same principle, insofar as the other slabs given in the scale are concerned, the quantum applicable to the penr or family penr, as the case may be, from respective years mentioned therein is applicable from the first day of the years mentioned therein from which additional quantum of pension or family pension or family pension is payable.

Based on the decision of Gauwahati High Court as is clear from the views of the Committee of the Hon'ble Judges constituted, to look after the needs/grievances of Rtd Judges of Bombay High court. The Honorable Guwhati high court judgment is a judgment in rem, which is not interfered with by the Supreme Court, and which deals with an All Indian Statute such as the High Court and Supreme Court Judges (Salaries and Conditions of Service) Act, 1954. The principal laid down in the said judgment of the Guwahati high court may be implemented in case of all similarly placed persons.

You are therefore, requested to amend Para 4 of DOP&PWN0.38-37-08-PPW(A)-11.08.2009 accordingly. Thanking You,

### पेन्शन खात्यातर्फे पेन्शनरांच्या प्रलंबित तक्रारीचे निवारण

भारत सरकारच्या पेन्शन खात्यातर्फे ६.८.२०२१ रोजीच्या परिपत्रकाव्दारे सर्व मंत्रालयाच्या सचिवांना पेन्शनर्सच्या तक्रारी वेळेत निकालात काढण्यासाठी सुचना दिल्या आहेत.

पेन्शन खात्यातर्फे पेन्शनर्स पोर्टलच्या माध्यमातून सेन्ट्रल पेन्शनर्स ग्रिव्हन्सेस मॅनेजमेन्ट सिस्टीम (CPENGRAMS) व्दारे पेन्शनर्सना आपली तक्रार ऑनलाईन नोंद करण्याची सोय आहे. २० जून २०१९ पासून ज्या पेन्शनरांना इन्टरनेट ची कल्पना किंवा सोय उपलब्ध नाही अशा पेन्शनरांना आपली तक्रार नोंदविण्यासाठी १८००–११–१९६० या टोल फ्री क्रमांकाची सुरुवात केली. टोल फ्री क्रमांकावर फोन केल्यास तेथील अधिकारी पेन्शनराच्या तक्रारीची नोंद करतो व तीचे निवारण करण्याकरिता संबधित मंत्रालय/ खात्याकडे ऑनलाईन माध्यमातून पाठविली जाते. या माध्यमातून नोंदणी झालेल्या तक्रारीच्या निवारणाबाबत संबंधित मंत्रालय/ खात्यांच्या अधिकाऱ्यासोबत पुनरावलोकन बैठक घेतली जाते. कधीकधी असेही लक्षात येते की पेन्शनरांचे समाधान न करताही तक्रार बंद करण्यात आली आहे. वरील बाबींचा विचार करून निवारण करण्याची जबाबदारी व तक्रार निवारणाच्या मुदतीकडे लक्ष वेधले आहे.

- पेन्शन व सेवानिवृत्तीनंतरचे लाभ मंजूर करण्याची जबाबदारी कर्मचारी ज्या कार्यालयातून सेवानिवृत्त झाली आहे. त्या कार्यालयाची असते.
- २) प्रत्येक तक्रारीचे निवारण ४५ दिवसाच्या आत केले पाहिजे.
- ३) पेन्शनर कडून आवश्यक कागदपत्र आले नाही म्हणून तक्रार कायमची बंद करू नये.
- ४) तक्रारींचे निवारण करतांना (Accepted or Rejected or Partially Accepted ) असा शेरा मारणे आवश्यक आहे
- ५) एकदा समाधान झाले नाही म्हणून पेन्शनरने पुनःदाखल केलेल्या तक्रारीचे निवारण ॲपीलेट अधिकाऱ्यातर्फेच करण्यात यावे. वारंवार येणाऱ्या तक्रारींचे विश्लेषण करून संबधित कार्यपद्धत सुव्यवस्थित केली पाहिजे.

### ८० वर्षावरील वयोवृद्धांना मिळणाऱ्या अतिरिक्त पेन्शनबाबत मा.गोहाटी हायकोर्टाचा महत्वाचा निर्णय :

सध्या सहाव्या वेतन आयोगाच्या शिफारसीनुसार वयोवृद्ध पेन्शनर्सना वयाची ८० वर्षे पूर्ण झाल्यावर त्यांच्या पेन्शनमध्ये २०% अतिरिक्त पेन्शन देण्यात येत आहे. ही वाढ वयाची ८० वर्ष सुरू झाल्यापासूनच देण्यात यावी, अशी पेन्शनर्सची मागणी आहे.

याबाबत श्री.विरेन्द्र दत्त ज्ञानी, निवृत्त न्यायाधिश यांनी हे प्रकरण मा. हायकोर्टापर्यंत नेऊन न्याय मिळवला.

श्री.विरेन्द्र दत्त ज्ञानी यांचा जन्म ३०.७.१९३६ रोजी झाला होता. त्यांनी ३०.७.२०१५ रोजी वयाच्या ८० व्या वर्षात पदार्पण केले. ८० वे वर्ष सुरु होतानाच २०% अतिरिक्त पेन्शन देण्यात यावे. असे निवेदन स्टेट बॅंक ऑफ इंडिया कडे सादर केले.

परंतु स्टेट बँक ऑफ इंडिया व पेन्शन पेमेंट ऑर्डर देणाऱ्या सबंधित (CPAO,New Delhi) कार्यालयातर्फे त्यांच्या निवेदनाची दखल देण्यात आली नाही. त्यानंतर श्री.ज्ञानी यांनी आपल्याला न्याय मिळावा म्हणून कायदेशीर नोटीस बजावली. मा.गोहाटी हायकोटातर्फे कायदेशीर नोटीसची दखल घेऊन मा. कायदा व न्याय मंत्रालयाच्या सचिवांना पत्र पाठवून ८० वे वर्ष सुरू झाल्यापासूनच २०% अतिरिक्त पेन्शन देण्यात यावे असे सुचित केले. परंतु मंत्रालयाकडून सुद्धा दाद मिळाली नाही.

श्री ज्ञानी यांनी न्याय मिळण्यासाठी रिट पिटीशन (writ petition) दाखल केले. मा. गोहाटी हायकोर्टात खालील युक्तीवाद करण्यात आला. २०% अतिरिक्त पेन्शन देण्यासाठी सरकारतर्फे काढलेल्या आदेशात 'From eighty to less than eighty five years' असा उल्लेख आहे.

यात From eighty years याचा नेमका अर्थ काय हे तपासले गेले. कॅालीन इंग्रजी डिक्शनरी नुसार चा अर्थ निर्गमन बिंदू 'point of departure' असा परिभाषित आहे. मा.न्यायाधिश गोस्वामी यांनी From हा शब्द वेळ किंवा जागा जेथून सुरुवात होते. त्यासाठी वापरण्यात येतो म्हणून From eighty years हा शब्दप्रयोग ८० वर्षाच्या सुरुवातीची वेळच सुचित करतो असा व्युक्तीवाद केला. त्याअर्थी याचिकाकर्ता श्री विरेन्द्र दत्त ज्ञानी यांचा दावा रास्त आहे. मा.गोहाटी हायकोर्टातर्फे सर्व बाबींचा विचार करून असा निर्णय देण्यात आला की सेवानिवृत्त न्यायाधिशांना सरकारच्या आदेशानुसार पहिल्या स्लॅब अंतर्गत २०% अतिरिक्त पेन्शनचा लाभ वयाच्या ८० वर्षाचे पहिल्या दिवसापासूनच देण्यात यावा व या प्रकरणात याचिकाकर्ता श्री.विरेन्द्र दत्त ज्ञानी, हे ३०.७.२०१५ पासुनच २०% अतिरिक्त पेन्शन मिळण्यास पात्र आहेत.

सरकारतर्फे मा. सुप्रीम कोर्टात या हायकोर्टाचे निर्णयाविरुद्ध स्पेशल लिव्ह पिटीशन (सिव्हिल) दाखल करण्यात आले. गोहाटी हायकोर्टाच्या निर्णयात हस्तक्षेप न करता दि. मा.सुप्रीम कोर्टातर्फे स्पेशल लिव्ह पिटीशन डिसमीस करण्यात आले.

टीपः मा. गोहाटी हायकोर्टाचा वरील निर्णय प्रकरणातील संबंधित व्यक्तीपुरताचं लागू आहे व केन्द्र सरकारच्या तत्सम पेन्शनर्सना वरील निर्णयाचा लाभ मिळण्यासाठी सरकारच्या निर्णयाची व त्यानुसार पेन्शन खात्याच्या परिपत्रकाची वाट पहावी लागेल.

**२०२०-२१ या आर्थिक वर्षांचे आयकर विवरणपत्राची मुदत -** २०२०-२१ या आर्थिक वर्षांचे आयकर विवरणपत्र (Income Tax Return) भरण्याची अंतिम मुदत ३१ डिसेंबर पर्यंत वाढविण्यात आली आहे. अंतिम मुदतीच्या आधी करदात्यांनी आपला आयकर भरावा असे आवाहन केंद्र सरकारकडून करण्यात आले आहे. कारण ३१ जुलै पर्यंत देय इन्कम टॅक्स भरणे आवश्यक असते. त्यानंतर इन्कम टॅक्सच्या बकाया रकमेवर १८% इतके व्याज दंड म्हणून भरावा लागतो.

कोरोना महामारीच्या पार्श्वभूमीवर व मधल्या काळात सॉफ्टवेअर मधील त्रुटींमुळे केंद्र सरकारने Income Tax Return भरण्याची मुदत ३१ डिसेंबर पर्यंत मुदत वाढवून करदात्यांना दिलासा दिला आहे.

ही अंतिम मुदत पाळली नाही तर ५००० रुपये अतिरिक्त दंड भरावा लागणार आहे. जर आपले वार्षिक उत्पन्न हे पाच लाखांच्या आत असेल आणि आपण अंतिम मुदत पाळली नाही तर आपल्याला १००० रुपयांपर्यंत दंड भरावा लागेल.

टीप : अग्रिम टॅक्स (Advance Tax) भरण्याचा नियम व्यवसाय किंवा व्यापार न करणाऱ्या जेष्ठ नागरिकांना लागू नाही.

एमएसीपी (MACP) योजने अंतर्गत वेतन वृद्धी संबंधात स्पष्टीकरण – प्रशासकीय परिमंडल व सर्व्हिस असोसिएशन कडून एसएसीपी अंतर्गत खालील मुद्दांवर वेतन वृद्धी करतांना कशी पद्धत वापरली जाणार या संबंधातील संदर्भ विचारात घेऊन स्पष्टीकरण करण्यात आले आहे. जर एखाद्या केंद्रीय कर्मचाऱ्याला एमएसीपी अंतर्गत आर्थिक बढतीचा फायदा मिळाला असेल व त्यानंतर पोस्टमन/मेलगार्ड किंवा पोस्टल असिस्टंट/ सॉटिंग असिस्टंट किंवा इन्स्पेक्टर (ज्या पदाचा ग्रेड पे/ पे मॅट्रिक्स मधील लेव्हल उच्च आहे) म्हणून प्रमोशन मिळाले असेल तर तो सरकारी नोकरीत प्रवेश केल्यापासून २० वर्षानंतर दुसऱ्या एमएसीपी अंतर्गत आर्थिक बढतीचा लाभ देतांना त्याला सद्या मिळत असलेल्या ग्रेड पे/ पे मॅट्रिक्स मधील लेव्हल च्या पुढील ग्रेड पे/ पे मॅट्रिक्स मधील लेव्हल करीता स्विकार्य राहील. अशा प्रकरणांमध्ये एमएसीपी अंतर्गत आर्थिक बढतीचा लाभ मिळाल्यानंतर लगेच पुढील नियमित पदोन्नती एमएसीपीबाबत आदेशातील पॅराग्राफ–४ मधील तरतुदीनुसार असेल. कारण पोस्ट मुख्यालयातर्फे (Directorate) दिनांक २९.०६.२०२१ च्या आदेशान्वये आदेश क्रमांक NO.20-27/2015 SPN-II dtd 20.08.2018 रद्व करण्यात आला आहे. त्यामुळे अशा नियमित पदोन्नती नंतर वेतन निश्चित करतांना इन्क्रिमेन्टचा फायदा न देता, केवळ ग्रेड–पे चा फरक देण्यात येईल. किंवा पे मॅट्रिक्स मध्ये वेतन निश्चित करतांना पदोन्नती झालेल्या लेव्हल मध्ये सध्याच्या लेव्हल मधील सेलच्या रक्कमेइतके किंवा ती रक्कम नसेल तर त्यापुढील सेलमधील रक्कमेइतके देण्यात येईल.

उदाः – जर एक केंद्रीय सरकारी कर्मचारी ०१.०८.१९९० रोजी एमटीएस (MTS) म्हणून थेट नियुक्त झाला असेल. त्याला MACP योजने अंतर्गत पहिली आर्थिक बढती (ग्रेड पे रू. १९००) ०१.०९.२००८ पासून दिली गेली. त्यानंतर ०१.०९.२००९ पासून पोस्टमन म्हणून पहिले प्रमोशन, दुसरे प्रमोशन ०१.०९.२०१३ पासून (LDCE मार्फत) पोस्टल सहाय्यक म्हणून आणि तिसरे प्रमोशन ०१.०१.२०२१ पासून (LDCE मार्फत) इन्स्पेक्टर ऑफ पोस्ट, म्हणून मिळाले. त्याला सरकारी नोकरीत २० वर्ष, आणि ३० वर्ष अनुक्रमे ०१.०८.२०१० आणि ०१.०८.२०२० पूर्ण झाल्यावर एमएसीपी अंतर्गत आर्थिक बढती मिळेल, तर त्याची वेतन निश्चिती खालील प्रमाणे करण्यात येईल.
