- Coordinate with the various stakeholders (local banks, IPPB, M/o Defence, M/o Railways, D/o Telecommunications, D/o Posts, State Treasuries, UIDAI and MeitY) for smooth conduct of the camps.
- Report any local/technical issues to DoPPW officials for resolution by technical team (Jeevan Pramaan).
- PWAs to nominate officials to make home/hospital visits for Pensioners who are unable to move to Campaign locations.
- Spread awareness about the Campaign among all their members as well as apprise their RWAs (Resident Welfare Associations) regarding the Campaign. Provide training to their members, where required about DLC generation and the Face Authentication technology for generating LC.
- Provide pics and short feedback videos from pensioners of 15-20 seconds each.
